#### **DISCUSSION:**

This is a request to amend the General Plan designation of Medium Density Residential to Planned Development and rezone from C-2 (General Commercial) to P-D (Planned Development) on a .33± acre parcel in order to replace a 4,406 square foot building with an 8,761 square foot building to be used as a retail market. The property is located at 4600 Broadway Avenue, at the south corner of the Broadway Avenue and Curtis Street intersection, in the Downtown Salida area, APN: 135-049-005. The proposed rezone will facilitate the project's ability to meet parking requirements and allow additional lot coverage. A Negative Declaration will be considered for the project.

On January 15, 2015, the Planning Commission held a public hearing and recommended the Board of Supervisors approve the request, on a unanimous (5-0) vote.

This item simply sets the date and time for a hearing on the matter before the Board of Supervisors.
