### DISCUSSION:

The project is a request to amend the General Plan designation of Agriculture and zoning designation of A-2-40 (General Agriculture) of a 1.5± acre parcel to P-D (Planned Development) to modify the current legal non-conforming status and allow for uses consistent with the C-2 (General Commercial) zoning district. If approved, development will occur in two phases. Phase one will modify access improvements to the site and allow additional commercial uses to operate in the existing commercial building site. Phase two proposes construction of a 6,500 square foot commercial building and associated parking lot subject to certain C-2 commercial uses. The property is located at 5801 McHenry Avenue, north of the City of Modesto, APN 004-070-010. A Negative Declaration will be considered for the project.

On March 5, 2015, the Planning Commission held a public hearing and recommended the Board of Supervisors approve the request, on a unanimous (8-0) vote.

This item simply sets the date and time for a hearing on the matter before the Board of Supervisors.

#### POLICY ISSUES:

The proposed general plan amendment and rezone furthers the Board's priorities of A Well Planned Infrastructure System and A Strong Local Economy by providing a land use determination consistent with the overall goals and policies of the Stanislaus County General Plan.
