STAFF RECOMMENDATIONS:

- 1. Approve the amendment to the C2AP-4063 Contract with the California Department of Education (CDE) for administration of Child Care and Development Block Grants.
- 2. Authorize the Community Services Agency Director, or her Assistant Director Designee, to sign the contract amendment.

FISCAL IMPACT:

The C2AP-4063 contract amendment for \$176,213 increases the total amount of this contract from \$3,752,760 to \$3,928,973. Sufficient appropriations and estimated revenues are included in the Community Services Agency Fiscal Year 2014-2015 Program Services and Support Budget to support Stage 2 Child Care expenditures.

The Child Care Programs are 100% Federal and State funded. There is no cost to the County General Fund for the Child Care contracts.

DISCUSSION:

The Community Services Agency receives program contracts from the California Department of Education (CDE) to fund Stage 2 Child Care. The Agency administers these Alternative Payment programs and generates payments for eligible families directly to the Child Care providers. The Agency submits monthly claims to the CDE for reimbursement of funds.

The CDE has augmented the contract for Fiscal Year 2014-2015 and the funds will be used to assist CalWORKs families who are transitioning off cash aid by allowing them to remain employed and off cash assistance. In order for current and former CalWORKs families to remain eligible for Stages 2 and 3 Child Care, they must be working, be within certain income limits, and have children who meet specific age requirements. The augmented funds provide financing for child care services to approximately 400 children enrolled in Stage 2 for Fiscal Year 2014-2015.

The Agency recommends accepting this CDE Stage 2 Child Care and Development Alternative Payment contract amendment effective July 1, 2014 through June 30, 2015.

POLICY ISSUES:

Approval of this request supports the Board's priority of Efficient Delivery of Public Services by providing payments for Child Care services received by working and lowincome recipient families at risk of becoming dependent on public assistance.

There is no staffing impact associated with this request.
