SUBJECT:

Approval to Use Public Facilities Fees to Purchase a Dump Truck for Frank Raines Off-Highway Vehicle Park

#### STAFF RECOMMENDATIONS:

- 1. Approve the use of up to \$40,065 funded by Regional Parks Public Facilities Fees, Fund 6405, to purchase a dump truck for Frank Raines Off-Highway Vehicle Park.
- 2. Direct the Auditor-Controller to increase estimated revenue in the amount of \$40,065 as detailed in the attached budget journal.

#### FISCAL IMPACT:

The total estimated cost of the new dump truck is \$90,000. The Frank Raines Off-Highway Vehicle grant will reimburse up to 74% of the total cost and the Public Facilities Fees will provide the remaining funding up to \$40,065. The \$90,000 in appropriations is included in the Off Highway Vehicle Fiscal Year 2015-2016 Budget. As of July 1, 2015, the remaining unobligated balance of Fund 6405 is approximately \$101,000.

Approval to Use Public Facilities Fees to Purchase a Dump Truck for Frank Raines Off-Highway Vehicle Park

## DISCUSSION:

The State of California Department of Parks and Recreation, Off-Highway Motor Vehicle Recreation Division, administers Operations and Maintenance grants to cities, counties, and other governmental or non-profit organizations that provide facilities relating to off-highway vehicles (OHV) activities. The Off-Highway Motor Vehicle Recreation Act of 2003 authorizes the allocation of grant funds for the purpose of establishing, maintaining, managing, and rehabilitating OHV areas, trails and facilities in California.

The State OHV grant has authorized the use of grant funds to fund 74% of the cost of a new dump truck, which would provide the ability to bring in materials to the Day Use Area like dirt, rock, and asphalt to provide additional space for our park patrons to use. The long term plan is to expand camping facilities on the day use side of the park to accompany overflow in large events. This equipment will be beneficial in expanding the camping facilities, expanding trails at the facility, restoring trail tread, and reducing erosion at the OHV park by moving soil from sediment ponds and other areas to sites that need conservation. In addition, the dump truck will be useful in moving green waste, chip and other similar materials into the new playground area of Frank Raines.

On April 16, 2015, the Public Facilities Fees Committee determined that the Parks and Recreation Department's request in the amount of up to \$40,065 for a dump truck for Frank Raines Park is an appropriate use of Public Facilities Fees (PFF) funds (Attachment A). The PFF Committee provides oversight of the funds; however, the ultimate authority for use of these funds lies with the Board of Supervisors.

### POLICY ISSUE:

The recommended action supports the Board's priority of the Efficient Delivery of Public Services by utilizing public facilities fees for equipment needed to sustain growth at the parks.

### STAFFING IMPACTS:

Existing staff will oversee the purchase and use of the equipment.
