crime reduction services. To afford maximum flexibility, counties that previously completed a competitive process with the Fiscal Year 2014-2015 funding, may allocate Fiscal Year 2015-2016 funding to those service providers who competed for the Fiscal Year 2014-2015 funding, or counties may choose to initiate a new competitive process. An allocation to any service provider is capped based on population and is set at \$25,000 for Stanislaus County pursuant to California Penal Code Section 1233.10(e); however, the cap applies to each separate fiscal year funding allocation made available by the State. Each county may use up to five percent of its allocation for administrative costs. This funding is available for expenditure for four years and any unspent funds revert to the State General Fund.

The following chart outlines the distribution for the Fiscal Year 2014-2015 funding, as well as the recommended distribution for the Fiscal Year 2015-2016 allocation.

Approval to Submit a Letter to Participate in the Community Recidivism Reduction Grant Program from the Board of State and Community Corrections and Approval to Award Grant Funds

DISCUSSION:

The Budget Act of 2015 provides additional funding to counties to support community recidivism and crime reduction services. Grants must be awarded by the Board of Supervisors through a competitive process to a nongovernmental entity or a consortium or coalition of nongovernmental entities that provide community recidivism and crime reductions services to persons who have been released from state prison, a county jail, or a juvenile detention facility, who are under the supervision of a parole or probation department, or any other person at risk of becoming involved in criminal activities.

Counties are eligible to receive funds if the Board of Supervisors, in collaboration with the county's CCP, agrees to the grant program. To afford counties with maximum flexibility, the State will allow county's that already completed the competitive process to allocate the Fiscal Year 2015-2016 funding to those providers who competed for the Fiscal Year 2014-2015 funding. Counties may also choose to initiate a new competitive process. Each county must notify the BSCC of their interest in participating in this grant program by September 30, 2015.

On September 16, 2014, the Board of Supervisors authorized the participation of Stanislaus County in the Community Recidivism Reduction Grant program, and authorized the Community Corrections Partnership to oversee the administration and oversight of the grant, including the preparation of a Request for Proposal (RFP) and returning to the Board of Supervisors with recommendations for award of funds.

On October 20, 2014, the General Services Agency released the Request for Proposal (RFP). The RFP was sent to nineteen local agencies, and there were seven responses: Learning Quest, Nirvana, National Alliance on Mental Illness, Friends Outside, El Concilio, United Way, and Mi Vida Empieza. An evaluation committee was convened that included the District Attorney, staff from Probation, the Chief Executive Office, Behavioral Health and Recovery Services, the Sheriff's Department, and Superior Court. Four proposals were determined to meet the goals of the grant funding. The CCP reviewed and recommended approval of the four proposals. On February 10, 2015, the Board of Supervisors approved the awards as recommended by the CCP. The following is a description of the proposals funded with the Fiscal Year 2014-2015 grant funding.

Friends Outside – a pilot program, modeled after a successful one in Santa Cruz County that provides assertive outreach to those who are on the verge of triggering a warrant. This program plans to serve 150 probationers, of which 75 are expected to comply and avoid the issuance of a warrant. The agency was awarded \$15,016 over two years.

National Alliance on Mental Illness (NAMI) Stanislaus – an expansion of mental health services at the Public Safety Center. NAMI will provide two "Peer to Peer Mentors" to facilitate eight 10-week Life Skills classes for persons diagnosed with mental illness or substance abuse addiction. This program plans to serve a minimum of 105 people. The agency was awarded \$17,088 over two years.

Learning Quest – to implement Pathways to GED, a program to help the recently incarcerated and alternative sentencing population successfully obtain a GED. Includes I-Pathways software access and purchasing the required GED curriculum materials for this specific program. The agency was awarded \$25,000 over two years.

Nirvana – to provide sober living housing, with drug and alcohol outpatient services included, for offenders in the criminal justice system or in jeopardy of being involved with criminal justice. The proposal is to fund 3 clients per month/36 clients per year, with an additional one bed provided by Nirvana. The agency was awarded \$25,000 over one year.

The evaluation committee and the CCP are recommending that a new RFP process for the additional funds not be initiated due to the limited amount of funding available and that the funds be used to extend the existing four programs detailed above.

As Chair of the CCP, the Chief Probation Officer is recommending the Board of Supervisors authorize the CCP to continue to oversee the administration and oversight of the additional funding, as well as any subsequent year's funding should it become available.

Counties receiving funds are required to collect and submit data to the BSCC. Service providers that receive a grant are responsible for reporting to the CCP on the number of individuals served and the types of services provided. The CCP must report any information received from grant recipients to the BSCC on or before January 31, 2016, and each year until the final reporting date of January 1, 2021.

POLICY ISSUES:

Board of Supervisor approval confirming the County's interest in receiving funds and the County's intent to distribute funds to service providers as specified in statute is required in order to receive the Community Recidivism Reduction Grant funds. Approval of this item supports the Board's stated goals and priorities of A Safe Community, A Healthy Community and Effective Partnerships.

STAFFING IMPACTS:

Acceptance of the Community Recidivism Reduction Grant will require minimal staffing resources primarily from the Probation Department related to administering the grant activities. No additional positions will be required.
