WHEREAS, each year the Stanislaus County Dale Butler Equal Rights Award is presented to one or more County employees in recognition of outstanding achievements in promoting equal rights; and,

WHEREAS, the Equal Rights Commission has voted to accept the nomination of Christine Ferraro Tallman, Clerk of the Board and County ADA Title II and Civil Rights Coordinator, for the 2015 Annual Dale Butler Equal Rights Award; and,

WHEREAS, as the Coordinator of the County's ADA and Civil Rights Committee, Christine Ferraro Tallman worked with Strategic Business Technology to create a public Accessibility website and an in-house intranet site for County Departments; and,

WHEREAS, Christine Ferraro Tallman is currently coordinating the development of the County's Self-Evaluation and Transition Plan to identify discriminatory barriers and to develop a plan to remedy those barriers to ensure that no person is subjected to discrimination under any program or activity.
