### **DISCUSSION:**

This is a request to set a public hearing for December 15, 2015 at 6:35 p.m. to consider Planning Commission's recommendation of Ordinance Amendment Application No. PLN2015-0047, Housing Related Code Amendments, a request to amend the Title 21 of the Stanislaus County Code, specifically Chapters - 21.08 General Provisions, 21.12 - Definitions, 21.48 - Highway Frontage (H-1), 21.56 - General Commercial (C-2), and 21.60 - Industrial District (M) and to add Chapters 21.86 - Reasonable Accommodation and 21.82 - Density Bonus for Affordable Housing, to Fulfill State Housing Element Requirements.

The County is currently in the process of updating its Housing Element to comply with the fifth cycle requirements, covering 2015-2023, as set forth in California Planning and Zoning Laws. The proposed ordinance amendments focus on three core areas: 1) SB 2 (Supportive and Transitional Housing and Emergency Shelters), 2) Density Bonus, and 3) Reasonable Accommodations. The County must be compliant with SB 2 in order for the Housing Element to be certified by the California Department of Housing and Community Development (HCD). A certified Housing Element may be used as a qualifying factor for future State funding. As part of the certification process, HCD will conduct a streamlined review of the Housing Element update when a jurisdiction meets State housing law requirements including a provision for density bonus and a formalized process for reasonable accommodation requests.

### **POLICY ISSUES:**

The proposed ordinance amendment furthers the Board's priorities of A Well Planned Infrastructure System, and A Strong Local Economy by providing a land use determination consistent with the overall goals and policies of the Stanislaus County General Plan.
