Approval to Set a Public Hearing on February 9, 2016 to Expand the Knights Ferry Cemetery District Board of Trustees from Three Members to Five Members Page 2

DISCUSSION:

The Knights Ferry Cemetery District was formed in 1936. Currently, there are three members on the Board of the Trustees for the District. On December 1, 2015, the Board of Trustees approved a resolution requesting the Stanislaus County Board of Supervisors to expand the Knights Ferry Cemetery District Board of Trustees from three members to five members.

Per the California Health and Safety Code Section 9025, the Board of Supervisors shall within 60 days consider the resolution at a public meeting. The hearing shall be noticed at least 10 days prior to the meeting in at least one newspaper of general circulation within the jurisdiction of the District. At its hearing, the Board of Supervisors shall receive and consider any written or oral comments regarding the resolution. After receiving and considering those comments, the Board may adopt a resolution that orders the increase in the number of members of the Board of Trustees for the Knights Ferry Cemetery District.

POLICY ISSUE:

The Board of Supervisors has the authority to increase or decrease the number of members of the Board of Trustees for the Knights Ferry Cemetery District per the California Health and Safety Code Section 9025. This item comes under the Board of Supervisors' Priority for a Healthy Community.
