## FISCAL IMPACT: (Continued)

The primary sources of funding for this project are detailed in the chart below:

The Board of Supervisors is requested to approve a Change Order with Hensel Phelps Construction Company to add roof top walk pads for the Sheriff's Office patrol paths. The pads will protect the roof when Sheriff Deputies are patrolling the facility.

The Project has a significant contingency for the Public Safety Expansion Project One.

#### **DISCUSSION:**

The Public Safety Center Expansion Projects are well underway.

## **Next Recommended Actions**

There is one recommended change that requires Board of Supervisor's approval pursuant to the County's Adopted Change Order Policy which requires Board approval for changes that exceed \$25,000.

The original design drawings for Public Safety Center Project One included walk pads on the roof for maintenance equipment but not for Deputy Sheriff Personnel to conduct routine patrols from the roof. The Project Manager recommends that the Board of Supervisors approve a Change Order in an amount not to exceed \$40,584.

### **Schedule**

All of the Public Safety Center Expansion Projects remain well within budget and on schedule. Today's action by the Board of Supervisors will help to move the project forward and ensure the safety of the projects roof and equipment.

#### **POLICY ISSUES:**

The action in this item will advance the Board of Supervisors' priority to strive for A Safe Community by increasing detention capacity to meet projected needs and minimize use of alternatives to incarceration for potentially dangerous criminals.
