SUBJECT:

Approval to Accept the Fiscal Year 2015-2016 Grant Award from the California Department of Insurance for the District Attorney's Office Auto Insurance Fraud Program

STAFF RECOMMENDATIONS:

- 1. Approve the receipt of the grant award from the California Department of Insurance for the District Attorney's Office Automobile Insurance Fraud Program in the amount of \$150,000.
- 2. Approve a formal resolution as required by the State to receive this grant.
- 3. Direct the Auditor Controller to decrease estimated revenue \$12,765 and decrease appropriations by \$37,657 as detailed in the Budget Journal form.

#### FISCAL IMPACT:

Estimated revenues and appropriations of \$200,288 for this grant were projected in the 2015-2016 Fiscal Year Recommended Final Budget. An award amount of \$150,000 was received by the California Department of Insurance (DOI). The award is \$50,288 less than anticipated. Additionally, the California DOI has authorized to roll forward unexpended funds of \$576 from Fiscal Year 2014-2015. The District Attorney's Office also anticipates receipt of prior year revenue of \$36,947 in the 2015-2016 Fiscal Year.

# FISCAL IMPACT: Continued

The net change will result in a decrease in estimated revenue by \$12,765 and a decrease in appropriations by \$37,657 as detailed in the chart below. No General Match is required to accept the grand award.

As of July 1, 2015, this budget unit had a negative fund balance of \$24,892. With the contribution of \$24,892 to Fund Balance, the Department anticipates ending the 2015-2016 Fiscal Year with zero fund balance.

The Auto Insurance Fraud Prosecution budget has two allocated positions; one Criminal Investigator II that is fully funded by this grant and one Paralegal III that is currently vacant due to lack of funding. As in previous years, additional funding has been used to offset the cost of a Deputy District Attorney position in the Criminal Division budget. In Fiscal Year 2014-2015, the amount offset was 42%. It is anticipated with the reduction in grant funding this year, only 5% of the Deputy District Attorney position will be funded from the Auto Insurance Fraud Prosecution budget. The remaining 95% funding for this position is funded in the Criminal Division fund salary allocation. This grant also funds operating expenditures that includes wireless communications, audit expenditures, and training for the Auto Insurance Fraud Prosecution staff.

# DISCUSSION:

In Fiscal Year 1996-1997, the District Attorney's Office was awarded funding approved by the Board of Supervisors for the Automobile Insurance Fraud Grant. Each Fiscal Year the Department receives a request for application. This will make Fiscal Year 2015-2016 the nineteenth consecutive year that the District Attorney's Office will have received funding from the California Department of Insurance for the Automobile Insurance Fraud Grant.

The grant award agreement was submitted to the California Department of Insurance the end of November 2015. The Department received notification of funds granted. In order to receive the grant award, the Board of Supervisors must approve the attached resolution.

Insurance fraud affects the citizens of Stanislaus County through increased insurance rates. The District Attorney's Office is committed to the investigation and prosecution of those who commit insurance fraud; the acceptance of the California Department of Insurance's Automobile Insurance Fraud Prosecution grant has allowed this investigation and prosecution to occur.

In Fiscal Year 2015-2016, the objectives of the grant will continue to focus on economic vehicle theft and its relation to auto insurance fraud. The Criminal Investigator will continue to work with the Stanislaus County Auto Theft Task Force.

#### POLICY ISSUES:

This agenda item is being submitted for Board approval in order to authorize acceptance of the grant. A formal resolution is attached. Acceptance of this grant will assist the District Attorney's Office in continuing to meet the Board of Supervisors goal of A Safe Community by investigating and prosecuting those who commit auto insurance fraud.

## STAFFING IMPACTS:

The grant funds 100% of an Investigator and 5% of a Deputy District Attorney. These staffing levels are able to sustain the reporting requirements of the grant.
