

**STAFF RECOMMENDATIONS:**

1. Set a Public Hearing on May 10, 2016, at 9:05 a.m. to introduce and waive the first reading of an ordinance to establish new fees, and amend or eliminate existing fees, for the Department of Environmental Resources.

**DISCUSSION:**

The Department of Environmental Resources (Department) charges fees for services it provides in the program areas of Code Enforcement, Environmental Health, Hazardous Materials, Landfill, Milk and Dairy, and Solid Waste. State law mandates that fees charged for services cannot exceed actual costs and must be used to cover the costs of implementing the programs.

Annually, in preparation for the Proposed Budget, the Department evaluates the program costs and the fees associated with programs administered. This process includes the consideration of new or additional fees, where appropriate, as well as modifications to existing fees in order to cover the program costs. The recently conducted fee survey of comparable counties in the State found that proposed fees are in-line with other counties of comparable demographics.

This year the Department is proposing new fees and fee modifications in a variety of its programs. The proposed fee schedule is included as Attachment A and details regarding recommended new fees and fee modifications are as follows:

***Hazardous Materials Fees***

On January 1, 1997, Stanislaus County was certified by the California Environmental Protection Agency (Cal EPA) to be the Certified Unified Program Agency (CUPA) for all Stanislaus County. In its capacity as a CUPA, the County, by and through the Hazardous Materials Division of the Department, administers the following programs, pursuant to the authorities granted by the California Health and Safety Code, Section 25404:

- Hazardous Materials Business Plan Program
- California Accidental Release Prevention Program
- Hazardous Waste Generator Program
- Tiered Permitting Program
- Underground Storage Tank Program (UST)
- Aboveground Petroleum Storage Tank Program (AGT)
- Medical Waste Management Program

CUPA staff spends the majority of their time inspecting facilities that fall under the CUPA programs. CUPA staff also perform other non-inspection duties, however, such as responding to and addressing complaints, plan reviews, consultations, follow-ups, legal action/enforcement, providing education and training workshops, and responding to emergency calls.

Based on staff's evaluation of the current CUPA fees versus projected expenses of the CUPA for Fiscal Year 2016-2017, staff recommends increases of the CUPA fees for Aboveground Petroleum Storage Tank (AGT) and the Farms Disclosure Program; creation of a California Electronic Reporting System Fee; as well as eliminating the existing Monitoring Wells permit fee and replacing it with new permit fees for Monitoring Wells and Soil Borings.

#### Aboveground Petroleum Storage Tank (AGT) Program

The Aboveground Petroleum Storage Tank (AGT) Program regulates facilities that store 1,320 gallons (or greater) of petroleum products in aboveground tanks. Continued inspector training, regulatory requirement changes, such as the recent re-writing of the Aboveground Petroleum Storage Tank laws, and the CERS reporting requirement, have increased staff time required within the program. The Board of Supervisors last amended the current Aboveground Petroleum Storage Tank Program fees in 2015 and recognized that gradual increases over time would be necessary to make the Program whole.

The projected costs associated with implementing the program are approximately \$67,750. This number was calculated by adding the average staff cost for administering the AGT inspection program for the last three years and the cost for training required to maintain the Aboveground Petroleum Storage Act (APSA) certification. The projected revenue at the current fee is approximately \$47,435, leaving a deficit of \$20,315. The staff recommendation is to increase the fees for this program by 10%. The proposed fees would produce additional estimated revenue of approximately \$4,743, leaving a deficit of \$15,572 for this program. Staff recommends continuing to gradually increasing the AGT fees over the next few years to fully cover the deficit.

#### Farm Disclosure Program

The Farm Disclosure Program regulates farming facilities that store hazardous materials in quantities greater than 55 gallons of a liquid, 200 cubic feet of a gas, or 500 pounds of solid material. Recent regulatory changes, such as the CERS reporting requirement, have

increased staff time within the program. The Board last amended the current Farm Disclosure Program fees in 2015 and here too, recognized that gradual increases over time would be necessary to make the program whole.

The projected costs associated with implementing this program are approximately \$39,320. The projected revenue at the current fee is \$15,505, leaving a deficit of \$23,815. The proposed 11% increased fee would produce additional estimated revenue of approximately \$1,205 for this program. Staff recommends continuing to gradually increasing the Farm Disclosure Program fees over the next few years to fully cover the deficit.

#### California Electronic Reporting System Fee

Stanislaus County does not currently have a fee associated with the State-mandated California Electronic Reporting System (CERS) database reporting. During Fiscal Year 2014-15, the Hazardous Materials Division spent approximately 1,773 hours (\$187,959) associated with the implementation of CERS. Ongoing costs associated with CERS implementation include education for both Department staff and the regulated community, enforcement, and purchasing and maintaining a CERS compatible database. The \$45 CERS fee would be applied to all businesses that are regulated under the CUPA with the exception of farms. There are approximately 2,700 CUPA regulated facilities. The proposed fee of \$45 per facility would be applicable annually to approximately 1,500 facilities and would produce an estimated revenue of \$67,500, leaving a deficit of \$120,459. This fee will likely be adjusted over the next few years to eliminate the deficit.

#### Change of Ownership/Transfer Fee

Currently, the Hazardous Materials Division has no mechanism for covering the administrative costs for changes of ownership/transfers of a business yet staff spend approximately one hour processing and updating new information. Staff, therefore, recommends establishing a fee equivalent to one staff hour for this item to recover costs.

#### Monitoring Wells and Soil Borings Fees

The current permit fees for Monitoring Wells and Soil Borings were last amended by the Board in 2001. The fee amount has not been revised since being established in 2001 and no longer reflects the costs incurred to process and approve permits and perform onsite inspections. The current permit fees for monitoring wells is \$75 for the first well and \$35 for each additional well. The current permit fee does not include soil borings or monitoring well destruction.

Hazardous Materials is responsible for approving permits for the installation/construction and destruction of groundwater monitoring wells and soil borings and geotechnical borings. The existing fee is only charged for permits involving the construction of monitoring wells and soil borings in which water samples are obtained. This means that a fee was only charged in approximately 30% of the permits issued in 2015.

Based on an evaluation of staff's time and costs associated with the issuance of permits for soil/geotechnical borings and the construction and destruction of monitoring wells in 2015, staff

recommends revising the fees to reflect the current Weighted Labor Rate (WLR) costs associated with the average amount of time spent to review and approve permit applications for monitoring wells and soil borings and also to perform onsite drilling/grout inspections. This fee will include issuing permits for soil/geotechnical borings and the destruction of monitoring wells.

Proposed permit fees are as follows:

- Monitoring Wells and Soil Borings: \$265 for the first well or soil boring, plus \$53 for each additional well or boring on the same property parcel, up to 6 wells or soil borings total (\$530 max). For more than 7 wells/borings any additional time incurred will be charged hourly at the current WLR.
- Destruction of Monitoring Wells: \$265 for the first well destruction plus \$53 for each additional well destruction. Additional time to perform multiple grout inspections will be charged hourly at the current WLR.

### ***Environmental Health - Water Well Construction Permit Fees***

Well construction permits are valid for one year from the date issued. The demand for new well installations has often resulted in a long wait time before construction can commence. As such, the Department receives a large number of extension requests in addition to requests to transfer permits from one driller to another or even amend a permit to change the well location, for example. The fees currently approved and charged have not taken into account the administrative costs associated with the transfer, extension, and amendment of well permit applications. With demand increasing for these types of well permit modifications, the labor cost associated has become significant. The proposed new fees aim to recoup administrative expenses incurred in processing permit modifications and will generate approximately \$12,000 annually. The recommended new fees for this program are explained below:

#### Well Permit Transfer Fee

The current well permitting process allows for well drillers and/or property owners to request transfer of well permits to another licensed C-57 well driller, so long as the well permit is valid. Upon written request for a transfer, the existing well permit number is voided. The associated fees and permit are transferred to the new driller upon new permit submission and staff approval. The well permit expiration date remains unchanged upon transference. The proposed fee of \$106 reflects one hour of staff time and would apply to all well permit types.

#### Well Permit Extension Fee

The current well permitting process allows for well drillers and/or property owners to request an extension of well permits, so long as the well permit has not expired. The written request for extension must provide a reason that necessitates the request. Each permit is eligible for up to two 180-day extensions. The proposed fee of \$53, which reflects one-half an hour of staff time, would apply to all well permit types.

Amended Well Permit Fee

The current well permitting process allows for well drillers to amend information on an existing well permit. Most amendments are related to well re-location or construction specifications. The proposed fee of \$53, which reflects one-half an hour of staff time, would apply to all well permit modifications.

***Milk and Dairy Program Fees***

The Milk and Dairy program fees charged by the County have not been raised since 2008. In 2012, however, the State imposed a surcharge of 15% which was required to be passed through. The current cost associated with implementing the program is \$401,248 with projected revenue currently at \$321,930, leaving a deficit of \$79,318. The deficit is due to increased staff costs and the loss of approximately 88 dairies since 2008. The staff recommendation is to increase the Grade A and Grade B dairy fees for this program by 11.43% and to gradually increase fees over the next few years to fully eliminate the deficit. In addition, six new fees have been added that will encourage dairy owners to bring their dairies into compliance. The proposed fees would produce additional estimated revenue of approximately \$55,984 for this program.

***Landfill Fees***

Ash Tipping Fee

On June 26, 2012, the Board approved the Amended and Restated Service Agreement with Covanta Stanislaus, Inc., for the operation of the waste-to-energy facility. As a result, ash tipping fees were raised in Fiscal Year 2012-2013 by \$10 per ton. This increase was necessary in order to cover future ash monocell development/construction costs as well as the post-closure obligations at the Geer Road Landfill. Also included in the new Service Agreement was a clause that would escalate the tipping fee each July 1<sup>st</sup> based on the Consumer Price Index (CPI), "Urban Wage Earners and Clerical Workers, All items, West-Size B/C." The CPI will increase the ash tipping fee by 1.33% for Fiscal Year 2016-2017. This will increase the current \$26.53 per ton tipping fee for ash to \$26.88 per ton. The estimated increase in revenue from this change will be approximately \$26,250.

Hard-to-Handle (Bulk Material)

Fink Road Landfill currently charges for the disposal of bulk irrigation drip line as normal refuse at the rate of \$33 per ton. Due to the handling difficulty of this material and to reflect additional costs associated with its disposal, staff recommends that it be reclassified as a "Hard-to-Handle" material, which has a disposal fee of \$100 per ton.

Bulk irrigation drip line is problematic in that the line cannot be integrated with normal household or industrial waste. The effect of attempting to integrate bulk irrigation drip line with normal waste leads to this material becoming heavily wrapped in dozer tracks and strewn about the landfill tipping floor. The cost of cleanup and disposal of this material exceeds the

normal refuse tipping fee because it must be segregated and immediately buried to prevent unnecessary servicing of landfill equipment and facility cleanup. The purpose of amending the definition of the "Hard-to-Handle" waste classification is to recapture actual costs associated with its disposal. Since the annual tonnage of this material, to date, has not been tracked separately from normal refuse, the estimated increase in revenue from this amended fee cannot be approximated with any certainty.

Mattresses, Box Springs, and Futons

This current fee category charges for the disposal of mattresses, box springs, and futons as Hard-to-Handle items, regardless of their condition. The County is currently in negotiations to contract with the Mattress Recycling Council (MRC), a non-profit organization that administers a State grant, to purchase and collect used but recyclable mattresses and box springs from solid waste facilities throughout the State so that they do not end up in landfills. When this contract is executed, the cost associated with the collection and storage of mattresses will be diverted to MRC with the understanding that the County will no longer charge residents for their collection and disposal. MRC will subsequently collect these materials from the landfill facility. MRC will, however, only take mattresses and box springs that are not contaminated or too damaged to recycle.

The amended fee, beginning with the anticipated execution of the contract with MRC and for the entirety of its duration, will effectively remove recyclable mattresses and box springs from this Landfill fee category, but continue to charge for mattresses and box springs that cannot be recycled, as well as the items that are specifically excluded under the contract. Items that will be accepted at no fee under this program are strictly defined in the Landfill Fees table below. The net difference in revenue will be neutral.

**POLICY ISSUE:**

Prior to levying a new fee or amending an existing fee, the County is required by Government Code Section 54985 et seq., to hold a scheduled public hearing as part of a regularly scheduled meeting of the Board of Supervisors. At that time the Board may introduce and waive the first reading of an ordinance to establish new and amend existing fees of the Department of Environmental Resources. If approved, these fee changes will become will correspond with Fiscal Year 2016-2017, and will become effective on June 24, 2016, with the exception of the landfill and ash tipping fees that would become effective on July 1, 2016.

**FISCAL IMPACT:**

If the proposed fee adjustments are approved, the increase in revenues for the Department of Environmental Resources is estimated to be \$205,964 in Fiscal Year 2016-2017. Increases in revenues for each individual program are estimated as follows: Aboveground Petroleum Storage Tanks (AGT), \$4,743; Farm Disclosure, \$1,205; California Electronic Reporting System (CERS), \$67,500; Monitoring Wells and Soil Borings, \$40,651; Water Program, \$12,000; Milk and Dairy, \$55,984; and Landfill, \$26,250. The recommended fee revenue will be included in the Department's Fiscal Year 2016-2017 Proposed Budget.

**AN ORDINANCE ADOPTING NEW AND AMENDING

THE BOARD OF SUPERVISORS OF THE COUNTY OF STANISLAUS, STATE OF CALIFORNIA, ORDAINS AS FOLLOWS:
