#### SUBJECT:

Approval to Set a Public Hearing for May 03, 2016 at 9:10 a.m. to Consider Planning Commission's Recommendation for Approval of Rezone Application No. PLN2015-0027, Valley BMW/KIA, North of the City of Modesto, and Adoption of a Mitigated Negative Declaration

#### STAFF RECOMMENDATIONS:

- 1. Set a public hearing for May 03, 2016 at 9:10 a.m. to consider Planning Commission's recommendation for approval of Rezone Application No. PLN2015-0027, Valley BMW/KIA, a request to rezone a 9+/- acre parcel from A-2-10 (General Agriculture) to Planned Development (P-D) and to subdivide the property into five parcels, for the development of two auto dealerships and the future development of similar auto related uses, located at 4761 McHenry Avenue (State Route 108), between Kiernan Avenue and Bangs Avenue, north of the City of Modesto; and to consider the introduction and waiving of the reading of an ordinance for the proposed rezone upon approval.
- 2. Authorize the Clerk of the Board to publish notice of hearing as required by law.

### **DISCUSSION:**

This is a request to rezone a 9+/- acre parcel from A-2-10 (General Agriculture) to Planned Development (P-D), subdivide the property into five parcels and extend Spyres Way through the site, located at 4761 McHenry Avenue (State Route 108), between Kiernan Avenue and Bangs Avenue, north of the City of Modesto. The project proposes to construct an approximately 30,000 square foot commercial building for an auto dealership during phase 1 and a 16,000 square foot commercial building during phase 2. The proposed dealership will be operated 7 days a week ranging from 7:00 a.m. – 9:00 p.m. on Monday through Saturday and 9:00 a.m. – 7:00 p.m. on Sundays. The applicant anticipates a maximum of 30 employees for the phase 1 dealership. The dealership will contain an office and storage area, with sales and service department. The project is within the City of Modesto's Sphere of Influence.

On April 7, 2016, the Planning Commission held a public hearing and on a 6-0 vote, recommended the Board of Supervisors approve the request as proposed. There was no one that spoke in opposition of the project. Dennis Wilson of Horizon Consulting Services spoke in favor of the project.

This item will set the date and time for a hearing on the matter before the Board of Supervisors.
