#### SUBJECT:

Approval for the District Attorney to Accept an Award for Additional Funding in the Victim Services Program Budget Unit from the California Governor's Office of Emergency Services for Fiscal Year 2015-2016

#### STAFF RECOMMENDATIONS:

- 1. Approve the receipt of the additional funding in the District Attorney's Victim Services Program Budget from the California Governor's Office of Emergency Services for Fiscal Year 2015-2016 in the amount of \$136,861.
- 2. Direct the Auditor-Controller to increase appropriations and estimated revenue in the Victim Services Program budget unit by \$136,861 as detailed in the attached budget journal form.

#### **DISCUSSION:**

As part of the 2015-2016 Adopted Budget, the Department included \$353,681 of funding received for the Victim Services Program grant. The Department has been notified by the California Governor's Office of Emergency Services that Stanislaus County received an additional \$136,861 in funding for Fiscal Year 2015-2016.

The Victim Services Program offers a variety of services to victims of crime and their families including court escort and support, case status information, crisis intervention/peer counseling, assistance with financial compensation through the State of California, emergency assistance and referrals for additional services.

#### POLICY ISSUE:

The Victim Services Program is funded by the Victim/Witness Assistance Program grant which requires the provision of 14 distinct services offered to victims of all crime types. Approval from the Board of Supervisors is required to increase the Victim Services Program budget for the additional funding that has been awarded by the grant.

#### FISCAL IMPACT:

The operating budget as of March 31, 2016 for the District Attorney Victim Services includes estimated revenue totaling \$379,039, appropriations of \$385,820, and a deficit of \$6,781 to be covered by Fund Balance in accordance with the Board of Supervisors approved Fiscal Year Page 1 of 2

2015-2016 Mid-Year Budget. Subsequent to the Third Quarter Financial Report, additional funding was awarded by the California Governor's Office of Emergency Services to those counties who received funding in the original grant award process earlier this fiscal year. This funding source of \$136,861 will cover additional salaries and benefits for an advocate position previously partially funded by the District Attorney - Criminal Division budget, updating the Victim Services Unit's interview room, and related expenses for the Department's facility dog, Honor. No additional General Fund match is required for this additional funding and the department will be eligible for a higher base level of grant funding in Budget Year 2016-2017.
