

ORDINANCE NO. C.S. 1177

**AN ORDINANCE ADOPTING NEW AND AMENDING
EXISTING FEES COLLECTED BY THE DEPARTMENT OF
PARKS AND RECREATION**


THE BOARD OF SUPERVISORS OF THE COUNTY OF STANISLAUS, STATE OF CALIFORNIA, ORDAINS AS FOLLOWS:

Section 1. Fees to be collected by the Department of Parks and Recreation are adopted and amended as set forth in the Department of Parks and Recreation Fee Schedule attached hereto as Attachment A and incorporated by reference, a copy of which is on file with the Clerk of the Board of Supervisors and is available for public inspection and copying in that office in accordance with the California Public Records Act.

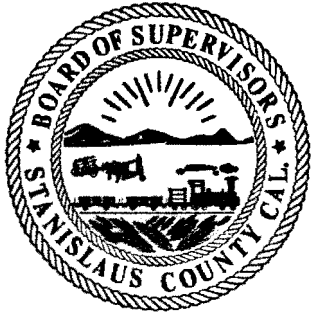
