SUBJECT:

Approval of Amendment No. 2 and Amendment No. 3 to the Master Agreement with Cypress Security LLC for Security Services in the amount of \$310,000

STAFF RECOMMENDATIONS:

- 1. Approval of Project 2012-004 Amendment 2 and Project 2015-007 Amendment No. 3 to the Master Agreement with Cypress Security LLC for Security Services to increase the not to exceed amount by \$310,000.
- 2. Authorize the Purchasing Agent to execute the Amendments to the Master Agreement with Cypress Security LLC, and to sign any subsequent amendments to the Project that do not increase the not to exceed total.

DISCUSSION:

The existing Master Agreement for security services was awarded to Cypress Security LLC as the result of a Request for Proposals process, with an initial term of July 1, 2012, through June 30, 2017. The Agreement provides for two optional one-year renewals through June 30, 2019.

A provision of the Master Agreement allows for the Purchasing Agent to execute individual Projects where the cost of services does not exceed \$100,000. Projects greater than \$100,000 shall be approved by the Board of Supervisors. These amendments apply to 832 12th Street, Modesto CA.

Project 2012-004 for two unarmed security guards at the 12th street building set the not to exceed limit to \$490,000. Amendment No. 1 to Project 2012-004 clarified the scope of the project, changing employee titles, added an armed uniformed guard at the first floor counter and increased the weekly hours from 40 hours to 45 hours per week, specified preemployment screening and knowledge/skill set, but did not change the not to exceed limit of the Project. Amendment No. 2, designated Project 2015-007, added an additional armedsecurity guard for the District Attorney's Office however, the not to exceed amount was erroneously reduced to \$325,000. If approved, Amendment 2 and Amendment No. 3 would increase this by \$310,000 for a new not to exceed limit of \$635,000. Renewals or extensions will require General Services Agency to return to the Board for approval.

Approval of Amendment No. 2 and Amendment No. 3 to the Master Agreement with Cypress Security LLC for Security Services in the amount of \$310,000

POLICY ISSUE:

The County's purchasing policy requires Board of Supervisors approval for contracts exceeding \$100,000. This requirement is based upon California Government Codes § 25212, et seq, and § 25502.5, et seq, which establish the powers of the Board of Supervisors and the Purchasing Agent.

FISCAL IMPACT:

Amendments No. 2 and No. 3 increase the agreement by \$310,000, with a new not to exceed amount of \$635,000 to the Master Agreement. Funding is available in the Fiscal Year 2016-2017 Adopted Proposed Budgets for the District Attorney's (DA) Office and Stanislaus County Employee's Retirement Association (StanCera).

THIRD AMENDMENT TO CYPRESS SECURITY LLC PROJECT NO. 2012-004

Reference is made to Project 2012-004 (the "Project") under the Master Agreement for Professional Services ("Agreement") made and entered into by and between the County of Stanislaus ("County") and Cypress, Security LLC., a California limited liability company doing business as Cypress Private Security, ("Consultant"), on July 1, 2012.

WHEREAS, the parties agreed to revise the scope of work to add service in Amendment 1 the Amended and Restated Project; and

WHEREAS, Amendment 2 to this Project, issued under Project number 2015-007, set the maximum not to exceed limit to \$325,000; and

WHEREAS, the County has a need to increase the not to exceed amount in Section C – Compensation subsection 6 by \$310,00 to pay for services through June 30, 2017; and

NOW THEREFORE, the parties hereby agree to amend the Project as follows:

- 1. Section C Compensation of the Project is amended to read as follows:
 - "6. The parties hereto acknowledge the maximum amount to be paid by the County for services provided under this Project shall not exceed \$95,000 per year for the first year and \$540,000 over the five-year term of the Master Agreement (through June 30, 2017), contingent upon the approval of the Stanislaus County Board of Supervisors budget for fiscal years 2012-2013 through 2016-2017. The maximum amount to be paid shall include, without limitation, the cost of any subcontractors, consultants, experts or investigators retained by the Consultant to perform or to assist in the performance of its work under this Project."
- 2. All other terms and conditions of the Project shall remain in full force and effect.

SECOND AMENDMENT TO CYPRESS SECURITY LLC dba CYPRESS PRIVATE SECURITY PROJECT NO. 2015-007

Reference is made to Project 2012-007 (the "Project") under the Master Agreement for Professional Services (the "Master Agreement") dated as of July 1, 2012 by and between the County of Stanislaus ("County") and Cypress Security LLC, a California limited liability company doing business as Cypress Private Security ("Consultant").

WHEREAS, the parties have agreed to revise the scope of work to add a Post to be serviced; and

WHEREAS, the parties have agreed to increase compensation due to Contractor for the added Post.

NOW THEREFORE, the parties hereby agree to amend the Project as follows:

- 1. Paragraph 1 of Section B of the Project is amended to read as follows:
 - 1. The Consultant shall provide an additional "armed" uniformed security guard to County's District Attorney's Department ("DA") at the following locations:

- 3. Paragraph 1 and 6 of Section C is amended to read as follows:

The maximum amount to be paid shall include, without limitation, the cost of any subcontractors, consultants, experts or investigators retained by the Consultant to perform or to assist in the performance of its work under this Project
