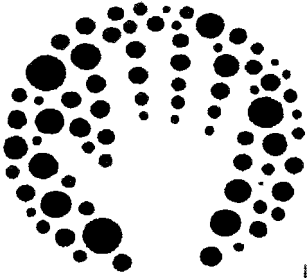
**STAFF RECOMMENDATIONS:**
