This is an update to the Stanislaus County General Plan, which is a comprehensive, long-term general plan to guide physical development within Stanislaus County. The project includes updates to the following elements of the Stanislaus County General Plan: Land Use, Circulation, Conservation/Open Space, Noise, Safety, and Agricultural Elements. The update does not include any changes in Land Use map designations, but rather is a 'clean up' of the General Plan to incorporate changes in state law, code, and local standards. The update also includes revisions to General Plan language and some new goals/policies/implementation measures designed to enhance and support existing goals/policies/implementation measures. No development project is proposed as part of the General Plan Update.

The Stanislaus County Planning Commission will conduct a public hearing to consider the General Plan Update on August 4, 2016. The notice of public hearing for the Board of Supervisors consideration of the General Plan Update will include the Planning Commission's recommendation.
