Approval to Proclaim September 2016 National Preparedness Month in Stanislaus County

STAFF RECOMMENDATIONS:

1. Approval to proclaim September 2016 National Preparedness Month in Stanislaus County.

DISCUSSION:

Launched in 2004 by the Federal Emergency Management Agency (FEMA), National Preparedness Month is a national annual preparedness outreach that aims to educate and empower Americans during the month of September and throughout the year to prepare for and respond to all types of emergencies, including natural disasters and potential terrorist attacks. Due to the success of last year's theme, "Don't Wait, Communicate" will continue as this year's theme. National Preparedness Month serves as a reminder that we must take action to prepare now and throughout the year for the types of emergencies that could affect us where we live, work, learn, reflect and relax.

FEMA highlights a weekly subject during National Preparedness Month. This year's topics are: Multigenerational Preparedness, Community Service, and Individual Preparedness. These themes encourage Americans to take simple steps to prepare for emergencies in their homes, neighborhoods, businesses, schools, and communities. Additionally, this year a local topic will be added to highlight StanAware. StanAware is the Stanislaus County Office of Emergency Services communications system that allows citizens to be contacted directly in case of a large-scale emergency and keep local residents informed in the event of an emergency or disaster. StanAware uses the Everbridge Mass Notification System in use by many other government agencies, universities and corporations. The focus will be to encourage all Stanislaus County residents, including County staff, to self-register in the system which allows the Stanislaus County of Emergency Services to phone, text or email residences, businesses and/or personal cell phones with emergency alert information.

The Office of Emergency Services is requesting that the Board of Supervisors approve a resolution proclaiming September 2016 National Preparedness Month. Throughout the month, information focused on the weekly topics will be disseminated via email to County employees. as well as Operational Area members and partner agencies. In addition, the Office of Emergency Services will provide preparedness information and encourage self-registration on StanAware to the public via stanemergency.com and social media.

POLICY ISSUE:

Approval to proclaim September 2016 National Preparedness Month encourages County employees, Operational Area members, partner agencies and the public to take action to prepare now and throughout the year for the types of emergencies and disasters that could affect Stanislaus County.

FISCAL IMPACT:

Current Office of Emergency Services staff will create and disseminate the weekly messages during the month of September via County email, stanemergency.com and social media. There is no cost associated with the recommended action.

BOARD OF SUPERVISORS' PRIORITY:

Approval to proclaim September 2016 National Preparedness Month supports the Board's priority of A Safe Community by educating Stanislaus County residents to prepare and respond to all types of emergencies.

STAFFING IMPACT:

Existing staff from the Office of Emergency Services will provide National Preparedness Month and *Ready* Campaign information to County departments, Operational Area Council members and partner agencies, and the general public.
