Approval to Summarily Vacate the Offer of Road Reservation from Parcel Map Volume 34, Page 49, Lying East of Litt Road, North of Claribel Road and South of the City of Riverbank

STAFF RECOMMENDATIONS:

Pursuant to Street and Highway Codes Sections 8331, 8333, and 8335:

- 1. Find based on the reasons stated in this report, the Road Reservation as described herein, is not required for street and highway purposes.
- 2. Find no public utility improvements have been built, requiring a Public Utility Easement.
- 3. Adopt the attached Resolution vacating the Offer of Road Reservation as shown on Parcel Map, Volume 34, Page 49, Parcel B, Exhibit "A" and as described in Volume 3714, Page 46, Exhibit "B" Stanislaus County Records.
- 4. Direct the Department of Public Works to record the resolution with the County Clerk-Recorder.

DISCUSSION:

The abandonment application was filed by Ramona Pettit, she is the sole owner of the underlying fee title to the property encumbered by the Offer of Road Reservation. The abandonment is being pursued to help alleviate illegal dumping, and trespassing issues. The offer has created some confusion between the adjacent property owners as to access rights on the private property. The Road Reservation was originally offered on Parcel Map Volume 34, Page 49 in 1983. The intent was to provide access for possible future development of the property. This is no longer possible because the current zoning requires a minimum size of 10 acre parcels and the current parcel size is 4.6 acres. Since 1983, no improvements have been made to the proposed road.

The Department of Public Works has determined the Offer of Road Reservation to be excess and wishes to dispose its interest. This action will serve as a constructive notice that the County has no interest in the property on behalf of the public, and the owner has the right to use and control the property. The City of Riverbank, having sphere of influence in this area has also agreed to the abandonment of the offer.

Approval to Summarily Vacate the Offer of Road Reservation from Parcel Map Volume 34, Page 49, Lying East of Litt Road, North of Claribel Road and South of the City of Riverbank

The Road Reservation is currently natural ground. No other utility improvements have been built in the reservation. All local utilities have been contacted for their input and it has been determined that retaining a Public Utility Easement is not required.

The vacation of this Offer of Road Reservation is exempt from review under the California Environmental Quality Act pursuant to Title 14 California Code of Regulations section 15305 as a minor alteration in land use limitations.

POLICY ISSUE:

California Street and Highways Code Sections 8330-8334.6 gives the legislative body of a local agency the authority to summarily vacate a street or highway. This action is being pursued under Section 8335.

FISCAL IMPACT:

All costs for staff time are reimbursed through fees paid by the applicant. The abandonment terminates the County's interest in this Offer of Road Reservation.

BOARD OF SUPERVISORS' PRIORITY:

The recommended actions are consistent with the Board's priority of A Well Planned Infrastructure System by removing any excess road right-of-way that is not needed for road way purposes, therefore removing any liability.

STAFFING IMPACT:

Existing Public Works staff will record documents on behalf of the County.
