#### SUBJECT:

#### STAFF RECOMMENDATIONS:

- 1. Set a public hearing for November 8, 2016, at 9:10 a.m. to consider Lot Line Adjustment and Williamson Act Cancellation Application No. PLN2016-0019, Aker, a request to cancel a 4.25± acre portion of Williamson Act Contract No.77-2725 and LLA involving property located at 4630 and 4530 Lone Tree Road, between Pioneer and Valley Home Roads, in the Valley Home area.
- 2. Authorize the Clerk of the Board to publish notice of hearing as required by law.

#### **DISCUSSION:**

This is a request to set a public hearing for November 8, 2016 to consider Lot Line Adjustment (LLA) and Williamson Act Cancellation Application No. PLN2016-0019, Aker, a request to cancel a 4.25± acre portion of Williamson Act Contract No. 77-2725 and LLA involving two parcels of 0.30± and 4.25± acres, proposed to be adjusted to 1.98± and 2.57± acres, located at 4630 & 4530 Lone Tree Road, between Pioneer Road and Valley Home Road, in the Valley Home area (APNs: 002-010-009 and 002-010-010).

The LLA cannot be approved without cancellation of the 4.25± acre portion of Contract No. 77-2725. The proposed 1.98± and 2.57± net acre parcels cannot be covered by a new Williamson Act Contract, as they will be below the current 10-acre minimum requirement for enrollment in a Williamson Contract.

The existing 4.25± acres parcel is improved with one single-family dwelling and two outbuildings with the remaining acreage being open pasture land. The 0.30± acre parcel is developed with a single-family dwelling with a detached garage. The purpose of the lot line adjustment is to address existing improvements of the 0.30± acre parcel encroaching on the property line.

In order for a Williamson Act contract to be cancelled, the Board of Supervisors must hold a public hearing on the request and make the necessary findings as required by state law, the County's Williamson Act Uniform Rules, and the contract itself. This item requests to set the date and time for a public hearing on the proposed contract cancellation.

#### **POLICY ISSUE:**

In order for a Williamson Act Contract to be canceled, the Board of Supervisors must hold a public hearing on the request and make the necessary findings as required by California Government Code Section 51282, the County's Williamson Act Uniform Rules, and the contract itself. The existing parcels involved in this request do not comply with current minimum acreage requirements for enrollment in a Williamson Act Contract.

#### FISCAL IMPACT:

Costs associated with setting the public hearing, publishing required notices, and conducting the hearing will be covered by the application fee paid by the applicant.

#### **BOARD OF SUPERVISORS' PRIORITY:**

Approval of this action supports the Board of Supervisor's priority of Efficient Delivery of Public Services and A Well Planned Infrastructure by considering a Williamson Act Cancellation request necessary to establishing adjusted parcels that are consistent with the County's General Plan and Zoning Ordinance.
