Dear Mr. Gibson, Mr. Rowe, Mayor Soiseth, Chair Monteith, and WARN Act Coordinator:

We are writing to give you notice of the permanent closing of BlueScope Buildings North America, Inc.'s (the "Company") Turlock facility located at 530 S. Tegner Road, Turlock, California 95380 resulting in the loss of all jobs at this site. The Company expects to complete the total and permanent shutdown of its facility at this location on or about March 3, 2017.

All affected employees have been notified of their separation dates and that their separation from employment will be permanent. Employees will end their employment on March 3, 2017. A listing of the affected job titles and number of affected employees in each job classification is provided on Attachment "A." The Company does not have a job bumping system, that is, employees will not be able to displace more junior employees out of their job positions as a result of this closure. There is no union representation at this site.
