Approval of the Oakdale Irrigation District Request for the Registrar of Voters to Render Election Services and Conduct a Special Recall Election on April 25, 2017

STAFF RECOMMENDATIONS:

- 1. Approve the Oakdale Irrigation District request for the Registrar of Voters to render all services, facilities, supplies and equipment necessary to conduct the special recall election for Oakdale Irrigation District – Division 4 Director on April 25, 2017.
- 2. Authorize the increase in appropriations and revenue of \$21,560 for the Clerk-Recorder, Elections Division budget for associated costs to conduct the special recall election on April 25, 2017, funded by reimbursement from the Oakdale Irrigation District.

DISCUSSION:

The Oakdale Irrigation District requests that the Stanislaus County Board of Supervisors authorize the County Registrar of Voters to conduct a special recall election on April 25, 2017.

Pursuant to Elections Code 11320 and 11381, the special recall election shall submit both the question of recall or removal of Oakdale Irrigation District Director – Division 4 and the election of one of those candidates nominated to succeed the recalled officer if a majority of the votes on a recall proposal are "yes".

If the District 4 – Director is recalled, the candidate receiving the highest number of votes for the office shall be declared elected for the unexpired term of the recalled officer, pursuant to Elections Code 11385.

If a majority of the votes on a recall proposal are "no", the District 4 – Director shall continue in office, pursuant to Elections Code 11383.

POLICY ISSUE:

Pursuant to Elections Code 10002 and subject to the approval of the Board of Supervisors, the County Registrar of Voters shall provide the specified election services necessary to conduct an election requested by a district.

Approval of the Oakdale Irrigation District Request for the Registrar of Voters to Render Election Services and Conduct a Special Recall Election on April 25, 2017

FISCAL IMPACT:

The Oakdale Irrigation District will reimburse the County pursuant to Election Code 10002 for services performed upon completion of the election and presentation to the District of an invoice. The Registrar of Voters estimates the election cost to be between \$15,840 and \$21.560.



BACKGROUND AND/OR HISTORY:

The District received the Registrar of Voters' Certificate of Recall Petition from the County of Stanislaus on December 14, 2016 by email. The certificate verifies the number of sufficient signatures on the recall petition. The Elections Code requires that within fourteen (14) days after the meeting at which the governing body receives the certificate of sufficiency the governing body shall issue an order stating that an election shall be held to determine whether or not the officer named in the petition shall be recalled (Elections Code §11240).

The election shall be held not less than 88 days, nor more than 125 days after the issuance of the order (Elections Code §11242).

Issuance of Order:

December 21, 2016

April 2, 2017*

125 days:

May 9, 2017

The District shall pay for the costs incurred for the recall which are estimated to be \$9-\$11 per voter.

The Stanislaus County Registrar of Voters has set the recall election date for April 25, 2017 (Elections Code §§ 1000 and 1500).

If the Oakdale Irrigation District fails to issue the order within 14-days, the County Elections Official, within 5-days, shall set the date for holding the election (Elections Code §11241).

*If election date falls on a weekend or holiday; it will be moved to the next business day.
