SUBJECT:

Approval to Purchase Samsung Zero Client Displays for the Virtual Desktop Infrastructure Project from Saitech, Inc., Fremont, CA

STAFF RECOMMENDATIONS:

- 1. Approve the purchase of Samsung Zero Client Displays from Saitech, Inc., Fremont, CA, for the Virtual Desktop Infrastructure Project, in the amount not to exceed \$111,610.60.
- 2. Direct the Auditor Controller to transfer appropriations from Fixed Assets to Services and Supplies as detailed in the attached budget journal.

DISCUSSION:

The Library currently has 380 computer workstations installed in both staff and public areas. The majority of these workstations were installed in 2008 and are currently running Windows XP, an outdated and unsupported operating system. As part of the Library's plan to simplify its Information Technology (IT) infrastructure, and update to a currently-supported operating system, a refresh of all of the 380 computer workstations with a Virtual Desktop Infrastructure (VDI) and associated Zero Client Displays was chosen.

VDI is the practice of hosting a desktop operating system within a virtual machine, like the Zero Client Display, that runs on a centralized server housed at a separate location. centralized server replaces each individual hard drive and allows IT staff to manage and update all VDI computer workstations simultaneously from one location.

The purchase and implementation of VDI was planned and scheduled to occur in Fiscal Year 2015-2016; however, consultants hired to assist with the VDI project identified several major upgrades that needed to be completed in order for the Library's IT infrastructure to be able to support a VDI environment. The upgrades were not completed in time to allow IT staff to select, order and encumber the VDI equipment prior to Fiscal Year 2015-2016 year end.

The General Services Agency (GSA) – Purchasing Division, in collaboration with the Library, developed Invitation for Bid (Bid) #16-88-CB: Samsung Model NC241-TS.

The Bid was issued on November 15, 2016. Bid notifications were sent to over 200 vendors. Thirty-six vendors downloaded the Bid. Questions were received from three potential proposers and Addendums 1 and 2 were issued in response. The Bid closed on November 29, 2016 and GSA Purchasing received 13 proposals from the vendors listed below. The amounts reflected include sales tax and e-waste disposal fees.

Saitech, Inc. submitted the lowest bid and it meets all of the Bid requirements. The General Services Agency (GSA) – Purchasing Division issued an acceptance of proposal letter to Saitech, Inc. on December 7, 2016 to purchase 315 SAMSUNG Model NC241-TS Zero Clients with a 36 month parts and labor warranty (Attachment 1).

The purchase of the Zero Client Displays is the next step in moving forward with the VDI conversion. This design will simplify the support and maintenance of the Library's computer workstations, allowing Library IT staff to focus on more important tasks.

POLICY ISSUE:

County Purchasing policies and procedures require a competitive bid process for new goods and services in excess of \$45,000, unless proven to be a Sole Source. Procurements in excess of \$100,000 require Board of Supervisors approval.

FISCAL IMPACT:

Existing appropriations in the Library's Fiscal Year 2016-2017 Budget will be used to purchase the 315 SAMSUNG Model NC241-TS Zero Clients. The attached budget journal (Attachment 2) transfers appropriations in the amount of \$111,611 from Fixed Assets to the appropriate Services and Supplies account.
