STAFF RECOMMENDATIONS:

- 1. Set a public hearing for April 18, 2017, at 6:35 p.m. to consider Planning Commission's recommendation for approval of Williamson Act Contract Cancellation and Parcel Map Application No. PLN2016-0108, Beachler Rumble, a request to cancel a 3.56 acre portion of Williamson Act Contract No. 1971-0064, to allow the creation of a 3.56 acre parcel and a 36.74 acre remainder, from a 40.3 gross acre parcel located at 3780 Ladd Road, on the southeast corner of Ladd and Stoddard Roads, in the Salida area.
- 2. Authorize the Clerk of the Board to publish notice of hearing as required by law.

DISCUSSION:

This is a request to cancel a 3.56 acre portion of Williamson Act Contract No. 1971-0064, to allow the creation of a 3.56 gross acre parcel (currently operating a custom ripping and leveling agricultural services business under Use Permit No. PLN2015-0086, Rumble Ag Services, Inc.) and a 36.74 gross acre remainder (currently improved with a single-family dwelling, detached agricultural storage barn, row crops, and almond orchard), from a 40.3 gross acre parcel in the Salida Community Plan – Planned Industrial zoning district. No change in land use is proposed as part of this project. This request would allow Rumble Ag Services, Inc. to be located on a 3.56 acre separate legal parcel. In order to create a parcel less than 10 acres in size, a Williamson Act Contract Cancellation is required.

On March 16, 2017, the Planning Commission held a public hearing and on a 9-0 vote, recommended the Board of Supervisors approve the request as proposed.

This item will set the date and time for a public hearing to consider the Planning Commission's recommendation before the Board of Supervisors.

POLICY ISSUE:

In order for a Williamson Act Contract to be canceled, the Board of Supervisors must hold a public hearing on the request and make the necessary findings as required by California Government Code Section 51282, the County's Williamson Act Uniform Rules, and the

contract itself. The purpose of the Williamson Act cancelation is to allow for the approval of a parcel map creating parcels consistent with Stanislaus County's General Plan and Zoning Ordinance.

FISCAL IMPACT:

Cost associated with setting the public hearing, publishing required notices, and conducting the hearing will be covered by the application fee paid by the applicant.

BOARD OF SUPERVISORS' PRIORITY:

Approval of this action supports the Board of Supervisor's priority of Efficient Delivery of Public Services and A Well Planned Infrastructure by considering a Williamson Act Cancellation request necessary to create parcels that are consistent with the Stanislaus County's General Plan and Zoning Ordinances.

Planning and Community Development Department staff is responsible for reviewing all applications, preparing all reports, and attending meetings associated with the proposed Williamson Act Contract Cancellation and Parcel Map application.
