STAFF RECOMMENDATIONS:

- 1. Set a Public Hearing on May 2, 2017 at 9:05 a.m. to introduce and waive the first reading of an ordinance to increase existing fees for Clerk-Recorder services to produce an official record.
- 2. Authorize the Clerk of the Board to publish the notice of hearing as required by law.

DISCUSSION:

This is a request to set a public hearing to consider the introduction and waive the first reading of an ordinance to increase existing fees for services in the Clerk-Recorder's office. Government Code section 27366 provides that the Board of Supervisors shall set the fees for production of official records in the Clerk-Recorder's office in an amount necessary to recover the direct and indirect costs of providing the copy. The fees for such production were last adopted in 2001 in the amount of \$3.00 for the first page and \$2.00 for each subsequent page. (See County Code Chapter 4.34)

This item will set the date and time for a hearing on the matter before the Board of Supervisors.

POLICY ISSUE:

Prior to amending similar existing fees, the County is required by Government Code Section 54985 et seq., to hold a scheduled public hearing as part of a regularly scheduled meeting of the Board of Supervisors. However, Sections 54985 et seq. do not apply to production fees for official records. For consistency and best practice this action aligns with County standard fee procedures which are addressed in a scheduled public hearing as part of a regularly scheduled meeting of the Board of Supervisors. At that time, the Board of Supervisors may introduce and waive the first reading of an ordinance to amend existing fees for Clerk-Recorder services to produce an official record.

FISCAL IMPACT:

There is a nominal fiscal impact associated with setting this public hearing for mandatory newspaper publishing which will be covered by the existing Clerk-Recorder's budget. If the proposed fee adjustments are approved, it is estimated that an increase in fee revenue will cover the direct and indirect costs of this public service.

BOARD OF SUPERVISORS' PRIORITY:

The recommended actions are consistent with the Board's priority of Efficient Delivery of Public Services by adopting necessary and reasonable fees to cover direct and indirect costs, consistent with State law, of Clerk-Recorder services to produce an official record.

STAFFING IMPACT:

Existing staff will support these recommended actions.
