#### SUBJECT:

Approval to Set a Public Hearing for May 16, 2017, at 6:35 p.m. to Consider the Planning Commission's Recommendation for Approval of Specific Plan Amendment Application No. PLN2015-0123 – Diablo Grande 2016, Located 10 Miles Southwest of the City of Patterson, in the Diablo Grande Community (APN Book 025, Index B, C, & D) and Adoption of an Addendum to an Environmental Impact Report

#### STAFF RECOMMENDATIONS:

- 1. Set a public hearing for May 16, 2017, at 6:35 p.m. to consider the Planning Commission's recommendation for approval of Specific Plan Amendment Application No. PLN2015-0123 Diablo Grande 2016, a request to modify the Diablo Grande Specific Plan text and Phase 1 Preliminary Development Plan to reflect current site conditions, refine development standards, increase development density, and utilize the 15 percent unit shift between villages, to increase the number of permitted residential units from 2,017 to 2,354 in the 2,250± acre Diablo Grande Community, located 10 miles southwest of the City of Patterson.
- 2. Authorize the Clerk of the Board to publish notice of public hearing as required by State law.

#### **DISCUSSION:**

This is a request to modify the Diablo Grande Specific Plan text and Phase I Preliminary Development Plan (PDP) to: (1) reflect current conditions, and (2) refine development standards allowing for an increase in development density.

On April 6, 2017, the Planning Commission held a public hearing and on a 6-0 vote, recommended the Board of Supervisors approve the request as proposed. The applicant's representative, counsel for West Stanislaus County Fire Protection District, and a Diablo Grande resident spoke in favor of the project. No one spoke in opposition.

This item will set the date and time for a public hearing to consider the Planning Commission's recommendation before the Board of Supervisors.

#### **POLICY ISSUE:**

In order to consider an amendment to the Specific Plan, the Board of Supervisors must hold a public hearing. The proposed project is consistent with the site's existing General Plan designation of Specific Plan. Modifying the Specific Plan text and Phase I Preliminary Development Plan will retain consistency between the General Plan and Zoning Designation for this site.

#### **FISCAL IMPACT:**

Costs associated with processing the application, setting the public hearing, publishing of required notices, and conducting the hearing will be covered by the application fee deposit plus revenue from additional invoicing at project end. Final calculations will determine if additional invoicing to the applicant is needed.

#### **BOARD OF SUPERVISORS' PRIORITY:**

The proposed project is consistent with the Board's priorities of A Well Planned Infrastructure System and A Strong Local Economy by providing a land use determination consistent with the overall goals and policies of the Stanislaus County General Plan.
