Section 1. Section 4.34.010 G., of the Stanislaus County Code is amended to read as follows:

“G. Clerk-Recorder department fees for production of an official record are \$6.75 for the first page and \$3.00 for each additional page.”

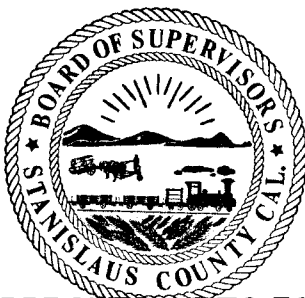
