STAFF RECOMMENDATIONS:

DISCUSSION:

On January 10, 2017 the Board of Supervisors approved the Oakdale Irrigation District's request to authorize the Registrar of Voters to render all services, facilities, supplies and equipment necessary to conduct a special recall election for Oakdale Irrigation District -Division 4 on April 25, 2017.

Pursuant to California Elections Code 15372, the Registrar of Voters has prepared and submitted a certified statement of the results of the recall election to the Oakdale Irrigation District, as the governing body.

POLICY ISSUE:

The Registrar of Voters provided election services as requested by the Oakdale Irrigation District pursuant to California Election Code 10002.

FISCAL IMPACT:

The Oakdale Irrigation District will reimburse the County pursuant to Election Code 10002 for services performed upon completion of the election and presentation to the District of an invoice. The Registrar of Voters estimates the election cost to be between \$15,840 and \$21,560.

BOARD OF SUPERVISORS' PRIORITY:

The recommended action supports the Board's priority of ensuring Efficient Delivery of Public Services and Effective Partnerships by authorizing the Registrar of Voters to conduct elections when requested by districts.

STAFFING IMPACT:

Existing staff within the Elections division have prepared and issued the attached statement.
