RECOGNIZING COLLEEN CHARLTON, OUTSTANDING SENIOR CITIZEN OF DISTRICT 1, STANISLAUS COUNTY

WHEREAS, Ms. Colleen Charlton volunteered as a Cub Scout Den Mother for 4 years; and.

WHEREAS, Ms. Charlton volunteered as the Awards Chairperson for a Boy Scouts Council for 4 years, documenting and evaluating the Scouts' progress towards badges and awards, and then ordering the appropriate badge / award for the Scouts once they fulfilled all needed requirements; and,

WHEREAS, Colleen volunteered for 3 years as a member of the Parent Teacher Association; and,

WHEREAS, she was a Hospice Volunteer for 2 years; and,

WHEREAS, Ms. Colleen Charlton volunteered as a Parish Nurse for 1½ years; and,

WHEREAS, Ms. Charlton is truly dedicated in helping others, whether it is a resident in a nursing facility or another Ombudsman with a difficult case. She is a very loving and compassionate person who wholeheartedly gives of herself.

We strive for excellence valuing: Respect, Integrity, Teamwork, Understanding, and Open Communication. Imagine Unlimited Potential"); and,

WHEREAS, Mary was a member of HOGs (Harley Owners Group) for 5 years, and was active on behalf of the fundraiser bike rides that were held to raise funds for MS (Multiple Sclerosis), and toys for needy children at Christmas; and,

WHEREAS, she served for 4 years on the In-Home Supportive Services Advisory Committee; and,

WHEREAS, Ms. Mary Burch served for 4 years on the Board of Directors for Community Continuum College; and.

WHEREAS, Ms. Burch voluntarily fed homeless people in Donnelly Park in Turlock for 4 years (she lived across the street from the Park); and,

WHEREAS, Mary has dedicated her life to serving others, having been a caregiver for her mother-in-law for 12 years, a caregiver for her own mother for 8 years, and caring for her disabled daughter for 43 years, all while doing a variety of volunteer work; and.

WHEREAS, she takes humble pleasure in helping others, whether paying for grocery items for the person in the line behind her, paying for prescriptions for senior citizens, or donating money to the homeless, with the goal of making them all feel valued for who they are.

NOW, THEREFORE, BE IT RESOLVED that the Stanislaus County Board of Supervisors does hereby congratulate Ms. Mary Burch for being the Outstanding Senior Citizen for District 2 and the Board additionally thanks Mary for her very special contributions to the entire community of Modesto, and to Stanislaus County.

RECOGNIZING ALFRED GARCIA OUTSTANDING SENIOR CITIZEN OF DISTRICT 3, STANISLAUS COUNTY

WHEREAS, the Stanislaus County Board of Supervisors wishes to acknowledge the outstanding service and commitment of senior citizens; and,

WHEREAS, Mr. Alfred Garcia served in the United States Marine Corp for 4 years; and,

WHEREAS, Mr. Garcia has been a member of the American GI Forum, PFC Oscar Sanchez, Modesto Chapter, for 43 years. The American GI Forum is a congressionally chartered Hispanic Veterans and Civil Rights organization that advocates for Veterans' issues (mental health, education, employment, etc.). For the last 5 years, Alfred served as the Chapter Commander, where he provided instrumental leadership in encouraging the membership to step up and work on behalf of Veterans (he also served in this capacity in the 1980's). The organization's motto is "Education is our Freedom and Freedom should be Everybody's Business." To that end, fundraisers, such as the annual 'Black and White Ball' are held to provide scholarships to deserving students. Mr. Garcia currently serves as the 2nd Vice Commander of the State GI Forum, and his leadership there inspires members statewide to actively advocate on behalf of Veterans; and,

WHEREAS, Alfred has been a member of the Disabled American Veterans (DAV) for 17 years; and,

WHEREAS, he has been a member of the Ceres American Legion Post # 491 for 4 years; and,

WHEREAS, Mr. Alfred Garcia has served as a Trustee for the Veterans of Foreign Wars (VFW) #3199 for 2 years, volunteering 10+ hours per month; and,

WHEREAS, Mr. Garcia served as the Chaplain of the Marine Corps League, Bill King Detachment, for 1 year, volunteering 5+ hours per month; and,

WHEREAS, Alfred is a member of the VFW Honor Guard Funeral Detail; and,

WHEREAS, he has voluntarily taught a GED class for El Concilio; and,

WHEREAS, Mr. Alfred Garcia has received accolades for his valuable volunteer work in the community, as he was recognized as the 2013 Veteran of the Year by the Latino Community Roundtable, and selected as the 2016 Veteran of the Year for Assembly District #21 by Assemblyman Adam Gray. His leadership, spirit, positivity, and perseverance make him an exemplary volunteer role model for others.

WHEREAS, the Stanislaus County Board of Supervisors wishes to acknowledge the outstanding service and commitment of senior citizens; and.

WHEREAS, Mr. Albert Lucchesi served in the United States Army for 3 years; and,

WHEREAS, Mr. Lucchesi has been a Volunteer with HICAP (Health Insurance Counseling and Advocacy Program) for 11 years, volunteering 2-3 days a week and 45+ hours per month, mostly in the Modesto Office, but he also holds office hours in Patterson and Turlock once a month. HICAP "provides free and objective information and counseling about Medicare. Volunteer counselors can help you understand your specific rights and health care options." His Supervisor notes that he is highly self-motivated and takes the initiative to learn new things and be well informed. He took extensive training to become a Medicare expert so he would give accurate information to his clients. He is always willing and able to assist with whatever is needed, and he is dedicated to working with the senior, disabled, and homeless populations, being very sensitive to their needs and making them feel respected. Al recently became a new Volunteer for the Senior Medicare Patrol, and in this role he will be educating the community and Medicare beneficiaries on Fraud Awareness; and,

WHEREAS, Albert has been actively involved for 7 years in two service programs at St. Joseph's Catholic Church:

- Family Promise program (a member of the interfaith ministry of 11 congregations in the Modesto area) that "provides temporary shelter and support to homeless families, helps them find permanent affordable housing, and provides other family support services to low income families with children"; and,
- St. Vincent de Paul Ministry "leads women and men to join together to grow spiritually by offering person to person service to the needy and suffering. Services provided include twice a week food bag distribution from the SVDP office and weekly assistance with emergency utility assistance and other needs"; and,

WHEREAS, he volunteered for 6 years, serving on the Department of Correction's Chowchilla Women's Facility Advisory Council; and,

WHEREAS, Mr. Albert Lucchesi volunteered for 6 years, serving on the Madera County Behavioral Drug Abuse Commission; and,

WHEREAS, Mr. Lucchesi was a Red Cross Volunteer for 4 years; and,

WHEREAS, Albert served on the Stanislaus County Civil Grand Jury for 2 years; and,
