# SUBJECT:

Public Hearing to Introduce and Waive the First Reading of an Ordinance to Establish New Fees and Amend Existing Fees for Planning Services

## STAFF RECOMMENDATIONS:

1. Conduct a public hearing to introduce and waive the first reading of an ordinance to establish new fees and amend existing fees for planning services.

# **DISCUSSION:**

The last comprehensive Planning and Community Development Department initiated increase to the planning fee schedule was adopted by the Board of Supervisors on May 18, 2010. The planning fee schedule reflects separate fees for the Planning and Community Development Department (Planning and Planning Commission Clerk), Department of Public Works, Department of Environmental Resources (DER), and Clerk of the Board associated with the review and process of land use permits and Williamson Act contracts. Since 2010, the only amendment to the planning fee schedule, specific to mining and re-inspection fees, was approved by the Board of Supervisors on April 28, 2015.

The 2016-2017 Adopted Final Budget included appropriations of \$20,000 for the Planning and Community Development Department to procure a consultant to perform a fee study for planning services. The Department has awarded a contract to a consultant to complete the fee study which is anticipated to be completed within the next six months. This item proposes an interim fee adjustment to reflect a 10% increase to the Planning portion of the fee schedule. The recommended 10% increase is consistent with changes in the Consumer Price Index (CPI). As reported by the Bureau of Labor Statistics Western Region (all cities population range <1,000,000), the CPI increased 9.8% between January 2010 and January 2017. Similarly, the Department's weighted labor rates have increased by approximately 20% since the 2010 fee increase was approved. This interim fee adjustment will allow the Department to begin to recoup a portion of the increase in operating costs that have been incurred since 2010 (e.g., salaries, benefits, office materials, and equipment), and addresses external increases in other direct costs incurred in the processing of discretionary permits.

The Department is recommending a phased approach to adjusting the fee schedule. Approval of a 10% increase will bring the fees charged more closely aligned with actual costs incurred to provide planning services. Once the comprehensive fee study has been completed by the consultant, it is anticipated that additional fee adjustments may be necessary in order to

recoup costs associated with providing planning services. Staff will return to the Board of Supervisors for consideration and approval of the findings and recommendations associated

In addition to the above 10% increase, the following changes have been incorporated into the fee structure:

with the study in 2018.

- 1. Planning Commission Clerk and Clerk of the Board fees have been increased to reflect increased publication costs for legal notices. In a few cases, the Planning Commission Clerk fee has been eliminated for application/activities not requiring legal notices or where the fee reflected an outdated document recording fee. The fee schedule has been updated to reflect that the required "additional recorder fees," if documents must be recorded, is in addition to any other fees. Document recording fees will continue to be in the amount set by the Clerk Recorder's Office.
- 2. A fee for Environmental Studies and Peer Reviews (of environmental studies) has been added to the fee schedule. Currently, there is no adopted fee to allow for recovery of these costs when not associated with a project billed at actual cost. However; there are times when fixed-cost projects require environmental studies prepared by a licensed professional (e.g., biological, traffic, or noise studies.) The Department has service agreements in place to obtain the necessary studies, but not the authorization to charge for the studies. There are also situations with controversial projects, where neighbors might claim that a study prepared under contract by the applicant is bias and, as such, the County needs to obtain an independent third party peer review. The proposed fee is actual cost with a deposit equal to the initial cost estimate for the study/review based on an agreed upon scope of services.
- 3. A fee for Field Inspections/Site Visits needed to verify compliance with conditions of approval and/or mitigation measures has been added to the fee schedule. The proposed actual fee, with a one hour minimum deposit, will be calculated annually based on the July 1<sup>st</sup> average weighted labor rate of planner staff (assistant/associate/senior/deputy director) assigned to performing the inspection/visit. The fee based on July 1, 2016 average weighted labor rate would be: \$69.
- 4. A fee for Permit and Zoning research has been added to the fee schedule. Currently, the Planning division only has a mechanism to charge for permit research for single-family dwelling (SFD) and zoning verification letter requests made by a property owner. There is no general cost recovery for a permit research request made by the general public. The proposed fee will be the same as the proposed Field Inspection/Site Visits fee.
- 5. A general note has been added to require that any application which has been inactive for one year, or more, be recharged current applicable fees, unless it is determined by the Director that the work performed under the original fee will not need to be revised and/or updated.
- 6. A general note has been added to require that any application submitted to legalize, or correct for a violation of the County Code, shall be charged actual cost with a deposit amount equal to the adopted application fee.

7. The fees for documents and media are proposed to be updated to reflect actual cost. With the availability of Department documents and Planning Commission material online (e.g., agendas, staff reports, audio, and video) request for these items are rare.

No other changes are being proposed by the Planning Department to the fee structure adopted by the Board of Supervisors in 2010. Since 2010 the weighted labor rates charged by both the Department of Environmental Resources (DER) and Public Works as part of planning fee schedule have been increased. This year, DER is proposing to increase their weighted labor rate from \$106 to \$111 per hour. The proposed fee schedule is provided in Attachment 1. New fees and added notes are shown in bold text and old fees are shown in strikethrough text. The proposed fee schedule also incorporates some general edits for cleanup purposes.

The average proposed increase per application type not requiring a public hearing is \$25. The average proposed increase per application type requiring a public hearing, including "actual cost" deposit applications, is \$192. The average proposed increase per deposit for an "actual cost" application type is \$279. The proposed increase for two of the Department's most common application types are: \$230 for an agricultural Use Permit and \$235 for an agricultural Parcel Map, involving Williamson Act contracted land, or requests to create more than four parcels.

A review of the eight comparison counties (Fresno, Kern, Madera, Merced, Monterey, Sacramento, San Joaquin, and Tulare) demonstrates the proposed total fee amounts in many cases are either equal to or less than the total fees charged by other agencies. Some comparison counties surveyed offer lower planning services fees as outlined below:

- Fresno County (Lot Line Adjustments, Parcel Maps, Tentative Maps, and Variances),
- Kern County (Lot Line Adjustments),
- Madera County (all application types),
- Merced (all application types), Sacramento County (Use Permit),
- San Joaquin County (Rezone); and,
- Tulare County (Lot Line Adjustment).

However; many of the lower fees found in the comparison counties have a range, with the high end of the range exceeding Stanislaus County's proposed fees. In addition, many of the comparison counties charge a California Environmental Quality Act (CEQA) review/Initial Study fee in addition to the application fee. Stanislaus County's application fees include the CEQA review/initial study costs. A fee comparison with comparable county agencies is provided in Attachment 2.

## **POLICY ISSUE:**

Prior to levying a new fee, or amending an existing fee, Stanislaus County is required by Government Code Section 54985 et seq., to hold a scheduled public hearing as part of a regularly scheduled meeting of the Board of Supervisors. At that time the Board may introduce and waive the first reading of an ordinance to establish new fees and amend existing fees of the Planning and Community Development Department. If approved, these fees will become effective on June 23, 2017.

## FISCAL IMPACT:

The increase in revenue resulting from the approval of this interim fee proposal is expected to partially offset direct costs related to processing land use permits and Williamson Act contracts and the ongoing provision of services.

It is anticipated that with the total adjustments as proposed, revenues to the Planning and Community Development Department may potentially increase by approximately \$15,000 based on Fiscal Year 2016-2017 permitting volumes.

## **BOARD OF SUPERVISORS' PRIORITY:**

This recommended action is consistent with the Board's priorities of A Safe Community, A Healthy Community, A Strong Local Economy, A Strong Agricultural Economy, A Well-Planned Infrastructure System, and the Efficient Delivery of Public Services by providing for cost recovery needed to allow the Department to continue providing high quality, streamlined permit processing services for the benefit of all our customers.

# AN ORDINANCE TO ADOPT A REVISED FEE SCHEDULE FOR SERVICES BY THE DEPARTMENT OF PLANNING AND COMMUNITY DEVELOPMENT

THE BOARD OF SUPERVISORS OF THE COUNTY OF STANISLAUS, STATE OF CALIFORNIA, ORDAINS AS FOLLOWS:

**Section 1**: The Board of Supervisors hereby adopts the Department of Planning and Community Development 2017 Fee Schedule, attached as Exhibit A and incorporated by reference, a copy of which is on file with the Clerk of the Board of Supervisors and is available for public inspection and copying in that office in accordance with the California Public Records Act.

**Section 2.** This ordinance shall be published once before the expiration of 15 days after passage of this ordinance, with the names of the members voting for and against the same, in the Modesto Bee, a newspaper published in the County of Stanislaus, State of California, and the ordinance shall take effect either (a) pursuant to Section 25123 of the Government Code, 30 days after the date of publication, or (b) pursuant to Section 66017 of the Government Code, 60 days following the final action on the adoption of the fees or charges, whichever date occurs last.

#### PLANNING FEE SCHEDULE NOTES

(1) Fees described above that require a deposit and are charged at "actual cost" have a minimum charge associated with them. The deposit required is the minimum charge and is non-refundable. This DOES NOT include any necessary consultant costs for environmental review, specialized studies, financial consulting or any other expert consulting services potentially needed by the County for processing these applications. Monthly draws against the deposit will be made based on staff time and materials needed to process the applications. Staff costs and expenses for Planning, Public Works, and DER will be billed at fully burdened weighted labor rates as provided by the Auditors Office at the time of services rendered.

All additional-staff time and expenses needed to complete the application processing that exceed the deposit amount will be charged at actual-cost, including labor charged at the weighted labor-rate. Invoices will be calculated on a quarterly basis and forwarded to the applicant for payment. If the deposit reaches a balance of 20% of the initial deposit or less, the Applicant will be asked to make a subsequent deposit in an amount dependent upon the amount of work left to complete on processing. Applicants will be expected to pay the subsequent deposit within 30 days of invoice date. In the event that the account is not paid within 30 days of the invoice date, processing will be suspended until such time that payment is made. Any remainder will be used to reconcile your final bill. If there is a balance remaining after reconciling the final bill, a refund check will be mailed to you. Public hearings will not be scheduled until payment in full is received.

- \* Fees may be refunded if the Planning Director, or his/her appointed designee, determines extraordinary circumstance warranting a refund exist.
- (2) Applications for two or more actions (for-example: i.e. Tentative Map and Exception ) will be charged the highest application fee, except applications for a Lot Line Adjustment or Williamson Act Cancelation See Exception Note Below. For those applications for two or more actions that include an action that is charged at "actual cost" (for example: General Plan Amendment, Rezone, & Parcel Map) they will be charged the highest deposit amount as a minimum charge and deposit; The this deposit is non-refundable. All additional staff time and expenses needed to complete the application processing that exceed the deposit amount will be charged at actual cost, including staff costs to be billed at fully burdened labor-sharged at-the-weighted labor rate per note #1 above. Exceptions: If a Lot Line Adjustment is included in a Combination Application, an additional \$695 will be required beyond the set fee or deposit amount in order to obtain a "Certificate of Compliance" from Public Works. Additional time required for these types of request will be charged at the same hourly rate.
- (7) Fees for the Departments of Public Works and the Department of Environmental Resources shall only apply when processing of the application(s) require referral to and/or action by the respective Departments.
- (8) A 1% Administrative Cost Recovery Fee will be charged to Public Works, Department of Environmental Resources, and Clerk of the Board for fees collected during the Land Use Application proces. An additional 2.5% fee will be charged for fees collected by credit card.
