ORDINANCE NO. C.S. 1189

AN ORDINANCE RELATING TO FARES FOR TRANSIT SERVICE

THE BOARD OF SUPERVISORS OF THE COUNTY OF STANISLAUS, ORDAINS AS FOLLOWS:

Section 1. Fares for transit services provided by Stanislaus Regional Transit ("StaRT") are amended and adopted as set forth in Exhibit A attached hereto and incorporated by this reference.

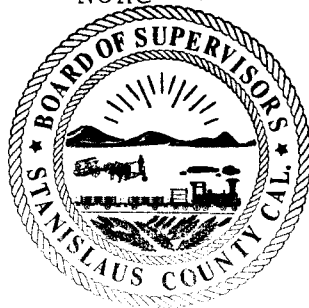

This ordinance shall take effect thirty (30) days from and after the date of its passage and before the expiration of fifteen (15) days after its passage it shall be published once, with the names of the members voting for and against the same, in the Modesto Bee, a newspaper published in the County of Stanislaus, State of California.
