Approval to Introduce and Waive the First Reading of an Ordinance to Amend Section 11.08.020 of the Stanislaus County Code, Adding a No Parking Zone on Floto Street in the La Grange Area

---

**STAFF RECOMMENDATIONS:**

1. Introduce and waive the first reading of an ordinance amending section 11.08.020 of the Stanislaus County Code, adding a No Parking zone on Floto Street in the La Grange area.

**DISCUSSION:**

The owner of the property located at 3054 Yosemite Boulevard and the lot immediately to the south of this property along Floto Street requested that a No Parking zone be established along Floto Street from Yosemite Boulevard extending just beyond his property access.

The owner has had issues with vehicles parking on this portion of Floto Street, which cause access issues to his property and blocks the southbound lane of Floto Street. Public Works staff investigated the complaint and concluded that vehicles should not be parking along Floto Street near its intersection at Yosemite Boulevard due to an inadequate width to provide both a travel way and parking. To alleviate this issue, the Department of Public Works staff recommends that a No Parking zone be installed on the west side of Floto Street from its intersection with Yosemite Boulevard south for 140 feet.

The specific description of the proposed amendment is identified and further described in the text of the proposed ordinance.

**POLICY ISSUE:**

California Vehicle Code 22507 requires Board Approval to establish no parking zones.

**FISCAL IMPACT:**

The cost to install two new signs is estimated to be \$500. Funding is available in the Adopted Proposed Fiscal Year 2017-2018 Public Works Roads Operation budget.

**ORDINANCE NO. C.S. \_\_\_\_\_**

**AN ORDINANCE AMENDING STANISLAUS COUNTY CODE,  
SECTION 11.08.020 RELATING TO A NO PARKING ZONE  
ON FLOTO STREET IN THE LA GRANGE AREA**

The Board of Supervisors of the County of Stanislaus, State of California, do ordain as follows:

**Section 1.** Amend the Stanislaus County Code, Title 11, Chapter 11.08, Section 11.08.020 (Red Curb Marking – Streets Designated) to add Subsection 545 (Floto Street) as follows:

"545. Floto St. On the west side of Floto St from its intersection thereof with Yosemite Blvd, south one hundred forty feet;"

**Section 2.** This ordinance shall take effect 30 days from and after the date of its passage, before the expiration of 15 days after its passage, it shall be published once with the names of the members voting for and against the same in the Modesto Bee, a newspaper in the County of Stanislaus, State of California.
