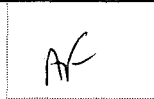

Approval to Accept the Nuisance Abatement Hearing Board's Decision of Costs Regarding the Expenses to Abate the Nuisance Located at 1313 Inyo, in the Modesto Area, Dangerous Building Abatement (DNB) Case No. 2016-0001

STAFF RECOMMENDATIONS:

1. Approval to accept the Nuisance Abatement Hearing Board's Decision of Costs regarding expenses to abate the nuisance located at 1313 Inyo, in the Modesto area, DNB2016-0001.
2. Authorize the recovery of costs associated with the forced clean-up as a recorded lien by special assessment on the property and the recording of the lien amount on the Assessment Roll.

DISCUSSION:

The Stanislaus County Planning and Community Development Department responds to dangerous building complaints throughout the unincorporated area of Stanislaus County and attempts to gain voluntary compliance through personal contact with property owners and those entities that have a financial interest in the property. Compliance efforts include: conducting investigations, issuing and posting Notice and Orders to Abate, recording the Certificate of Existence of Substandard and Dangerous Building(s) with the Clerk Recorder's Office, presenting cases before the Nuisance Abatement Hearing Board, forwarding the decision to the Board of Supervisors, and conducting forced clean-ups through a competitive bid process.

On February 23, 2017, the Nuisance Abatement Hearing Board supported staff's recommendation that the property located at 1313 Inyo, in the Modesto area, was a nuisance and forwarded the matter to the Board of Supervisors recommending their approval. On March 7, 2017, the Board of Supervisors adopted the Nuisance Abatement Hearing Board's Decision in Board Action No. 2017-104 and authorized a forced clean-up at the property. Following the Board's action, the Planning and Community Development Department and the Stanislaus County General Services Agency facilitated the bid process and procured a contract with Modesto Sand and Gravel for the demolition of the dwelling and clean-up of the property. The demolition and clean-up was completed on April 18, 2017.

On June 22, 2017, the Nuisance Abatement Hearing Board supported staff's recommendation that the billing for the abatement and clean-up was reasonable and forwarded the matter to the

Board of Supervisors for consideration. By accepting the Nuisance Abatement Hearing Board's Decision of Costs (Attachment 1) the Board of Supervisors affirms the reasonableness of the billing. Once accepted, the charges will be forwarded to the Treasurer - Tax Collector to be collected in a manner prescribed by County Code as a recorded lien by special assessment against the property. For a detailed summary of costs see Attachment 2.

POLICY ISSUE:

The Board of Supervisors' acceptance of the decision of the Nuisance Abatement Hearing Board is necessary for recording of a lien by special assessment on the property for recovery of abatement costs pursuant to Stanislaus County Code Section 2.92.070.

FISCAL IMPACT:

In June 2014, the Board of Supervisors approved an item to expand the Dangerous Building Abatement Program using Neighborhood Stabilization Program (NSP) income. NSP provides funding for payment of abatement activities in targeted NSP areas. The costs associated to administer the abatement process include: contractor costs, staff time, and other incidental costs allowed by Stanislaus County Code. The costs associated with the abatement and forced clean-up will be fully covered by NSP 1 funds which were included in the Planning and Community Development Department's Fiscal Year 2016-2017 Adopted Final Budget.

If accepted, forced clean-up costs of approximately \$13,736 will be placed on the property as a recorded lien for the abatement of the dangerous building and it may take up to five years before the property is auctioned and reimbursement is received.

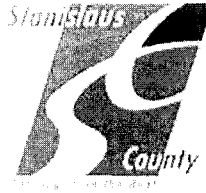
