

ORDINANCE NO. C.S. 1199

AN ORDINANCE AMENDING STANISLAUS COUNTY CODE,  
SECTION 11.08.020 RELATING TO A NO PARKING ZONE  
ON FLOTO STREET IN THE LA GRANGE AREA

The Board of Supervisors of the County of Stanislaus, State of California, do ordain as follows:

**Section 1.** Amend the Stanislaus County Code, Title 11, Chapter 11.08, Section 11.08.020 (Red Curb Marking – Streets Designated) to add Subsection 545 (Floto Street) as follows:

"545. Floto St. On the west side of Floto St from its intersection thereof with Yosemite Blvd, south one hundred forty feet;"

**Section 2.** This ordinance shall take effect 30 days from and after the date of its passage, before the expiration of 15 days after its passage, it shall be published once with the names of the members voting for and against the same in the Modesto Bee, a newspaper in the County of Stanislaus, State of California.

Upon motion of Supervisor Olsen, seconded by Supervisor DeMartini, the Foregoing ordinance as passed and adopted at a regular meeting of the Board of Supervisors of the County of Stanislaus, State of California, this 8th day of August, 2017, by the following called vote.


