STAFF RECOMMENDATIONS:

 Authorize the Chairman to sign the Annual Medi-Cal Cost Avoidance Program and Annual Subvention Program Certificates of Compliance issued by the California Department of Veterans Affairs

DISCUSSION:

The Stanislaus County Veterans Services Office (CVSO) assists Veterans, their dependents and survivors in obtaining Federal, State, and County benefits, such as: compensation for service related injuries; reopen compensation for re-evaluation increase; VA medical care; vocational rehab; benefits for convalescent and assisted living residents; survivors annuity based upon service connected death; pension for war era Veterans; death pension for survivors of war era Veterans who died of a non-service connected disability; dependent allowances; California state Veterans homes; request for military records and decorations; discharge upgrade and correction of military records; life insurance; burial benefits and National Cemetery information; State college tuition fee waiver program for dependents; fishing and hunting licenses; license plates; motor vehicle registration fee waiver; and Veterans Tax benefits. The CVSO also offers information and referral for education benefits, home loans (both CA and Cal Vet), hospitalization, outpatient medical and dental treatment, alcoholism and drug dependence treatment program, employment and/or unemployment compensation, small Business Administration, Social Security, and PTSD (Post Traumatic Syndrome Disorder) counseling.

The annual Subvention Program partially funds counties for expenses incurred in the operation of the County Veterans Service Office, in accordance to Military and Veterans Code Sections 972, and 972.1, A State General Fund Expenditure, and 972.2 a Special Fund Expenditure. The Stanislaus County Veterans Services Office anticipates receiving \$108,295 for Fiscal Year 2017-2018.

The annual Medi-Cal Cost Avoidance Program Certificate of Compliance is authorized by Military and Veterans Code Section 972.5. The program establishes that all activities of the CVSO reasonably benefit the Department of Health Care Services (DHCS) or realize cost avoidance to the Medi-Cal program. All State and County Medi-Cal Eligibility Workers who generate a Form CW-5 (Veterans Benefits Referral) and/or MC 05 (Military Verification and

Referral form) will be instructed to indicate the applicant's Aid Code on the face of the form and send it to the local CVSO.

The California Department of Veterans Affairs requires that all counties receiving State Subvention and Medi-Cal Cost Avoidance funding must certify that the county is in compliance with the administrative requirements and regulations as prescribed by the California Department of Veterans Affairs. The California Department of Veterans Affairs also requires the counties' Chairman of the Board to sign the Certificates of Compliance certifying that the county is in compliance with the Military and Veterans Code Sections 972, 972.1 and 972.2.

POLICY ISSUE:

In accordance with Military and Veterans Code Section 970, the Board of Supervisors may appoint a County Veterans Services Officer (CVSO) to administer the aid to Veterans provided for in Division 4, Chapter 5, Military and Veterans Code. The CVSO must be aware of, and abide by, the vast network of requirements and regulations as prescribed by various agencies and levels of government, including: Military and Veterans Code, Article 4, Sections 970 through 973, the California Code of Regulations (CCR), Title 12, Sections 450 through 455, and Title 38, U.S. Code, Sections 1.5 and 14.6.

FISCAL IMPACT:

It is anticipated the Stanislaus County Veterans Services Office will receive approximately \$108,295 in funding for Fiscal Year 2017-2018 from the California Department of Veterans Affairs. This funding will be included in the Fiscal Year 2017-2018 Final Budget.

BOARD OF SUPERVISORS' PRIORITY:

By authorizing the Chair to sign the Annual Medi-Cal Cost Avoidance Program and Annual Subvention Program Certificates of Compliance, the Department of Aging and Veterans Services will be able to continue to provide Veterans services to residents of Stanislaus County, consistent with the Board's priority to promote the Efficient Delivery of Public Services by providing excellent community services.
