**STAFF RECOMMENDATIONS:**

1. Introduce and Waive the First Reading of an Ordinance Amending Section 11.08.020 of the Stanislaus County Code, Amending a Red Curb Marking on Waring Road in the Denair area.

**DISCUSSION:**

Several constituents in the Denair area have contacted Public Works staff and have requested a No Parking Anytime Zone along the east side of Waring Road near Haven Way and Monte Vista Avenue.

Public Works staff conducted a field investigation and found that vehicles, including trucks with trailers, were parking along the east side of Waring Road posing a sight obstruction for motorists turning from Haven Way onto Waring Road. Additionally, vehicles turning from westbound Monte Vista Avenue to northbound Waring Road cannot see the vehicles parked around the corner prior to turning.

A No Parking Zone 970 feet long currently exists along the east side of Waring Road immediately to the north in front of the Country Squire community. To help alleviate this issue and enhance traffic safety, the Department of Public Works staff recommends that the existing No Parking Anytime Zone be extended from its existing termini, to Monte Vista Avenue.

The specific description of the proposed amendment is identified and further described in the text of the proposed ordinance.

**POLICY ISSUE:**

California Vehicle Code 22507 requires Board approval to change parking zones.

ORDINANCE

**AN ORDINANCE AMENDING STANISLAUS COUNTY CODE,  
SECTION 11.08.020 RELATING TO A NO PARKING ZONE  
ON WARING ROAD, IN THE DENAIR AREA**

**THE BOARD OF SUPERVISORS OF THE COUNTY OF STANISLAUS ORDAINS AS  
FOLLOWS:**

Section 1. Amend the Stanislaus County Code, Title 11, Chapter 11.08, Section 11.08.020 (Red Curb Marking – Streets Designated) to amend Subsection 215 (Waring Road) to read as follows:

“215. Waring Road. On the east side of Waring Road from its intersection with Monte Vista Avenue to a point one thousand three hundred thirty feet north of the intersection;”

Section 2. This ordinance shall take effect 30 days from and after the date of its passage, and before the expiration of 15 days after its passage, it shall be published once with the names of the members voting for and against the same in the Modesto Bee, a newspaper in the County of Stanislaus, State of California.
