## SUBJECT:

Approval of Appointment in Lieu of Election to the Knights Ferry Community Services District for the November 7, 2017 Consolidated District Election

## STAFF RECOMMENDATIONS:

1. Whereas not more than one person was nominated for the elective offices to be filled at the Consolidated District Election to be held on Tuesday, November 7, 2017, or there were no nominees as of 5:00 p.m. on Wednesday, August 16, 2017, the Registrar of Voters requests the Board of Supervisors make appointments in lieu of election as indicated:

Three Directors (4 Year Full Term): Eric R. Ulrich, Sean P. McCarthy (no other candidate(s) filed) Two Directors (2 Year Short Term): Nancy Warren Patton, Jason C. Turner

## DISCUSSION:

Pursuant to California Elections Code 10515, the County Clerk - Recorder - Registrar of Voters submits to the Board of Supervisors and requests that the Board of Supervisors in its capacity as the supervising authority of the district, make appropriate appointment(s) in lieu of the election.

California Elections Code 10515 provides the following directive to elections officials and district boards: (a) If, by 5 p.m. on the 83rd day prior to the day fixed for the general district election: (1) only one person has filed a declaration of candidacy for any elective office to be filled at that election, (2) no one has filed a declaration of candidacy for such an office, (3) in the case of directors to be elected from the district at large, the number of persons who have filed a declaration of candidacy for director at large does not exceed the number of offices of director at large to be filled at that election, or (4) in the case of directors who must reside in a division but be elected at large, the number of candidates for director at large from a division does not exceed the number required to be elected director at large while residing in that division; and if a petition signed by 10 percent of the voters or 50 voters, whichever is the smaller number, in the district or division if elected by division, requesting that the general district election be held has not been presented to the officer conducting the election, he or she shall submit a certificate of these facts to the supervising authority and request that the supervising authority, at a regular or special meeting held prior to the Monday before the first Friday in December in which the election is held, appoint to the office or offices the person or

persons, if any, who have filed declarations of candidacy. The supervising authority shall make these appointments.

### POLICY ISSUE:

Pursuant to California Election Code 10515, the Board of Supervisors shall make appointments of those who have filed declarations of candidacy in lieu of election.

### FISCAL IMPACT:

There is no fiscal impact associated with this item.

### BOARD OF SUPERVISORS' PRIORITY:

The recommended action of Appointment in Lieu of Election supports the Board's priority of ensuring Efficient Delivery of Public Services by maintaining and improving the efficiency of County government processes through the Appointment in Lieu of Election process.

#### **STAFFING IMPACT:**

There is no staffing impact associated with this item; existing staff within the County Clerk-Recorder Elections division have prepared and issued the attached statement.
