NOTICE IS HEREBY GIVEN THAT the State Water Resources Control Board (State Water Board) will accept comments on the proposed approval of the Central Valley Regional Water Quality Control Board's (Central Valley Water Board) amendment to the Water Quality Control Plan for the Sacramento River and San Joaquin River Basins that would establish a control program, including Total Maximum Daily Loads (TMDLs), for discharges of pyrethroid pesticides (Basin Plan amendment).
