Approval of the Request from Knights Ferry Elementary School District to Consolidate and Hold Future Elections on the Same Day as the Statewide General Election Conducted in Even-Numbered Years

STAFF RECOMMENDATIONS:

- 1. Approve the request from the governing board of the Knights Ferry Elementary School District to consolidate future elections on the same day as the Statewide General Election conducted in even-numbered years.

DISCUSSION:

The California legislature has enacted the California Voter Participation Rights Act. Cited in California Elections Code (EC) sections 14050 through 14057, it would prohibit a political subdivision from holding an election other than on a statewide election date if holding an election on a non-statewide election date has *previously* resulted in a significant decrease in voter turnout. A "significant decrease in voter turnout" is defined as 25% less than the average voter turnout within that political subdivision for the previous four Statewide General Elections.

Registrar of Voters anticipates the desire of districts within Stanislaus County that have traditionally consolidated into the Uniform District Election Law (UDEL) election held on the first Tuesday following the first Monday in November of odd-numbered years to move to consolidate on the same day as the Statewide General Election conducted in even-numbered years.

The governing body of the Knights Ferry Elementary School District has submitted a resolution to the Board of Supervisors to place its election of governing body members to be held on the same day as the Statewide General Election conducted in even-numbered years.

If the Board of Supervisors approves this request, consistent with California Elections Code section 10404.5, the Knights Ferry Elementary School District will change its election dates from November of odd-numbered years to the Statewide General Election held in even-numbered years. The Resolution (Attachment) requests the Board of Supervisors to approve

the District's request to schedule its board member elections in 2020 and 2022 to consolidate with the Statewide General Election in even-numbered years.

Pursuant to Elections Code 10404.5 (c) the Board of Supervisors has notified all school districts and the Stanislaus County Board of Education of the receipt of the resolution to consolidate and requested input from each district on the effect of consolidation.

Pursuant to Elections Code 10404.5 (e), within thirty (30) days after the approval of the resolution by the Board of Supervisors, the Registrar of Voters shall notify all registered voters of the district affected by the consolidation. The notice shall be delivered by mail and at the expense of the school district.

County Impact

An analysis conducted by the Elections office indicates that the Elections System and Software voting system currently used in Stanislaus County can accommodate these district changes. With the addition of districts to the Statewide General Election Ballot, the physical length of each ballot card increases from 14 inches to a maximum of 19 inches in length; the number of ballot cards can increase from one ballot card per voter per election to two ballot cards per voter per election; and additional ballot types, additional sample ballot pamphlets, voting units, printers, precinct ballot tabulators and vote-by-mail ballot tabulators will be required to process votes and to provide timely results.

The original purpose of the Unified District Election Law (UDEL) odd-numbered year election was to provide a local election platform for districts and candidates to appeal to voters, avoiding conflict with the extensive State and Federal general election cycle. Local candidates in an odd-numbered year election are prominent and can better educate voters on their election race. These same candidates and races in an even-year election are considered "down ballot" contests and receive fewer votes, and often are the recipients of "pattern" votes where a voter votes the first, second or last candidate on each race depending on the ballot position their selected presidential or gubernatorial candidate is positioned on the ballot.

The unique preparation and election requirements for a UDEL election require the Elections Office to prepare candidate nomination documents, Fair Political Practices Commission (FPPC) monetary requirements and election law filing requirements which are different from those in the current General Election even-year cycle. Once these two very different election types are consolidated into a single even-numbered year election, the Elections Office preparation and cost to the County will necessitate an increase in both budget and staffing to enable two separate mandated elections to coincide on the same ballot within the same election cycle.

POLICY ISSUE:

As required by Elections Code 10404.5 (a), the Knights Ferry Elementary School District has notified the Stanislaus County Board of Supervisors that it has passed a resolution requesting the consolidation of board member elections with future Statewide General Elections, which

will move the current election dates of the seated board members from odd-numbered to even-numbered years.

Elections Code 10404.5 (d) (1) requires that the Board of Supervisors approve the resolutions unless it finds that Stanislaus County's ballot style, voting equipment or computer capacity is such that additional elections or materials cannot be handled. No evidence exists to support such a finding.

FISCAL IMPACT:

The Registrar of Voters anticipates an increase in election related expenses for the even-numbered election years.

Local elections require a higher level of candidate support including nomination papers, candidate statements, ballots, sample ballot pamphlets and additional election preparation. Additional Elections staff support is anticipated, as well as impacts to the County General Fund because the County will be responsible to pay the increased division costs attributed to the Elections Division.

The Knights Ferry Elementary School District will continue to be invoiced and reimburse Stanislaus County for election specific costs to conduct their district election in even-numbered years. The blending of local elections with statewide elections is anticipated to increase the overall level of services required of the Registrar of Voters.

Alternately, as fewer districts continue to consolidate with the Uniform District Election Law (UDEL), it is likely to drive up costs for those remaining districts that continue to hold their elections in odd-numbered years.

There is no immediate fiscal impact associated with this approval. Any increases in costs will be addressed in the respective budget year affected.

BOARD OF SUPERVISORS' PRIORITY:

Approval of the recommended action supports the Board of Supervisors' priority of Efficient Delivery of Public Services by consolidating local district elections with the Statewide General Elections in even-numbered years.

STAFFING IMPACT:

Consolidation of local school district elections with Federal, State and County even-numbered year contests is anticipated to increase the level of staffing services in the Elections Division to conduct two different types of mandated elections on the same established election date.

Re: Knights Ferry Elementary School District Request to Reschedule Governing Board Member Elections from Odd-Numbered Years to Even-Numbered Years; Elections Code Section 10404.5

Dear Supervisors:

Please be advised that the Knights Ferry Elementary School District ("District") at a regular meeting held Thursday, September 14, 2017, voted to change its governing board member election schedule from odd-numbered years to even-numbered years.

Pursuant to Elections Code section 10404.5, the District hereby submits a copy of the District's resolution along with this formal request to the County Board of Supervisors to approve the change sought by the District.

Under Elections Code section 10404.5(d)(1), the County Board of Supervisors shall approve the resolution within 60 (sixty) days of receiving the request unless it finds that the ballot style, voting equipment, or computer capacity is such that additional elections or materials cannot be handled.

The District seeks to consolidate its election with the statewide general election for several reasons. First, voter turnout is generally greater for statewide general elections than for special local elections including school board member elections. Second, there is a potential cost savings to the District for consolidating. Third, the District wishes to avoid any potential liability resulting from the recently enacted California Voter Participation Rights Act as a result of maintaining elections in odd-numbered years.

Currently, there is insufficient time to change the District's election method in advance of the November 2017 election.

RESOLUTION NO. [#20172018002]

A Resolution by the Governing Board of the Knights Ferry Elementary School District (“Board”) for consolidation of future governing board member elections with the statewide general election pursuant to Elections Code section 1302(b).

RECITALS

WHEREAS, the current date for election of governing board members of the Knights Ferry Elementary School District (“District”) is every two (2) years on the first Tuesday after the first Monday in November of odd-numbered years (e.g., November 2017) [Ed. Code, § 5000 and Elec. Code, § 1302(a)]; and

WHEREAS, statewide elections are held in California only in June and November of even numbered years (e.g., November 2018) [Elec. Code, § 1001]; and

WHEREAS, with the passage of the California Voter Participation Rights Act [Elec. Code, § 14050, et seq.], the Legislature has indicated its interest in providing for the greatest possible voter participation in local elections, including school district governing board member elections; and

WHEREAS, voter turnout is generally greater for statewide elections than for special local elections including school district governing board member elections; and

WHEREAS, the Board desires to change the date of future Governing Board member elections to be consolidated with the California Statewide general election in order to provide greater voter input into Governing Board elections; and

WHEREAS, Elections Code section 1302(b) authorizes the District to change the election date for its Governing Board members by adopting a resolution for consolidation of election and seeking approval of the change by the Board of Supervisors of the affected county in accordance with Elections Code section 10404.5; and

WHEREAS, if the change in election date is approved, the November 2019 District election date will be moved to the first Tuesday after the first Monday in November 2020, with the terms of Governing Board members which would have expired in December 2019 being extended to December 2020 and the terms of Governing Board members which would have expired in December 2021 being extended to December 2022 [Elec. Code, § 10404.5(g)].

NOW, THEREFORE, BE IT RESOLVED that the Governing Board of the District adopts this Resolution to consolidate the election date for members of the Governing Board with the date for the California general election held in November of even-numbered years [Elec. Code, § 1001] pursuant to Elections Code section 1302(b).


BE IT FURTHER RESOLVED that the Superintendent, or designee, is directed to submit this Resolution to the Stanislaus County Board of Supervisors explaining the rationale for the Resolution and requesting formal approval of the change by the Board of Supervisors at a public meeting within sixty (60) days after submission, and after the Resolution has been posted in public places.

BE IT FURTHER RESOLVED that if the request for consolidation of election is approved by the Stanislaus County Board of Supervisors, the District recognizes its obligation to pay the expense of mailing the notice of approval of the change in election date by the Stanislaus County Board of Supervisors as required by Elections Code section 10404.5(e).


BE IT FURTHER RESOLVED that if the request for consolidation of election is approved by the Stanislaus County Board of Supervisors, the date of the next scheduled Governing Board election in November 2019 shall be moved to the first Tuesday after the first Monday in November 2020 and each subsequent Board member election shall be held two (2) years thereafter in November of even numbered years in conjunction with the statewide general election.

BE IT FURTHER RESOLVED that if the request for consolidation of election is approved, the term of office of current Governing Board members expiring in November 2019 shall be extended to November 2020 and the term of Governing Board members expiring in November 2021 shall be extended to November 2022.
