**AN ORDINANCE ADOPTING NEW FEES TO BE CHARGED SPECIFICALLY FOR

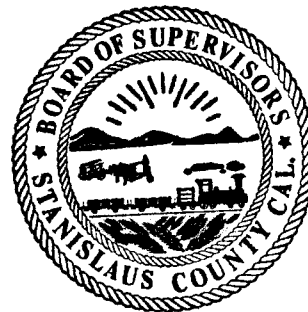
