#### **DISCUSSION:**

On May 6, 2014, after a successful appeal to the Board of State and Community Corrections, Stanislaus County was awarded \$40 million dollars under SB 1022 to build a re-entry facility. On April 19, 2016, the Board of Supervisors approved a contract with Roebbelen Contracting, Inc. (Roebbelen) to construct the SB 1022 REACT Center.

The Stanislaus County SB 1022 REACT Center will improve and significantly enhance the County's Public Safety Facilities to provide for development of jail alternative programs, in-custody treatment, counseling, and re-entry services.

The County of Stanislaus is proud to be the only California County that was awarded funding from the State of California for three separate facility financing programs aimed at housing and rehabilitating juvenile and adult offenders:

SB 81 for local youthful offenders;

- AB 900 Phase II for local adult offenders; and
- SB 1022 for local criminal justice facilities, including support buildings and program space.

The construction of the SB 1022 REACT (Re-Entry and Enhanced Alternatives to Custody Training) Center is the final piece of a very determined plan to modernize public safety facilities and bring more opportunity for those incarcerated to change their lives and reduce the tragic cycle of recidivism in our community.

The REACT Center has enabled the County to construct new program space within the secure perimeter of the Public Safety Center that links with the Stanislaus County Probation Department's Day Reporting Center. The program space will allow for evidence-based programs to enhance current alternatives to incarceration. Key to the project are the programmed spaces for adult education, religious services, counseling, self-help classes, mental health evaluations/classes, and other life-skills and job/career preparatory programs.

Through the design and construction of the SB 1022 REACT Center, and by designing its Public Safety Center campus to accommodate various types of facilities in close proximity to one another, the County has developed a comprehensive programs delivery process, focused on enhancing current programs and services to include presentenced, post-booking, and reentry/transitioning populations.

The Sheriff will be able to further centralize public safety operations with the completion of the REACT Center. The REACT project will allow for the closure of the Downtown Men's Jail, expect for Court holding (until the State of California constructs a new Courthouse). This is a significant goal and accomplishment that dates back to the late 1980's when an objective was established to consolidate all three jail locations into one at the new Public Safety Center.

This project represents the final phase of the Stanislaus County Public Safety Center Expansion Projects and the completion of the County's \$120 million jail expansion plan. Other projects included the Day Reporting Center, Project One (Maximum Security and Medical/Mental Health Facility) and Project Three (Intake, Release and Transportation).

### Next Steps for the SB 1022 REACT Center

While construction of the facility is now complete, work continues in order to prepare the facility for opening and commencement of operations in May 2018. Remaining funds available in the project budget will complete the furniture and equipment plan and install a video visitation system.

The REACT Center adds an additional 288 replacement beds. No new staff positions are planned in the REACT Phased Staffing Plan. The REACT Center will activate based on the phased opening and staffing plan. The REACT Center will open with staff positions currently located at the existing Men's Jail.

The Men's Jail will convert and become a Court Holding Facility. The facility will no longer operate on a 24/7 basis but will operate Monday through Friday, opening and closing each day. Once converted, the Court Holding Facility will operate using eight existing staff positions currently assigned to the Men's Jail.

The REACT Phase I opening will activate 192 replacement beds and move 26 existing staff positions from the Men's Jail to the REACT Center. This activation is currently planned for May 2018 and will meet the Board of State and Community Corrections (BSCC) occupancy timeline.

The REACT Phase II opening will activate an additional 96 replacement beds and utilize the remaining 17 staff positions from the Men's Jail. The time frame for this Phase II activation is dependent upon the Sheriff's ability to fill staff vacancies. A rough estimate for Phase II occupancy is late 2018.

Successful completion of this project finishes the largest capital projects effort undertaken by the County and is a significant accomplishment for the community. The successful and timely completion of the REACT Center is a tribute to the design teams: HOK Architects, Lionakis, the Sheriff's Transition Team, the Capital Projects team, the inspection team and the outstanding General Contractor, Roebbelin Industrial Contractors.

#### **POLICY ISSUE:**

The Board of Supervisors has the responsibility for final acceptance of capital improvement projects.

### **FISCAL IMPACT:**

The original estimate to build the REACT Center was \$44,583,000, which includes all soft costs. The State of California funded \$39,888,000 or 90% of the project cost and the County funded \$4,695,000 which includes the required 10% local match and \$250,000 of ineligible costs.

The original estimate for construction only of the REACT Center project was \$35,693,105. The final construction cost for the REACT Center is \$32,797,880, which includes approximately 1% in approved Change Orders.

The total construction of the REACT project is nearly \$2.9 million under budget.

#### **BOARD OF SUPERVISORS' PRIORITY:**

These actions will advance the Board of Supervisors' priority to strive for A Safe Community with the construction of a facility that focuses on reduction of recidivism, increased detention capacity to meet projected needs, use of alternatives to

incarceration and providing program opportunities consistent with the Public Safety Realignment.

These actions also support the Board's priority to provide Efficient Delivery of Public Services in pursuing State funds by leveraging limited County resources effectively.

### **STAFFING IMPACT:**

The existing Capital Projects Team and the Sheriff's Transition Team will continue to collaborate as they focus on the successful completion of this major Public Safety Center Expansion effort and prepare to commence operations at the REACT Center.

### The REACT Center

- The REACT Center will:
  - Add 288 Replacement Beds through a Phased Opening;
  - Transition the Downtown Men's Jail to Court Holding Only; and,
  - Complete the County's Public Safety Campus Masterplan and the largest capital projects effort ever undertaken by the County.

- Prepare for Staffing of the Facility.


















