The undersigned, being first duly sworn, says:

That I am the General Manager/Secretary of the Del Puerto Water District; and

That in accordance with authority and responsibilities assigned to me by the Board of Directors in accordance with the Uniform District Elections Code, the California Water Code, and Resolutions of the Board of Directors of the Del Puerto Water District adopted July 19, 2017 and September 20, 2017, I personally attest and swear upon penalty of perjury to the following:

- 1) On November 13, 2017, after the conclusion of the All-Mail Ballot Election, I collected all the ballots cast in preparation for tabulating the ballots for the Division 3 Board of Director position and the Measure submitted to Voters entitled "Shall the mailed ballot be used to conduct all future general district elections".
- 2) I then proceeded to tabulate the ballots in accordance with the provisions of said Board of Directors Resolutions, the Uniform District Elections Code, and the California Water Code.
- 3) <u>Division 3 Board of Director Position & Measure</u> The results of the tabulation of the ballots showed the following:
 - A. The Total Number of Ballots mailed to potential voters was 81.
 - B. The Total Number of Ballots returned was 62.
 - C. The Total Number of Ballots rejected in accordance with the provisions of said Board of Directors' Resolutions, the Uniform

District Elections Code, and the California Water Code Government Code was 25.

- D. In accordance with ballot weighing provisions of said Board of Directors' Resolutions, the Uniform District Elections Code, and the California Water Code Government Code, the maximum number of potential votes was 14,758.
- E. The actual number of votes received and note rejected during the voting time period was 7,551.
- F. The number of votes cast in favor of Division 3 Candidate Peter Lucich was 5,141 and in favor of Candidate Hunter Riddle was 2,410. The number of YES votes regarding the Measure was 6,205 and NO votes was 1,346.

Accordingly, as a result of the above voting tabulation, and in accordance with the provisions of said Board of Directors' Resolutions, the Uniform District Elections Code, and the California Water Code, Peter Lucich is deemed to have been elected to the Division 3 Board of Director position for term beginning December 1, 2017 and ending December 3, 2021, and the Measure submitted to Voters entitled "Shall the mailed ballot be used to conduct all future general district elections" is deemed to have been approved.

Every holder of title to land within the Del Puerto Water District, or his or her legal representative, shall be entitled to cast one vote for each irrigable acre's worth of land, as provided in the California Water District Code. See the Voter's Information Guide mailed earlier for more complete information regarding your voting rights.

The Election Official, at the time of mailing the ballot to each person qualified to cast a vote, shall affix thereon the number of votes to which the voter is entitled. Any error in the number of votes shall be corrected only by the Del Puerto Water District Election Official. No ballot shall be counted by the District if the number of votes affixed hereon has been altered. If this ballot does not have a number above indicating the number of votes to which you are entitled, return it immediately to the Del Puerto Water District for a replacement. If you believe the number of votes set forth above is incorrect, Contact the District for verification or correction.

All marks, except a cross (+ or X) and a write-in candidate are forbidden. If you wrongfully mark, tear or deface this ballot, return it to the Del Puerto Water District Office to obtain another ballot.
