STAFF RECOMMENDATION:

- 1. Set a Public Hearing on May 15, 2018 at the 6:30 p.m. meeting to introduce and waive the first reading of an ordinance to establish new fees and amend or eliminate existing fees for the Department of Environmental Resources.
- 2. Authorize the Clerk of the Board to publish notice as required by law.

DISCUSSION:

The Department of Environmental Resources (Department) charges fees for services it provides in the program areas of Environmental Health, Hazardous Materials, Landfill, Code Enforcement, Solid Waste, and Milk and Dairy. State law mandates that fees charged for services cannot exceed actual costs and must be used to cover the costs of implementing the programs.

Annually, in preparation for the Proposed Budget, the Department evaluates the program costs and the fees associated with programs administered. This process includes the consideration of new or additional fees, where appropriate, as well as modifications to existing fees in order to cover the program costs. The recently conducted fee survey of comparable counties in the State found that the proposed fees, later mentioned in this report, are in line with other counties of comparable demographics.

The Department is proposing new fees and fee modifications to some of its programs, in addition to adjusting the Department's weighted labor rate (WLR), which impacts all programs and fee categories for services that are charged by the hour such as plan check fees. If approved, these fee changes will become effective on June 22, 2018, with the exception of the landfill fees that would become effective on July 1, 2018. The proposed fee schedule is included as Attachment 1 and details regarding recommended fee modifications are as follows:

Environmental Health Fee

The California State Water Resources Control Board (Water Boards) contracts with the Department to serve as its Local Primacy Agency (LPA) for public water systems in the County's unincorporated areas. When a violation of the California Safe Drinking Water

Act or any of its regulations, permits, standards, citations or orders issued or adopted goes uncorrected, the Department may issue a citation to the public water system. According to the California Safe Drinking Water Act, Article 9, Section 116650 (e), In these instances, "the State Board may assess a penalty in an amount not to exceed one thousand dollars (\$1,000) per day for each day that a violation occurred, and for each day that a violation continues to occur."

As the LPA, the Department enforces this State program for public water systems with less than 200 service connections, and as such, the State has directed each LPA to impose citation penalty fees to noncompliant public water systems to encourage timely compliance. At this time, the Department's Fee Schedule does not reflect the citation penalty described in the California Safe Drinking Water Act, Article 9, Section 116650(e). As the Water Boards' LPA, it is imperative that the Department Fee Schedule reflect the State's statues in order to enforce a citation penalty. The Department proposes adding a new Citation with Penalty Fee - Not to exceed \$1,000 per day in the Water Program Fee Schedule as reflected in Attachment 1. Staff will continue with its historic efforts to obtain compliance without imposing administrative penalties, but when necessary, the Department estimates approximately \$5,000 a year in revenue from enforcing the citation with penalty fee for non-compliant public water systems.

Hazardous Materials Fee

On December 5, 1995, the Department received approval from the Board of Supervisors to submit an application to the California Environmental Protection Agency (Cal EPA) to become the Certified Unified Program Agency (CUPA) for Stanislaus County. The application indicated that CUPA's are required to implement a consolidated permit program, single fee system, and a single, unified inspection and enforcement program to minimize duplication and overlap. The Hazardous Materials Division's Inspection and Enforcement Plan was prepared according to the requirements of Section 15200 (a), Title 27, California Code of Regulations.

In a November 18, 1996, letter, Cal EPA accepted the Department's application and appointed the Department to serve as the Stanislaus County CUPA effective January 1, 1997. In its capacity as a CUPA, the County administers the following programs, pursuant to the authorities granted by the California Health and Safety Code, Section 25404:

- Hazardous Materials Business Plan Program
- California Accidental Prevention Program
- Hazardous Waste Generator Program
- Tiered Permitting Program
- Underground Storage Tank (UST) Program
- Aboveground Petroleum Storage Tank (AGT) Program
- Medical Waste Management Program

Pursuant to the California Health and Safety Code (H&SC), Chapter 6.11, Section 25404.1.1, if the CUPA determines that a person has committed or is committing a violation of any law, regulation, permit, information request, order, variance, or other

requirement, the CUPA is authorized to enforce or implement an Administrative Enforcement Order requiring the violation be corrected and imposing an administrative penalty. To comply with the State's directive, the Department proposes adding a new Administrative Penalty Fee, as per this California H&SC Section to the Hazardous Materials Fee Schedule as reflected in Attachment 1. In these instances, a penalty of up to ten thousand dollars (\$10,000) per day for each day that a violation occurred may be assessed.

The Department uses educational means to gain the cooperation of business operators and achieve compliance with statutes and regulations. When educational efforts alone are not enough to gain compliance, the Department will be required to utilize appropriate enforcement procedures to achieve compliance. If violations present a significant existing or imminent threat to human health or safety or the environment, formal enforcement action may be initiated immediately.

It is difficult to estimate the enforcement penalties due to many factors, such as: the extent of deviation from legal requirements, the potential for harm/threat to human health and safety and the environment, the violator's compliance history, the violator's good faith efforts to comply, the deterrent effect on the violator and on the regulated community, and any unusual circumstances and/or mitigating factors. With these factors in mind, staff estimates approximately \$10,000 a year in revenue from imposing administrative penalties to violators of the CUPA Program.

Landfill Fees

Elimination of the Solid Material (Inert) Fee

The historic Fink Road Landfill Solid Material (Inert) Fee has been \$5 per ton and the Normal Refuse Fee is currently \$33 per ton. Inert material includes: dirt, rock, gravel, concrete, asphalt, plaster, brick, roofing tile, and sheetrock. A survey of neighboring county landfills (i.e., San Joaquin and Merced) and local transfer stations was completed in order to review and compare other local inert material disposal rates. The survey revealed that neighboring county landfills do not differentiate between inert material and normal refuse. These prices range from \$48.65 per ton (North County Landfill - San Joaquin County), \$38.11 per ton (Foothill Landfill - San Joaquin County), and \$43.05 per ton (Billy Wright, and HWY 59 Landfills – Merced County). The local transfer stations charge between \$20.50 per ton (Turlock Transfer), and \$61 per ton (Bertolotti Transfer). Since inert material does not decompose, it consumes more landfill air space than normal refuse. In addition, due to its nature, disposal of inert materials requires greater usage of equipment and labor. For these reasons, staff recommends that the Solid Material (Inert) Fee category be deleted and that inert material be considered Normal Refuse. This is considered a benefit to the landfill as inert materials are consuming valuable space at a significantly reduced cost.

Ash Tipping Fee

On June 26, 2012, the Board approved the Amended and Restated Service Agreement with Covanta Stanislaus, Inc., for the operation of the Waste-to-Energy facility. As a result, ash tipping fees were raised in Fiscal Year 2012-2013 by \$10 per ton. This increase was necessary in order to cover future ash monocell development/construction costs as well as the post-closure obligations at the Geer Road Landfill. Also included in the new Service Agreement was a clause that would escalate the tipping fee each July

1st based on the Consumer Price Index (CPI), "Urban Wage Earners and Clerical Workers, All items, West-Size B/C." The CPI will increase the ash tipping fee by 2.96% for Fiscal Year 2018-2019. This will increase the current \$27.38 per ton tipping fee for ash to \$28.19 per ton. The estimated increase in revenue from this change will be approximately \$55,000 for Budget Year 2018-2019.

Hard-to-Handle Description Clarification

The current Fink Road Landfill Hard-to-Handle (Bulk Material) Fee description: "large chunks of concrete" and "all other material over 4' x 4" often needs customer clarification. Staff proposes changing the description of the Hard-to-Handle (Bulk Material) to say: "large chunks of concrete over 2' x 2' x 2'," and "all other material over 4' x 4" in order to provide more clarity of the Hard-to-Handle (Bulk Material) definition. The revenue is not expected to change with this written clarification of what is currently identified as Hard-to-Handle (Bulk Material).

Public Meetings

On February 27, 2018, the Department held two public meetings (Attachment 2) to discuss the proposed new, amended and eliminated fees. Information about the workshops was disseminated through the Department's normal dissemination process via postal service mailed to all parties affected or potentially affected by the fees. In addition, information regarding the proposed fee workshops was published in the Modesto Bee and on the Department's website. The overall feedback from the workshop participants was favorable to the proposed new, amended and eliminated fees. One local garbage hauler expressed concern of eliminating the Inert Fee. One Bay Area hauler e-mailed a similar concern. One local business e-mailed a concern of increased fees in general, however, the Department clarified that their annual fee would not be affected by the proposed fees.

POLICY ISSUE:

Prior to adopting a new fee or amending an existing fee, the County is required by Government Code Section 54985 et seq., to hold a scheduled public hearing as part of a regularly scheduled meeting of the Board of Supervisors. At that time the Board may introduce and waive the first reading of an ordinance to establish new and amend existing fees of the Department of Environmental Resources.

FISCAL IMPACT:

If the proposed fee adjustments are approved, the increase in revenue for the Department of Environmental Resources is estimated to be \$70,000 in Budget Year 2018-2019. This includes anticipated revenue increases of \$5,000 from Water Program Citation Penalty Fees, \$10,000 from Hazardous Materials CUPA Penalties, and \$55,000 from Ash Tipping Fees. The recommended fee revenue will be included in the Department's Budget Years 2018-2019 Proposed Budget.

BOARD OF SUPERVISORS' PRIORITY:

The recommended actions are consistent with the Boards' priority of Delivering Efficient Public Services and Community Infrastructure by making funds available to the Department of Environmental Resources to continue to operate efficiently and effectively, and improving the quality of life in Stanislaus County.

STAFFING IMPACT:

Existing staff will support these recommended actions.
