DISCUSSION:

Stanislaus County Department of Parks and Recreation (Department) operates four regional parks that charge entrance, use, and privilege/service fees: Frank Raines Off-Highway Vehicle Park, La Grange Off-Highway Vehicle Park, Modesto Reservoir, and Woodward Reservoir. The revenue collected from these fees pays for the operations and maintenance of these facilities. In addition, the Frank Raines and La Grange Off-Highway Vehicle Parks receive State grants for the operations and maintenance as well as special projects.

Annually, in preparation for the proposed budget, the Department evaluates the cost of services provided and the fees associated with these regional parks. The evaluation process includes the consideration of new fees, where appropriate, as well as modifications to existing fees in order to cover the cost of operations and maintenance at these sites (Attachment 1). The proposed fee changes include the elimination of the Stanislaus County Resident Day Use Discount and include increases in camping and camping discounted fees. The Day Use Discount is proposed to be eliminated because verifying residency negatively impacts the wait times in line at the entrance stations.

The recently conducted fee survey of similar facilities in the surrounding areas found that the proposed camping fees are comparable to other parks with the exception of the Day Use Fee, which will be slightly higher. The staff proposal is that the Day Use fee for all visitors will increase from \$10 to \$15. The current \$10 Day Use fee for Stanislaus County Residents has not been raised since 2011. The proposed Day Use fee is slightly higher than the neighboring Turlock Lake Day Use fee, however the amenities provided at both Modesto and Woodward Regional Parks are much greater than those provided at Turlock Lake. Both Regional Parks provide larger facilities and include Sheriff

Deputy patrols throughout the year. Additionally, the Department has completed many recent projects that have improved the facilities such as resurfaced parking areas, improved and added restrooms, picnic shelter roof replacements, added concrete tables, ash receptacles and barbecue pits, and is currently in the process of upgrading the Modesto Reservoir Fuel Pumps that will allow for improved customer service by upgrading 1970's-era fuel pumps to pumps that allow for the purchase of fuel with a credit card swipe.

In a regularly scheduled meeting on February 8, 2018, the Parks Commission reviewed and recommended to support the proposed fees.

On February 15, 2018, the Department held a workshop (Attachment 2) to review and discuss the proposed fee changes with the public. Information about the workshop was disseminated through the Department's normal process via e-mail to parties affected by the fees, including over 10,000 regular users of the parks and members of the public who requested to be placed on a notification list. Information regarding the proposed fees was also posted on the Department's Internet site, Facebook page, and information was posted in the Modesto Bee on February 10 and 11, 2018, in the legal and public notices section. Approximately sixteen people from the public attended the workshop and no questions or comments were received on the recommended fee changes.

Proposition 26

Proposition 26 was approved by California voters on the November 2010 ballot. Its passage amended sections of the California Constitution to define many fees as taxes, stipulating that they can no longer be levied or increased unless passed by not less than a two-thirds majority vote. The proposition, however, exempts specific types of fees from this requirement as follows: 1) charges imposed for entrance to or use of local government property; and 2) charges for a specific benefit, privilege, or governmental service granted directly to the payer.

County Counsel has opined that Parks and Recreation fees are not a tax under Proposition 26, but did clarify that benefit, privilege, and service fees such as hunting permits and reservation fees cannot be discounted if subsidized by other full fee payors. In these fee categories, all customers must be charged equally and the amounts charged cannot exceed the reasonable cost to provide the benefit/privilege/service. The Department is not proposing to discount any benefit/privilege/service fees and the fees within these categories reflect only the cost of providing these services.

POLICY ISSUE:

Prior to levying a new fee or amending an existing fee, the County is required by Government Code Section 54985 et seq., to hold a scheduled public hearing as part of a regularly scheduled meeting of the Board of Supervisors. At that time the Board of Supervisors may introduce and waive the first reading of an ordinance to establish new and amend existing fees of the Department of Parks and Recreation. If approved, these fee changes will become effective on June 22, 2018.

FISCAL IMPACT:

If the proposed fee adjustments are approved, the increase in revenue for the Department of Parks and Recreation is estimated to be \$500,000 in Budget Year 2018-

2019. If the anticipated revenue materializes, the Department will request to increase Park Maintenance staff in order to perform a higher level of maintenance at Woodward and Modesto Reservoirs where the maintenance needs of the facilities have increased substantially due to the increased visitation.

BOARD OF SUPERVISORS' PRIORITY:

The recommended actions are consistent with the Boards' priority of Delivering Efficient Public Services and Community Infrastructure by making funds available to the Department of Parks and Recreation to continue to operate efficiently and effectively, and improving the quality of life in Stanislaus County.

STAFFING IMPACT:

Existing staff will support these recommended actions.
