# SUBJECT:

Approval of an Exclusive Use Agreement/Permit with Tailfeather Events, Inc., to Hold a Dirtybird Campout Event at Modesto Reservoir Regional Parks From Thursday, October 4, 2018, through Monday, October 8, 2018, and Find the Project Categorically Exempt From the California Environmental Quality Act

# **STAFF RECOMMENDATION:**

- Approve the filing of a Notice of Exemption finding that the proposed event is exempt under the provisions of the California Environmental Quality Act pursuant to State guidelines section 15323.
- 2. Approve the Exclusive Use Agreement/Permit with Tailfeather Events, Inc., to hold a Dirtybird Campout event at Modesto Reservoir Regional Park from Thursday, October 4, 2018, through Monday, October 8, 2018.
- 3. Authorize the Director of Parks and Recreation, or designee, to direct Tailfeather Events, Inc., to adhere to the requirements set forth as outlined in the Temporary Exclusive Use Event Agreement/Permit.
- 4. Authorize the Director of Parks and Recreation, or designee, to negotiate and approve future events with Tailfeather Events.

# DISCUSSION:

Modesto Reservoir Regional Park (MRRP) is located at 18143 Reservoir Road in Waterford. This regional park offers over 3,200 acres of land and 2,800 acres of reservoir for recreation and camping, and open space for outdoor recreation activities. The facility can accommodate tent, trailer, and recreational vehicle camping including full hook-up, developed and undeveloped campsites. Daily recreational opportunities include: swimming, fishing, boating, kayaking, canoeing, picnicking, water and jet skiing, waterfowl hunting and bird watching.

The Department of Parks and Recreation (Department) has received an exclusive use request from Tailfeather Events Inc., an event Production Company, requesting exclusive use of the Modesto Reservoir Regional Park from Thursday, October 4, 2018 - Monday, October 8, 2018, during which they would hold a Dirtybird Campout event. Tailfeather Events, Inc. organizers would be on-site from Wednesday, September 26, 2018 through Thursday, October 12, 2018, to allow for the setup of the event as well as to dismantle and clean up after the event. These dates could vary slightly due to other planned events and the final permit will reflect the actual dates approved.

This event is new to the County; however, Tailfeather Events, Inc. (Tailfeather) has a positive relationship with Monterey County and has produced other successful events at various locations. Staff spoke with Monterey County about their experiences with Tailfeather and no areas of concern were identified; in fact, their staff indicated they would gladly have them back for future events.

The Dirtybird Campout was founded by Claude VonStroke of Dirtybird Records who has partnered with Tailfeather to produce the event. The Dirtybird Campout includes potato sack races, s'mores around a campfire, archery contests, water balloons, tug-of-war, and musical entertainment and dancing in the evenings. The musical artists mingle freely with the attendees and are the Camp "counselors," wearing scout-like uniforms and shouting instructions through megaphones. They lead teams of attendees who are divided into Green, Yellow, Orange and Purple groups and whose progress is posted on a large scoreboard. Winners earn merit badges and prizes. Other activities for the weekend include tie-dyeing classes, scavenger hunts, stand-up comedy shows, yoga classes, and a camp talent show. Food and beverage vendors will also be present.

The Dirtybird Campout would bring approximately 7,500 attendees to Modesto Reservoir for the duration of the event. The event will take place on a weekend after attendance has dwindled from the summer season, presenting a unique opportunity for additional revenue during a typically slower period at the Reservoir.

In preparation for the October 2018 event, a planning meeting was held with the event promoters, coordinators, and local agencies, such as the Sheriff's Office, Consolidated Fire, California Highway Patrol, and Mountain Valley Regional to ensure that any concerns these agencies may have will be addressed. Local agencies, including the cost of law enforcement, will contract directly with TailFeather Events, Inc., for costs associated with supporting this event. In addition, the Department facilitated a meeting in Waterford recently to provide an opportunity for the local community to address any concerns. Invitations were sent to residents within a three mile radius of the Reservoir and nine community members attended the meeting. A few residents who live immediately next to Modesto Reservoir were interested in hearing about the event and asked some questions. They reminisced about other events that had been held at the Reservoir in the past, such as the drag boat races that could be heard as far as Waterford. They appreciated the attention to any traffic issues that could arise and stated that they had received notification of the decibel testing, but pointed out that they had not been disrupted by the sound test. Other attendees were there to gain additional information about the event activities and asked questions regarding security at the event.

The attached Operations Plan includes a fully detailed traffic and noise plan that the event will adhere to in order to ensure that the traffic is managed in an orderly manner and that the decibel levels of the music are maintained within the approved levels (Attachment 1).

An overview of the traffic and noise plans are outlined below:

# Traffic

- Traffic attendants will be on-duty, and a traffic attendant layout plan will be implemented at all times to monitor and control event traffic along Reservoir Road and Highway 132.
- Traffic attendants and security personnel will prevent attendees from attempting to enter the event through private property or from parking on private property surrounding the Reservoir.
- In order to minimize vehicle movement during the event, no ins and outs are allowed for general attendees. For special circumstances, a specific credential will be allocated by the Security Lead on duty at the time of exit.
- Three or more flaggers will be on duty during peak traffic times to ensure that right-of-way for non-event traffic is maintained along Highway 132, and Reservoir Road entering and exiting Modesto Reservoir.
- To keep traffic flowing smoothly, attendees will be ushered off the road into the identified festival entrance gate and routed to a staging area.
- Signage will be used to direct attendees to the festival entrance to ensure the surrounding public roads are not negatively impacted.

# Noise

In May 2018 the Department contracted with Acoustical Engineering Consultants (AEC) to conduct a mock-up concert sound test on the evening of May 10th, between the hours of 9:00 p.m. to 12:00 a.m. Prior to the sound test, the Department mailed approximately 125 letters to the property owners with in a three mile radius of MRRP advising them of the upcoming sound test sometime over a five day time span, and provided a dedicated phone line to facilitate the communication of residents with Department staff during the sound test. The letter instructed people to call the dedicated number to report if they heard noise during the test.

The mock concert consisted of a single speaker tower with ground-stacked low frequency cabinets and a pair of mid/high frequency speaker cabinets flown above. The speaker tower was aimed in three directions: west, north, and east. Music representative of typical events was played through the speakers from approximately 9:00 p.m. to 11:00 p.m. During the test, speaker setups and levels were adjusted to match typical limits set for concerts held at Woodward Reservoir Regional Park based on a previous study which is described in more detail, below.

Continuous sound level measurements were also taken at the Reservoir boundary to the northwest across the reservoir from the speakers. Additional short duration measurements were taken at the nearest residences along Reservoir Road and Yosemite Boulevard/Highway 132. Source sound levels at 50 feet were taken from the speakers for each setup which averaged between 95 dB(A) and 99 dB(A) and 115 dB(C) to 117 dB(C) during the test to match peak limits set for previous concerts at Woodward Reservoir (after correcting the limits for distance). Comparison sound levels near the source with levels near the residence to the northwest approximately 1.9 miles

away. Both A and C weighted levels did not change as the music was cycled on and off, and instead gradually trended lower between 8 pm and 12:30 am as background sources decreased. Levels were below Stanislaus County's noise regulation limits at this location with A-weighted levels dropping from approximately 42 dBA down to 35 dBA through the evening and night. Distance, speaker aiming, and intervening terrain features could have been enough to limit sound levels from the speakers in this area.

During the actual sound test, staff received a total of 6 calls from residents from three households who reported hearing the sound test. Callers that reported hearing the test advised staff they were hearing both the low-frequency sounds and music and one caller felt the sound test should have been conducted on the weekend rather than a week night.

AEC offered many noise reduction measures specific to MRRP.

AEC recommended frequency limits set at an hourly average  $L_{eq}$  of 90dBA and 103 dBC using a referenced distance of 150 feet from the speakers during peak times and 79 dBA and 92 dBC at 150 feet during off peak times. All off-peak sound systems must be four-corner speaker setups; a measure which would confidently minimize the potential for low frequency bass sounds that could disturb the surrounding community. In addition, recommendations were made regarding direction of stages and sound systems, the use of sound barriers to avoid the spread of sound, as well as ongoing noise monitoring and a hotline phone number to facilitate communication with residents during the event with modifications and adjustments to decibel levels made as needed to ensure the sound remains within the permitted levels.

California Environmental Quality Act (CEQA) Guidelines include a number of project classes that the Secretary for Natural Resources has determined do not have a significant effect on the environment, and that are therefore, categorically exempt from the preparation of environmental documents (Guidelines, §15300 et seq.). "Class 23" guidelines include the normal operations of existing facilities for public gatherings for which the facilities were designed, where there is a past history of the facility being used for the same or similar kind of purpose.

For the purposes of this section, "past history" shall remain if the same or similar kind of activity has been occurring for at least three years and that there is a reasonable expectation that the future occurrence of the activity would not represent a change in the operation of the facility. Facilities included within this exemption include, but are not

limited to, racetracks, stadiums, convention centers, auditoriums, planetariums, swimming pools, and amusement parks (Guidelines, §15323).

The normal operations of MRRP include individual recreational activities such as camping and water sports, but it also includes large public events that occur throughout the year. The proposed Dirtybird Campout event is much like many of the other events that have occurred at the facility in the past. Looking at the documents of past events, the County's General Plan and supporting documents, and the County's Parks Master Plan, staff believe substantial evidence is present for the Board of Supervisors to determine the proposed event falls within the Category 23 exemption. The proposed event involves neither the presence of higher attendance, greater traffic, nor the generation of more noise at the facility than prior events. The proposed activity will occur in lightly populated agricultural area on property that is set aside specifically for recreational activities of this sort and the event will occur in an area of the facility which will not be adversely impacted by the activity.

The Department worked with County Counsel in reviewing this proposed event and has determined it to be categorically exempt from CEQA, pursuant to Guidelines section 15323: Normal Operations of Facilities for Public Gatherings, as the proposed event does not have the potential to have a significant effect on the environment.

Staff recommends that the Board approve the filing of Notice of Exemption (Attachment 3), with the Stanislaus County Clerk-Recorder's Office (pursuant to Public Resources Code Section 21152 and CEQA Guidelines section 15062), finding that the proposed event is exempt under the provisions of CEQA pursuant to State Guideline Section 15323- Normal Operations of Facilities for Public Gatherings.

The Department supports this exclusive use request and is now in the final stages of permitting this event, provided that Tailfeather Events, Inc., adheres to all the requirements set forth by the Department as outlined in the Temporary Exclusive Use Event Agreement/Permit.

The Department is requesting approval to negotiate future events with Tailfeather Events, Inc., event promoters if they continue to adhere to the conditions of their permit and the event does not significantly impact the park or surrounding community.

# **POLICY ISSUE:**

California Business and Professions Code section 16100 and the County's Police Powers under Article XI, Section 7 of the California Constitution, together authorize the Board of Supervisors to regulate outdoor entertainment activities within the County's jurisdiction. This specifically includes issuing permits and charging associated fees.

# **FISCAL IMPACT:**

If approved, approximately \$91,250 will be assessed for the event fees, exclusive use, and reservation fees. Additional revenue may be realized from park entrance fees if participants utilize developed camping areas and bring in vessels.

# **BOARD OF SUPERVISORS' PRIORITY:**

The recommended actions support the Board's priorities of *Developing a Healthy Economy* by partnering with event coordinators to encourage attendance at our regional parks. Marketing and advertising of the event will continue to lead to greater exposure and a stronger economic gain for parks.

# **STAFFING IMPACT:**

Existing department staff will oversee the coordination of this special event and the event promoters will reimburse the Department for actual staff costs and the cost of the noise engineer.

# I. Introduction to Dirtybird Campout at Modesto Reservoir Regional Park

The Department of Parks and Recreation of Stanislaus County has hosted several large outdoor events at the Woodward Reservoir Regional Park and is now looking to offer Modesto Reservoir Regional Park a similar camping and event space.

Modesto Reservoir Regional Park (MRRP) is located 7 miles East of Waterford on Hwy 132. MRRP offers over 2,800 acres of reservoir for recreation, and camping/ open space for outdoor recreation including full hook-up, developed and undeveloped campsites. Daily recreational opportunities include: Swimming, fishing, boating, kayaking, canoeing, picnicking, water and jet skiing, waterfowl hunting, and archery.

Tailfeather Events, Inc., ("TFE") owner and operator of "Dirtybird Campout" ("Event"), is an event production company requesting use of the South Shore of Modesto Reservoir Regional Park (MRRP) to host the 4th annual Dirtybird Campout- West Coast from Thursday October 4, 2018, through Monday, October 8, 2018.

Dirtybird Campout is an adult summer camp themed music event. The event began in 2015 with approximately 4100 attendees, and has grown to 7800 attendees in 2017. The event is seeking MRRP to be the host location that can better serve the attendees by providing traditional camp and recreation programming in line with the event programming such as field games, canoeing, kayaking, swimming, archery, fishing, arts and crafts and more, while also providing stages for music programming and variety shows such as talent shows, Bingo, magic shows, and comedy.

The event organizers will be on site starting Wednesday September 26, 2018 and remain on site through Friday October 12, 2018 to allow for set up of the event as well as to dismantle and clean up after the event. These dates could vary slightly due to other planned events and the final permit will reflect the actual date approved.

TFE has been promoting large one-day, multi-day, and touring festival events with the title Dirtybird BBQ and Dirtybird Campout for over 5 years. These events take place in the United States, and include Lake San Antonio in Bradley, California, Oak Canyon Park in Silverado, California, Treasure Island San Francisco, Shoreline Park In the Port of Oakland, Golden Gate Park in San Francisco, Circuit of the Americas in Austin, Texas, Belle Isle in Detroit Michigan, Governor's Island in New York City, NY, The Seattle Center, Seattle, WA, Sports Authority Field in Denver, Colorado, Smashed Canvas in Miami, Florida, the Oregon Museum of Science and Industry in Portland, Oregon, and The LA Coliseum Plaza in Los Angeles, California.

Dirtybird Campout and Tailfeather Events, Inc. aim to strengthen local economy through partnership with Stanislaus County Department of Parks and Recreation and by promoting recreation activity availability and awareness of the park. It is the goal of Tailfeather Events, Inc. to bring the Dirtybird Campout to this site for this year and many years to come.

# II. Security Plan

# **PURPOSE**

Creating a safe environment for all attendees and locals alike. We aim to accomplish this by having a solid line of communication between production, traffic, security, parks, and all local law/ fire / enforcement and EMS (Ambulance).

Nexus of communication between all facets of event production mentioned above with multichanneled two-way radios and repeaters as needed operating 24 hours from event open to close. Dirtybird Campout will supply radios with the programming of their channel to the Parks Department and the Sheriff's Department. The Dirtybird Campout Command Post is also directly tied to the communication network of the Stanislaus County Parks and Recreation Department, the California Highway Patrol.

# Personnel

<u>Executive Producers – Aundy and Barclay Crenshaw</u> Handle all invoices payable and all onsite cash-flow.

# Risk Management Representative - Jeff Kasky

Liaison between municipality, law enforcement, and mediator.

Director of Events Lisa Sunde, Main point of contact for all event related questions.

Production Manager, Lee "Brutus" Kalkofen, Responsible for all stages and content infrastructure.

# Operations Director - Kohn Dwight & Gemini Production Services

Coordinates site operations between permitting, parking, traffic, on-site operations, noise management and all local law enforcement/ fire/ EMS (Ambulance) to maintain all legal and safety perimeters. Oversees all power, water, fencing, equipment, and security lighting is installed and operational.

EMT and EMS trained personnel on call 24 hours from event open to close. EMT's also onsite for build and breakdown. Collaborates with all safety personnel. Will perform emergency action leadership. Will provide a detailed breakdown of medical and emergency response planning.

# <u>Security Director- Lonny Biegel - Combination of Security Teams (Over watch, High Rock or other similar)</u>

Monitors proper use of the site as well as enforcing boundaries of the event 24 hours per day. Will work in collaboration with all above teams to engage in conflict resolution and ensure a safe, enjoyable time for all parties involved. The teams are linked together through the Command Post and are all on call for emergency security matters. All major safety operations are directed by the center of communications, the Command Post. Additional security will be onsite during build and breakdown. Dirtybird Campout will provide Security stationed on water craft. Offering illumination and overseeing open water lifeguarding

# <u>Ticketing & Box Office Manager - Aundy Crenshaw & TBD</u>

Manager maintains a flow of incoming attendees and traffic along with overseeing staff. Staff will provide ticketing services including purchase, will call, and wrist banding during designated times.

Parking/Traffic Manager & Staff: Sam Pavlick with (PST) Staff: Platinum Parking Services
Parking & Traffic Manager is responsible for clearly marking roads, designated parking spots, and vehicle flow from entrance to camping areas. Manager will direct production vehicles to a separate entrance. Staff responsible for keeping all traffic cleared off of public roads at all times. Also provide portable toilets for public road access and parking lot areas for attendees use while they wait to enter the event. Dirtybird Campout will designate a towing company and a staging area for attendees vehicles to be towed to should the need arise to remove vehicles from areas where they are presenting a hazard.

Fire Prevention/Safety: Stanislaus Consolidated Fire + Our Safety Director + Fire Marshall Certified personnel with full safety equipment including nomex shirt and pants, helmet with nomex hood, gloves, goggles, safety boots, and fire shelter. The Stanislaus Consolidated Fire Protection District will station one Type 3 Fire Engine and staff a team made up of one Fire Captain, one Engineer, and one Firefighter at the site during peak burn times (10am-8pm) each day of the event. Contact the Fire District at (209) 869-7470, a minimum of 30 days prior to the event to schedule the request and pay all necessary fees for the personnel and equipment.

# <u>Sheriff</u>

"It is the mission of the Stanislaus County Sheriff's Office to provide a professional police presence. We will enforce law violations in a fair and impartial manner, while respecting the rights of persons to assemble and enjoy the event. We will provide a safe environment for the citizens and event participants."

The Sheriff will use the current substation at MRRP as their command post. The command post will staff a Sgt. 24/7 during the event. The Sgt. will man the radio and relay pertinent information to deputies on patrol. The Sheriff's department will also provide a phone number to the Dirtybird command post to contact the sheriffs in case radio communication experiences a break down.

# Lifeguards:

Dirtybird Campout will designate areas for swimming with buoys for distances from shore and Swimming hours posted. Lifeguards will provide oversight at designated swimming areas during posted swimming daylight hours. Security will instruct attendees to stay out of the water during non-swim times.

# Security on Watercraft

Tailfeather Events, Inc. will provide 1 Bayliner walk thru Bow or similar watercraft for Daytime Safety and Security Patrol on the water. At night the vessel will be positioned mooring side of ramp for rapid response. This boat will be operated by Licensed and Bonded security under the Direction of the Dirtybird Campout Director of Security.

Hours of security - Wed 1500 to Monday 0800 hours available for Daytime Patrolling. Positioned the vessels mooring side of ramp for rapid response.

Lifeguards for daytime and security positions that are roaming and patrolling shoreline will support water security.

Roaming Nighttime Security will monitoring shoreline.

Stationary or Moving: The vessel will be moving when on water. Only off water to refuel or to perform rescue operations.

Equipment / Function: All safety lighting equipped bow to stern. Starboard and Port side flood lamps for search, access ladder and flat running board off tail of vessel. Onboard personal floating device for capacity and extra rescuing. Safety rings and lifeguard bananas.

## **POLICY**

# Alcohol Policy and Minors: Beverage Caterer TBD

Dirtybird Campout is a 21+ event. All attendees will be asked to present ID at the time of entry. Every attendee will be asked to present valid ID. Anyone underage would be ejected from the site.

Beverage Caterer will be connected to the ABC license. For more on the Dirtybird Campout Alcohol Management Plan, please see Alcohol Policy on Page 7.

# Drug Policy

Drug use is strictly prohibited and is grounds for immediate ejection from the event. All cases of drug use found on the premises will be immediately reported to the Stanislaus County Sheriff's Department.

# No Glass Policy

Glass will not be allowed on event grounds. Security Staff will make preliminary search of vehicles upon entry. All glass will be confiscated or recycled in the waste management center.

## General Eviction or Arrest Policy

The Security Liaison will work with the Stanislaus County Sheriff's Department to establish protocol for addressing attendee evictions and arrests. Arrestees will be detained on site at the Security command center and turned over to the Stanislaus County Sheriff's Department officers as soon as possible.

# Public Campground Signage and Wayfinding

Compliance with posted signage stating "No vehicles trailers or tents beyond this point", as per County Ordinance 18.08.010 Designation of public campgrounds, shall be enforced at all times. Signs cannot be covered with decorations and are to remain readable Dirtybird Campout will provide wayfinding signage for our Attendees to all event staging areas, parking, security, medical, games, activities, and to each campground.

## **Event Boundaries**

The Security Liaison will work with the Stanislaus County Sheriff's Department to establish protocol for maintaining event boundaries on the water and event perimeter. Fencing will be provided in designated areas where environmental boundaries are not in place.

With the exception of designated boats approved for production and security purposes, boaters from the public access use on the West Shore will are not permitted to shore up nor disembark at the event site.

All production and security boats will be listed by owner and phone number, along with Department and use of boat for event purposes. All official boats will be Quagga mussel inspected

and will pay the daily fees for each boat in addition to the fees of the land use.

Event Boundaries will be delineated on the site map included in this operations plan.

#### **ALCOHOL MANAGEMENT GUIDELINES**

The Dirtybird Campout is now into its 4th year as an event the State of California, and it is essential that all measures pertaining to the sale and supply of liquor are undertaken. Below are the steps the event organizers and the licensed beverage caterer will be taking to ensure that State and County alcohol rules are adhered to and the event does everything within its power to mitigate any alcohol- related harm associated with the supply and sale of alcohol.

Management Strategies of Alcohol Sales

#### Communication

As a 21+ event, Dirtybird Campout will set expectations with its Attendees before the event to influence the attendee behavior at the event. Clear guidelines about alcohol at the event, with the focus of all advertising and notifications being centered around games, food, and music.

# Alcohol Management

The Core tools to the Alcohol Management Plan are:

- 1. Imposing Glass restrictions upon entry
- 2. Controlled sales of all alcohol sales
- 3. Promotion of low- alcohol options, non- alcoholic options, food and water
- 4. Controlling the number of serves per person
- 5. Restricting alcohol sales to the license bar only (no food vendors will be selling alcohol).
- 6. Restricting in and out of event and vehicular movement

## Supply Control

Experienced Licensees will control the alcohol sales at Dirtybird Campout. This will help reduce the risk of irresponsible alcohol service, and provide better communication between the events' planning partners during the event.

# Intoxication minimization

The following steps will be implemented:

- 1. Security and Bar staff will be equipped with both the ability and the impetus to monitor Attendees for intoxication.
- 2. Areas designated to the sale of liquor will have designated security to monitor people at point of sale.
- 3. Signage pertaining to on- premise will be required at all bars and alcohol sales booths
- 4. All venue alcohol management procedures will aim to prevent intoxication, prevent any intoxicated Attendees being allowed to be served.
- 5. All attendees driving away from the site will be monitored to ensure they are not leaving while intoxicated.

# Harm Minimization

Despite the best measures, people can still become intoxicated and may need assistance. The event will provide a safe area where they can be helped by trained and experience members of the medical and harm reduction professions.

Alcohol Sales will begin at 12:00 pm and run through 2:00 am.

Activities are planned throughout the entire event cycle from 8 am to 3 am in order to relieve Attendees from boredom, which is often a catalyst for excessive alcohol consumption.

Security will be placed on all entrances / exits to the event to prevent any Attendees from

exiting or entering the event while intoxicated.

Serving to intoxicated persons and minors will not be tolerated. Alcohol will not be served in glass jugs or glass handles (only official event vessels).

All bars selling alcohol will have their own liquor license specific to the Dirtybird Campout and Stanislaus County regulations. There is NO off license (alcohol is not to be taken off site).

# III. First Aid/Medical personnel & Operations

Emergency medical services (EMS) shall be supervised by the designated Medical Leader who will make appropriate contact with the Oak Valley District Ambulance as necessary. Tailfeather Events, Inc. will contract with the Oak Valley District Ambulance to have medical response in place.

The Dirtybird Campout Medical Leader and Safety Director will be designated by Rock Medicine, Gordon Oldham.

The following are some of the Medical Unit Leader's responsibilities. Coordinated by the Medical Unit Leader, a complete medical program will be in place, which includes:

- A. Onsite mobile hospital unit staffed by trained personnel equipped to handle basic first aid and minor injury.
- B. On-call ambulance contracted with Oak Valley District Ambulance to the closest appropriate hospital for emergency treatment. All patients transported from the scene will be transported in accordance with MVEMSA policies. If a contract is not obtained with Oak Valley Ambulance for an on scene unit, or if the Oak Valley Ambulance has transported a patient from the event and a second incident occurs, another ambulance provider may be dispatched to the scene depending on the resources available at any given time.
- C. On-call air ambulance. All air ambulances will be requested by calling 9-1-1. "The VRECC Dispatch Center is responsible for requesting air ambulance in compliance with Mountain-Valley EMS Agency policies.
- D. On-duty Advanced Life Support (ALS) and Basic Life Support (BLS) personnel will be located at the Camp Medical tent located in the main event area at the South Shore Boat Ramp of Modesto Reservoir. A secondary ranger station will be located at the Campground Plaza for first aid only.
- E. Continuous contact with local EMS agencies, Stanislaus County Sheriff and California Highway Patrol to coordinate emergency actions.
- F. Full report of any medical problems encountered is documented using the incident report.
- G. Individual hospitals do not need to be contacted regarding the event. Hospital contact, if necessary, will occur through the ambulance provider.
- H. Assist in other areas i.e. fire, evacuation and other safety concerns.

The Safety Director will provide the Emergency Response Plan that will coincide with this Operations Plan document.

#### IV. FIRE PREVENTION PLAN

# <u>Purpose</u>

This report is designed to outline the fire prevention and suppression for Music Festivals and large events held at Modesto Reservoir.

#### I. FIRE PREVENTION MEASURES

- 1. The event organized or his/ her designee shall apply for and obtain all applicable operational fire code permits as identified in the California Fire Code (e.g. temporary membrane structures and tents, and open burning).
- 2. One approved site campfire will be allowed to do marshmallows and monitored campfire activities around the summer camp theme. No other Campfires will be allowed on site. All pre-event advertising (website, Eventbrite ticket page, ticket holder information, social posts, posters, flyers, newspapers, magazines, etc.) will strongly communicate no fires are allowed. Programs handed to each attendee at the event will discuss all fire restrictions including "no campfires". If necessary, the stage microphone will be used to remind the audience that no fires are allowed. Orientation and trainings will also be given during the pre-event to educate all staff about fire safety. The Campfire shall not be conducted within 25 feet of a structure or combustible material. Conditions that could cause a fire to spread with 25 feet of a structure shall be eliminated prior to ignition. The proposed campfire shall be constantly attended until the fire is extinguished. A minimum of one portable fire extinguisher complying with the California Fire Code with a minimum of a 4-A rating or other approved on-site fire- extinguishing equipment, such as dirt, sand, water barrel, or water truck shall be available for immediate utilization.
- 3. One water truck will be utilized for dust suppression. Continuous watering of event site in unirrigated areas away from shoreline, weather permitting. A water truck using clean water, will be used before and during the event to dampen the roads, parking areas, and wherever deemed useful and will be available for any emergency.
- 4. Modesto Reservoir Regional Park will be responsible for mowing developed areas prior to event. This area includes: Marina Day use, picnic shelter lawn, Group Camping behind the substations, Loops A- D, the RC area. Tailfeather / Dirtybird will be responsible for mowing the undeveloped campsites south and east of Lot A, and Mr. Byrd's leased area for camping.
- 5. Concessions to Minimize Vehicle Movement. The event will not allow in-out access to general attendees. Exception will be granted for emergency situations and will be determined by security personnel at the Front Gate Entrance.
- 6. Communications. Open communication will be maintained with all local agencies to ensure all preventative measures are taken. Event staff and Event Security and Medical teams will be ready to consult with the Stanislaus Consolidated Fire Protection District, Stanislaus County Sheriff's Department, CalFire, California Highway Patrol, Oak Valley Ambulance, and Stanislaus Parks and Recreation Agency concerning security, fire, and traffic control. Event will maintain a minimum of 30 (number determined by staff leads and number of security and medical personnel) wireless radios communications (walkie-talkies) will be in full-time

- operation to ensure instant communication. Wireless Radios will be distributed to each lead staff member, and fresh batteries will be available at various staff charging stations throughout the event grounds. Communications regarding fire prevention must be a primary concern of the event management team. It has been and will continue to be our policy obtain the assistance and guidance of safety specialists to assure a comprehensive fire prevention plan.
- 7. County Fire Personnel. The Stanislaus Consolidated Fire Protection District will station one Type 3 Fire Engine and staff a team made up of one Fire Captain, one Engineer, and one Firefighter at the site during peak burn times (10am- 8pm) each day of the event. Contact the Fire District at (209) 869- 7470, a minimum of 30 days prior to the event to schedule the request and pay all necessary fees for the personnel and equipment.
- 8. Trained and Instructed Staff. The operational personnel of the event are given specific instruction in the maintenance of fire prevention measures.
- 9. The Event will provide fire extinguishers to be placed at the following locations: Each UTV (production and operation vehicles) every stage, every food vendor and food booth, every generator, all large scale (over 400 sf) program structures, production offices, fueling areas, and other areas as appropriate.
- 10. Fire Prevention Team. Firefighter #1 certified personnel will be on hand during the event and will report directly to the Fire Captain of Stanislaus Consolidated Fire Protection District upon their arrival. In addition, a water truck and our own extinguishing equipment will be accessible throughout set-up, event hours, and take- down phases of the event.

# EVENT STAFF RESPONSIBILITIES WHEN A FIRE OCCURS WITHIN THE PROJECT AREA OR VICINITY.

# A. Dispatcher

- When dispatcher is notified, he or she will immediately notify on-call Fire personnel on the event radio FIRE emergency dispatch channel. FIRE will have its one dedicated channel.
- 2. Immediately notify Stanislaus Consolidated Fire Protection District and Stanislaus County Sheriff's Department on dedicated line and/or radio channel.
- 3. Remain on duty to handle messages and initiate action upon requests until relieved or released by the Stanislaus Consolidated or CALFIRE Fire agencies.

# B. Firefighter Personnel

- 1. Upon notification will work in tandem with onsite Stanislaus Consolidated Fire Protection District and CALFIRE staff to address the incident.
- 2. If Stanislaus Consolidated Fire Protection District personnel are not onsite, Firefighter Personnel will immediately gather Event Safety & Operations Directors and crew, tools, and equipment and head to the incident location.
- 3. Will serve as main eyes and ears for Stanislaus Consolidated Fire Protection District and Command Post until relieved or replaced by the Stanislaus Consolidated Fire agencies.
- Will maintain contact with Command Post, Medical Leader, and Fire agencies, and Dirtybird Campout Safety Director as needed to monitor and address fire incident.

# C. <u>Trained and Instructed Staff Members</u>

1. Will be instructed by Dirtybird Campout Safety and Operations Director to report in to the Event Production Command Center to provide assistance as needed.

#### **GENERAL PROVISIONS**

# Fire Prevention

# **Burning:**

Absolutely no personal campfires allowed. Permit needed for any "ceremonial fires" or any art installations that include fire.

# **Spark Arrestors:**

Spark arrestors required for all diesel and gasoline engines (including generators), power saws, and other equipment on site with the exception of those used on concrete flooring.

# Smoking:

Continual instruction will be given to staff and attendees regarding the safe disposal of cigarette butts.

# Power Saws and Generators:

Spark arrestors that meet F.S. standards are required on all power saws and generators. An 8 oz. fluid fire extinguisher and size 0 round pointed shovel will be carried with each Power saw and be present at each generator while in operation. Gas and oil will be carried only in metal safety cans. All generators will have spill containments around fueling Containers.

# **Ground Preparation:**

Watering of areas including day parking areas and other areas of potential hazard. Water trucks will be used continuously to minimize fire danger and dampen roadways. Only clean water will be used for these purposes.

#### Communication:

Continual communication will be maintained with all event attendees to assure their awareness of all fire and safety regulations. An onsite communications system will be maintained to ensure proper and immediate response to fire danger and will consist of stage PA announcements, Games Headquarters PA Announcements, and Campground Management announcements.

# Fire Suppression

It is understood and agreed that the contractor will do all in his power to prevent and suppress fires on or adjacent to the project area as stipulated. In line with this agreement, personnel will be supplied from project crews to fight fires on the project area up to the total number of men and women employed by the contractor, as they are needed by the fire team lead. All Fires that occur within the event area shall be investigated by the Stanislaus Consolidated Fire Protection District and/or the Stanislaus County FIU. Fires that occur within the State Responsibility area will be investigated by CALFIRE personnel. All vegetation fires that occur within the event area shall be contained and controlled with the appropriate control lines around the fire perimeter.

#### **Duration of Plan**

This fire plan will apply to any and all subcontractors and their employees employed by the contractor, and the contractor will be responsible for making sure that all such subcontractors and their employees are made aware of the contents of this fire plan. This plan will be in force for the duration of the Event. Additional professional firefighting personnel will be on call throughout the Event.

## **Traffic Overview**

Attendees will begin to arrive to the Modesto Reservoir Regional Park beginning Thursday October 4th at 2pm. Peak ingress times are Thursday October 4, 2018 2:00 pm through Friday October 5, 2018 at 11:00 pm. Peak egress times will be Monday October 8, 2018 8:00 am through 12:00 pm.

Traffic attendants will be on-duty and a traffic attendant layout plant will be implemented at ALL times to monitor and control Event traffic along Reservoir Road and Highway 132. Traffic attendants and security personnel will prevent attendees from attempting to enter the Event via alternate routes, private property surrounding site including cattle ranch and orchard lands, or by private vessels, other than the park main entrance. Traffic attendants and security personnel will be stationed to ensure there is no parking on private property along the roads including 1 mile East of Reservoir Road to 1 mile West of Reservoir Road on Highway 132.

Attendees that arrive before or after listed gate hours will be offered the option of camping in the developed area of Modesto Reservoir's West Shore for a per night fee. Alternatively, Attendees may choose depart the site and return when the Gate and Security Checkpoint box office reopens during regular Gate hours.

In order to minimize vehicle movement during the event, no ins and outs are allowed for general attendees. Attendees with special circumstances will be made the exception, and will be given a specific credential allocated by the Security Lead on duty at the time of exit.

## **Routes to Modesto Reservoir**

# Attendees

On the event website, general attendees will be directed to take Highway 132 to Reservoir Road, (7) miles east of Waterford, in order to arrive at the main Event entrance. Flaggers will instruct all event traffic to turn north onto Reservoir Road at the junction of Reservoir Road and Highway 132.

Attendees headed westbound on Highway 132 will be instructed to turn "Right" and head north onto Reservoir Road in the direction of the South Shore Boat Ramp.

All attendees will be directed to the Front Gate Entrance and Box Office at the park entrance on Reservoir Road. See Front Gate Protocol for more detail (Page 24).

# Emergency & County

Emergency vehicles may enter via Reservoir Road during off- peak Event ingress hours (prior to Thursday at 2pm, and then again Saturday 3:00 pm through Monday 6:00 am) OR if the Emergency requires entrance through the Reservoir Road gate to expedite a quicker response.

Emergency vehicles may also access the West Shore and any location of the event site through Reservoir Road for a quicker response when it is appropriate.

Emergency vehicles are instructed to enter on Dienstag Road during peak ingress and egress hours (Thursday 2pm- Midnight, Friday 8am- Midnight, Saturday 8am- 2pm) to bypass heavy event traffic. Emergency vehicles will turn north on Dienstag Road to enter the park grounds through the EMS gate located along the private road that connects with Reservoir Road. Security and Traffic Flagger personnel will be stationed at Dienstag throughout the event. Personnel at the gate will have access to opening and closing this gate to provide access to any ambulance, especially during peak ingress and egress times.

## Staff & Production

During off-peak ingress and egress Front Gate hours, Production vehicles will enter via the main park entrance off Highway 132 to Reservoir Road. All production vehicles will be instructed to access the Event grounds via Reservoir Road during the pre-event period.

Production staff will be required to go through Gate Box Office Entrance during peak gate hours. There will be Production lanes for staff entrance during these hours.

### Stanislaus County Staff and Local Neighbors

County staff and boundary sharing neighbors who access their properties and offices regularly at MRRP will be provided a pass that will allow them direct access to the West Shore or to their neighboring properties through our toll booth with limited security searching. Security will be informed of these type of passes and communicate priority access.

## **Traffic Teams**

There will be a variety of personnel and crews working to maintain traffic safety during ingress and egress. Crews will be positioned on Highway 132, Reservoir Road, the Modesto Reservoir Regional Park Entrance, Security Checkpoint, West Shore Parking lot, and South Shore Credential Checkpoint. All points are listed on the traffic layout map (Page 21). Teams include Dirtybird Campout Traffic Director and Security director California Highway Patrol, Event Traffic Flaggers, Event Security, Ticket Scanners, and Front Gate/ Box Office manager and staff. All personnel will be trained to direct and manage traffic flow. A map of flagger positions is provided.

Dirtybird Campout will coordinate with Parks staff and CHP on the placement of electronic sign a week prior to the event that will state "Special Event 10/04/18 -10/08/18- Use Alt Route" in place at recommended (1) week prior to event placed Eastbound on Highway 132 at Waterford near Yosemite Blvd and F Street.

California Highway Patrol Command Post will consist of Two Officers and one Sergeant and will be active October 4th, 5th, and 8th during Front Gate peak ingress and egress hours. The Command Post location is on the Highway 132 and Reservoir Road intersection.

Traffic Flaggers will be in position to ensure vehicles safely on Highway 132 and on the road from Reservoir Road through the Front Gate. Flaggers will restrict parking access in undesignated areas, ensure safety and compliance with park regulations, and facilitate non-Event traffic. Three or more flaggers will be on duty during peak traffic times to ensure that right-of- way for non- Event traffic is maintained along Highway 132, Reservoir Road entering and exiting Modesto Reservoir Regional Park.







# **INGRESS DESIGN**

## # 1 EMS ENTRANCE:

Emergency vehicles will be routed into the event via the EMS Gate along Dienstag Road and will utilize this as the event and campground Entrance and Exit Route for the duration of the event.

Emergency vehicles responding to emergency activities on the West Shore will access the West Shore via the MRRP Reservoir Road Front Gate entrance.

# #2 LOCAL AND NEIGHBORHOOD TRAFFIC

All border sharing neighbors of MRRP who require access to Reservoir Road and properties adjacent to MRRP, will receive a neighborhood packet prior to the event. This packet will contain event information, event passes, and a priority parking permit hang tag. This vehicle hang tag credential will grant all holders priority access to Reservoir Road, through traffic controls and the Event Gate and Security Checkpoint entrance.

Neighborhood Packets will be available for pick up at a Neighborhood meeting located onsite at the Dirtybird Campout Production office, or at a local designated area. A letter will be submitted to all neighbors regarding this packet pick up information. Neighbors will be invited to pick up their packets Wednesday October 3, 2018 from 3 pm- 8 pm. If a neighbor does not pick up a packet during designated hours, our staff will offer a drop off as well as list the neighbor on the guest list for the event.

# #3 PRODUCTION ENTRANCE:

During off-peak ingress and egress Event Gate hours, Production vehicles will enter via the main park entrance off Highway 132 to Reservoir Road. All production vehicles will be instructed to access the Event grounds via Reservoir Road during the pre-event period.

During peak ingress Event Gate hours, production staff will be required to go through the Event Gate Entrance protocols upon entry during peak gate hours. A traffic attendant will be stationed at the junction of Dienstag Road and Reservoir Road at all times to monitor vehicle and check staff credentials.

#### #4 MRRP Front Entrance

The MRRP entrance will be used by Dirtybird Campout to filter event attendees and the public accessing the West Shore of MRRP. When a non- attendee vehicle approaches the MRRP Entrance, they will be guided directly to the MRRP Toll booth to pay the day or overnight camping use fee for the West Shore. The event traffic teams will then guide those vehicles to the Reservoir Road intersection just north of the Front Entrance and instruct them to turn onto the West Shore for their campgrounds. Traffic Signage will support this information for the public.

MID and residents living on Reservoir Road will be given vehicle passes that will allow for a switch pass through this first Front Entrance, and then again through the Event toll booth on Reservoir Road and Jaquay Way.

## #5 RESERVOIR ROAD INTERSECTION

Once vehicles are identified as Public campers or Event Attendees, at the MRRP Front Entrance, all vehicles will approach the Reservoir Road Intersection where 2 flaggers are stationed to review vehicle passes and determine access. ALL vehicles with proper WEST SHORE credentials including MID and MRRP employees and the residents who live on reservoir road will be guided to continue West on Reservoir Road.

If a vehicle is identified as an Attendee, the will be directed to turn east to the South Shore Ramp and Dirtybird Campout Gate.

If a vehicle does not have proper credentials, vehicles will be turned around and required to return to the Park Front Entrance to purchase a day use pass.

Once Attendee vehicles clear the Reservoir Road Intersection Flagger checkpoint, they will continue to the Dirtybird campout Gate east of Jaquay Way for credentials security check and processing

# #6 DIRTYBIRD CAMPOUT GATE & SECURITY CHECKPOINT

The entrance to Dirtybird Campout Event is located on Reservoir Road East of MIDD at the South Shore of Modesto Reservoir Regional Park. We will be setting in place a Gate to serve as our entrance for processing Attendees just East of Jaquay Way on Reservoir Road. Multiple Lanes will be designated for specific use. Flaggers will be stationed to direct traffic (see flagger map). Signage will be available and flaggers will provide instruction for admission lanes.

All Attendees will be directed to Reservoir Road off of Yosemite Blvd Highway 132 by Traffic Attendants with bright orange flags (Flaggers), traffic safety vests, and traffic specification road signage. Event Attendees will head north on Reservoir Road to the Dirtybird Campout. Each vehicle will go through one of the multiple lanes at the security checkpoint. Event passes will be scanned and attendees will be remain in vehicles for wrist banding. Vehicles will be searched for prohibited items and stowaways.

The security checkpoint will be in place at the Event Gate to ensure attendee safety and compliance with park and permit regulations such as no glass, no fireworks, and no weapons, no animals, no fuel cans, and other prohibited items determined by Dirtybird Campout. A "Do's and Don'ts" digital poster will be delivered to all ticket holders with Security Checkpoint information about is allowed inside the Event. A list of prohibited items will be provided to all ticket holders via email, as well as posted on social channels and event program and field guides.

Every rider in every vehicle must have a 3 day Event Pass. All Dirtybird Campout campers

must purchase 3 day Event passes. Tickets are sold online at Dirtybirdcampout.com and can be purchased prior to arriving to Dirtybird Campout. As this event is anticipated to sell out online prior to opening day, any attendees who arrive without proper tickets for scanning will be allowed to camp on the West Shore of MRRP for the regular day and overnight use fees. They can pay these fees to the MRRP toll booth at the Reservoir Road Front Gate Entrance.

In the case that the event is not sold out, attendees will be allowed to purchase a 3- day Event pass. Event pass purchasing can be made in any lane with the Dirtybird Campout ticket partner Eventbrite using the Eventbrite ticketing scanners.

Ticketing questions will be directed to pull over to LANE 1 to the far south of the Gate checkpoint. They will be directed to park temporarily in a designated parking lane and speak to the Box Office manager. Once a ticket is purchased, they will then return to their vehicle and proceed to the Gate / Security Check.

If event is sold out, anyone arriving without a ticket will have the option to pay for day use or overnight camping on the West Shore of Modesto Reservoir Regional Park OR they will be required to leave the front gate in the vehicle they came in even if all other passengers and vehicles have proper credentials.

Vehicle camping passes may be purchased online prior to event opening and are only available while supplies last.

Vehicle Pass holders who have pre-purchased vehicle, RV, or GROUP passes will receive vehicle color coded sticker credentials that will be placed on the upper left or driver's side corner of their windshield for security and Flagger viewing.

Once attendees are wrist-banded and have passed security check, staff will hand out Dirtybird Campout FIELD GUIDES and direct them to follow flaggers and signage to the camping areas. Field Guides will also be delivered in a digital file to all ticket holders prior to the event, along with their tickets.

All vehicles will receive vehicle credentials indicating General Parking (no camping), or Vehicle Camping. Various options: General Camping, ADA Camping, RV hook up Camping, RV No Hook up Camping, Group Camping, Wise Owl (boutique) Camping, Artist Camping, Production Camping and others camping zones to be determined. All Camping areas will be named in theme in an A- Z formation from west to east and will be placed on the Field Guide map.

All single rider vehicles will be charged a fee/ fine of \$40 for carbon imprint, regardless if they have purchased a vehicle camping pass.

All General Public wishing to access the park during gate hours will be required to enter through the Public Access Lane at the MRRP toll booth. Public campers will receive a West Shore access Public vehicle pass which will grant them access to the west shore of the park only. Public attendants will not be allowed to access the south shore of the park with the public camping or day use pass. Public attendants will not be permitted to dock on the South Shore areas during the event days.

Traffic attendants and flaggers will be positioned to direct vehicles to car and RV camping and

general camping spots in the camping grounds where they will be parked for the entire duration of their stay at the event.

ALL attendees in vehicles must show wristbands and vehicle credentials at this and all Flagger stations.

# #7 GENERAL PARKING (NO CAMPING)

There will be an area on the West Shore assigned for General Parking. No camping will be allowed in this parking area. Shuttles will be provided to campers to access the Festival camping grounds. This General Parking area will have a fee per vehicle. All vehicles must display vehicle credentials at all times. All vehicles will camp on the Dirtybird Campout event camping grounds.

# GENERAL PARKING OVERFLOW OPTION

In the event traffic slows to 10 MPH and backs up on Highway 132 to (3) miles west to Waterford, or half a mile east of Skyline Blvd during peak ingress hours, an overflow route to the general Camping will be activated for use. Dirtybird Campout will divert traffic to the designated overflow lot near the Front Gate Entrance in the open space south of the MRRP Park offices.

This overflow area will not impede public traffic use of the MRRP West Shore or any neighbors who will have priority access to private driveways.

# #8 OVERNIGHT SECURITY STATION/ CLOSED GATE HOURS:

When the FRONT GATE is closed, an overnight post will be created at Reservoir Road and Highway 132 where Security personnel will inform campers they have the option to camp overnight on the MRRP West Shore camping grounds with no event access for an additional fee, or to turn around and return the nearest hotel or public overnight camping park or other public camping location where they MUST remain overnight until the Front Gate reopens.

Front Gate hours will be sent to all ticket holders, posted online on the Dirtybird Campout website and social channels, and posted at the Overnight security station. Portolets (2 minimum) will be placed at Highway 132 and Reservoir Road. Security will be stationed at Reservoir Road to

re-direct approaching campers.

## #9 TEMPORARY/ OVERNIGHT PARKING TBD


In partnership with the MRRP, Dirtybird Campout overnight gate security will direct attendees to camp on the West Shore campgrounds for a fee. The Modesto Reservoir Regional Park the overnight fee is \$30

# # 10 PEDESTRIAN WALKWAY:

A safe walkway will be created along the Reservoir Road leading pedestrians with safety fencing. Traffic Attendants and signage will be stationed along Reservoir Road along the Shoreline to direct pedestrians to stay on designated walking path.

Traffic attendants will monitor Event traffic along Yosemite Blvd. Highway 132 on regular shifts and prevent attendees from attempting to enter the Event via the private property orchard, the Modesto water irrigation district, cattle ranch areas, agricultural areas, and/or parking and walking onto any private property along the road. During the event Reservoir Road will be limited to 5 mph.

#### **EGRESS Overview**

Event security will ensure that all attendees have vacated the site by 12:00 pm on Monday October 8, 2018, the last day of the approved South Shore permit. Traffic attendants will be stationed to direct traffic out of the venue in one lane through Reservoir Road and onto Highway 132. If there is a backup on site in the campground, we will communicate to campers to stand by as we work to safely move traffic onto Highway 132.

#### WASTE MANAGEMENT on EGRESS

Attendees leaving the site will pass through the Waste Management area on the exit route located at the MRRP RV waste station where they will be permitted to dispose of recycling and waste capture. The event will work with Turlock Scavenger to provide designated dumpsters for landfill, recycling, compost, and other sorting areas to ensure no trash is left on the surrounding roads & Highways. Dirtybird Campout Waste Management Vendor Services will provide staff, signage, and information about drop off.

#### Ticket Holder Information - Sent to all attendees

Dirtybird Campout West Coast is an adult camping and music festival held October 4th- 8th, 2018.

The General Admission and Wise Owl Campgrounds open for Early Arrival on Thursday October 4th, 2018. Early Arrival passes must be purchased to arrive on this date. Gate opening time (TBD).

The Dirtybird Campout Games Headquarters (Games HQ) located in the festival grounds will open on Thursday afternoon for Early Arrival. Music stages will open Friday October 5, 2018 at 12:00 pm.

All Campgrounds close at 12:00 pm on Monday October 8th, 2018.

#### Location:

Dirtybird Campout West is now located at Modesto Reservoir Campground, a beautiful regional park in Stanislaus County, California. Located just (7) miles east of the town of Waterford off Hwy 132, our new home has over 2,800 acres of reservoir to host our summercamp style playground and music event.

#### **Ticketing FAQs:**

- 21+ Event. All attendees must bring a valid government-issued ID to pick up their wristbands and enter the festival.
- Every attendee and all vehicles must have proper credentials to be anywhere on site at Dirtybird Campout.
- Event is rain or shine.
- · All sales final. No refunds or exchanges.
- · Artists and activities schedule is subject to change.

Do I need to purchase a pass for my vehicle or RV? Yes, ALL vehicles entering Dirtybird Campout (except bicycles and motorcycles) must purchase a Vehicle Pass in addition to their festival ticket. Vehicle Passes will allow you to camp with your vehicle inside the campgrounds. RV's and vehicles with trailers will need to purchase an RV Pass instead of a Vehicle Pass. There are no additional parking options available inside or around the venue!

What's a VIB Pass? The VIB Pass includes everything in the 3-Day Pass, plus access to backstage lounge, private restroom and bar, and one Campout BBQ ticket!

What's an Early Arrival Pass? Early Arrival Passes allow you to come into the Campout a day early and we will have music programming on Thursday evening (stay tuned for lineup!), starting at 2pm on Thursday, October 4th, Early Arrival Pass holders will be able to enter the campgrounds and set up their campsite and get settled. You still need a Festival Pass or VIB Pass in addition to the Early Arrival Pass. Main festival programming still starts on Friday at 12pm.

What is a Group Camping Pass? The Group Camping Pass allows you to camp with your friends in a prime shoreline location up to 8 people. This campaign pass includes 2 vehicle passes. The spot is 24' x 48' and can usually hold 4 tents + 2 vehicles.

Are there payment plans for tickets? Yes! Tickets can be purchased with a small deposit and monthly payments through Affirm, our payment plan partner. To select a payment plan, simply click on the payment method option in the checkout process and select "Monthly payments with Affirm".

What is the refund policy? All sales are final. There are no refunds or exchanges.

Is my ticket transferable? There are no refunds on tickets, but you can transfer them if you are unable to attend. Please review Eventbrite's How to Update Your Ticket Information Tutorial HERE for details on how to do this.

Do I have to bring my printed ticket to the event? Yes, you will need to bring your printed ticket to the Front Gate Entrance at the Security Checkpoint entrance to receive your festival wristband. No one will be allowed entry without a proper festival wristband on.

The name on the registration/ticket doesn't match the attendee. Is that okay? If the name on the ticket does not match the name of the attendee, that is okay. Be careful to make sure that you don't lose your ticket or have it stolen from you because if it is used before you arrive, you will have to purchase another one.

Are there day passes? No. Currently there are only full weekend passes available for this event.

Where can I contact the organizer with any questions? Please email events@dirtybirdcampout.com and we'll assist you with any questions you may have.

Logistics & Venue FAQ

When can I come into the Campout / what are the event gate hours? You may only enter the festival during the event Front gate / box office hours. You are free to leave at any time, but you may not go in and out. Wristband pickup and festival admittance to the event will not be permitted outside of gate hours! The Front Gate & box office hours will be posted closer to the event.

Is there parking available onsite? There will be limited vehicle passes to park and camp with your vehicles inside the campgrounds with the purchase of a Vehicle or RV Pass. If you do not purchase a Vehicle or RV Pass, there are no additional parking lots inside or around the new venue.

You do not need to purchase a Vehicle Pass for each person riding in the vehicle, but everyone (including the driver) does need to have a 3-Day Pass or VIB Pass to come in with the vehicle. Bicycles and motorcycles are excluded.

Are there ins and outs at the festival? You may leave the festival at any time, but there are no ins and outs. It's dangerous to drive your car around the festival grounds so we are prohibiting ins and outs this year. Check the website for gate hours.

I'm coming from out of town. What airport do I fly to? The closest airport to Modesto Reservoir Campgrounds is Oakland International Airport, about 1.5 hours away from the venue. San Jose International Airport and Sacramento are about 2 hours away, San Francisco International Airport is 3 hours away, and Los Angeles International Airport is about 4.5 hours away.

You can hitch a ride to Dirtybird Campout on the Camp Bus from Oakland and Los Angeles airports! Tickets will be available to purchase during the General on sale.

What are my transportation options getting to the event if I don't have a car? There will be Camp Bus tickets available for purchase at the general on sale offering round-trip transportation from Oakland and Los Angeles to the event.

Can I bring an RV? Is there any additional cost? Yes, you can bring an RV to the Campout with the purchase of an RV Pass (available as a separate item on the ticket page). Any vehicle larger than a van or towing a trailer will need to purchase an RV Pass. Your RV can not be larger than total length 45' for an RV Towing a vehicle, 65' for total trailer length. There are three options of RV Passes for purchase:

1) RV Pass with Non-Hookups, 2) RV Pass with Electric, Water & Sewer and 3) RV Pass with Electric & Water. Please keep your entire footprint in mind when purchasing your RV pass. For example, if your car is towing your trailer, the length of your car must be included. One RV Camping Pass is good for one RV. You do not need to purchase a RV Camping Pass for each person camping in the RV, but everyone (including the driver) does need to have a 3-Day Pass or VIB Pass to come in with the RV.

What pass does my vehicle need?

- Van or Camper-Van = Vehicle
- Minibus or bigger = RV
- Car with Trailer = RV
- 5th Wheel = RV

Please note the state limits of length for RVs. Motor home length maximum by the state of California is 45', and 65' for a motorhome towing with a trailer.

Can my friends with Vehicle Passes camp next to me in my RV Campsite? There will be two distinct areas for Car Camping and RVs. At this new location, we are not able to mix car camping and RV Hookups and RV Non-Hookups – even if you arrive together.

Can I camp with my car? Yes! Everyone that brings a vehicle and purchases a vehicle pass will be able to camp next to their vehicle. There will be no additional parking lots in or around the venue. For this reason, ALL attendees with vehicles entering Dirtybird Campout (except bicycles and motorcycles) must purchase a Vehicle or RV Pass in addition to their festival ticket.

## **General Festival FAQ**

What kind of activities will there be? Dirtybird Campout is a full summer camp experience. In addition to great music and dancing, there will be extensive daytime and nighttime summer camp programming! Stay tuned for the Games & Activities announcement for a full list of activities.

Where can I take a shower? We will have showers available throughout the campgrounds for \$7 each. Don't forget your towel, soap and shower shoes! There is no bathing in the reservoir – even if you have biodegradable soap.

Where can I brush my teeth? You can brush your teeth anywhere you want, except in the

RESERVOIR! But we recommend doing it in your campsite and rinsing with a cup of water. You should brush at least twice a day and spit in a container or disposable bottle you can throw away, not on the ground!

Can I bring my own stove? Due to the high fire risk, all open flame, charcoal grills and propane stoves are not allowed at Dirtybird Campout. Passes for optional BBQ Feasts on Saturday and Sunday are available for purchase on the ticket page. There will also be several delicious food vendors to enjoy. There will be electric plugins available in Group Camping and in RV hookups for electric appliances. Thanks for your cooperation and understanding!

I'm not a very experienced camper... are there any camping packages available? Dirtybird Campout offers pre-set up boutique camping packages for those who want to come enjoy the campout experience and prefer the efficiency and ease of a pre-set camp option. Our boutique camping is called "Wise Owl Camp" and info can be found in the ticket descriptions. Get wise and let us handle all the dirty work and just sit back and enjoy your stay!

I want to get the right supplies for the weekend. What do you recommend bringing? Depending on how you roll, camping can be simple and basic or it can be a timeless luxury experience. We recommend the following basics: tent, shade for tent, sleeping bags and blankets, camp chairs, lanterns, folding tables, trash bags, snacks and drinks, sunblock, bug spray, lip balm, good, closed-toed walking shoes, fun lights for camp at night time, flags and other identifiable objects so you can find your camp, and anything else fun you can think of. We want there to be plenty of space for everyone, so please be mindful of your footprint.

What will I be able to purchase on site? There will be plenty of food vendors on-site to feed you throughout the weekend as well as several bars serving beer, wine and cocktails. Ice will be available to keep your drinks chilled and your food fresh.

There will also be a Camp Merch Booth selling special edition Campout Merchandise in limited quantities. We will also have a general store for batteries, ear plugs, camp lights and other camping basics. Please be advised, some vendors are cash only so please come prepared! ATMs will be available on site.

What can/can't I bring to the event? You cannot bring weapons, generators, fuel cans, sound systems, charcoal or propane stoves / lanterns, animals/pets, fireworks, glass, and kegs or large quantities of alcohol into the event.

You can bring blankets, backpacks, toys and games to play with, lots of friends and good attitudes. Stay tuned for more information on your camper packing list and field guides!

If I trip and fall while playing an intense game of frisbee. Do you have a Medical Tent? Yes, we will have medics available on site. There will be a medical and harm reduction tent in a central location at the festival. Check the festival map that will be published closer to the event for exact locations.

If you have any issues or see someone with an issue, please don't hesitate to call on our medic staff for support. They are here to help you and happy to do it.

What if it rains? Dirtybird Campout is a rain or shine event, no refunds. The music, games and fun will go on! If the weather reports predict rain or if you want to be extra cautious, we recommend coming prepared with extra shoes, trash bags, raincoats, tarps, and extra stakes to secure your tent. A little mud never hurt nobody!

Will there be work-exchange at this year's Campout? Counselor in Training applications will be available soon. To get updates, sign up for our newsletter at Dirtybirdcampout.com/west.

Where do we throw away our trash at the end of the event? We encourage all campers to pack out their own trash from the festival. That means leaving no trash behind and taking it all with you to dispose of in a proper receptacle off-site. We recommend bringing lots of trash bags and leaving extra room in your vehicle to haul your trash away when you leave.

However, we will offer waste drop zones where you can responsibly dispose of your trash onsite. Sorted waste can be dropped off at collection stations free of charge, while unsorted waste

will incur a fee per bag. More info will be available soon. Let's keep it beautiful, Campers!

Will there be a BBQ? Yes! We will be grilling up some delicious meat and veggies. Our Campout BBQ will be sure to wow your taste buds! Specifics are in the ticket descriptions. You will be asked whether you want meat or vegetarian in the checkout process.

Will there be merch available? Yes! We will have some special items available for pre-order when you buy your ticket, as well as exclusive Dirtybird Campout clothing and merchandise at the Dirtybird Campout General Store.

#### **Emergency Response Plan**

## **Objectives**

- A. Identify the duties of onsite personnel, organize, and implement a thorough emergency response plan in collaboration with all appropriate agencies.
- B. Establish clear protocol for quick and effective mobilization, dispersion of casualties, mutual aid dispatching, communication, and accurate situation evaluation.
- C. Differentiate levels of emergency and priority of patients to communicate the situation.
- D. If an event, beyond the scope of normal operating procedure, were to occur, incident management, including patient distribution, will occur in compliance with the OES Region IV MCI plan.

## III. <u>Incident Command Personnel</u>

During an emergency response situation, initial onsite responsibilities will be allocated to the following key personnel (in order of point responsibility):

Incident Commander Local Agency Response Personnel Safety Manager Risk Manager Communications Officer Director of Events

## IV. <u>Incident Command System (ICS)</u>

The ICS system will be used to determine responsibilities and roles for coordinating the overall response. Each service responding will have its own system for organizing its efforts to meet its responsibilities or assigned duties. It will be our policy to assist the appropriate authority under the direction of our Emergency Response Plan.

#### **Incident Command**

Agency/Personnel or Agencies responsible for overall management of an incident site.

## Incident Commander

Individual, or agency, responsible for ensuring inter-incident coordination for command operations, planning and logistical matters. This position is normally assigned to the investigative agency. In the event that the investigative agency is not yet onsite, the most qualified personnel at the site at time of the incident will assume incident command until relieved by a more qualified agency representative or reassigned as necessary.

## **Command Post**

Initial command post will be the pre-designated location assigned by the event administration. The incident commander may relocate at his/her discretion. The Command Post will be located at the main production office at the Command Center. The Incident Commander, local agency response personnel, Personnel Safety Manager, Risk Manager, Communications Officer, Director of Events, and all Dirtybird Campout Area lead(s), shall report to the command post. Unified Command principles shall be utilized when controlling incidents with outside resources; Stanislaus Consolidated Fire Protection District, CALFIRE, Stanislaus County Sheriff, California Highway Patrol, Stanislaus County Parks Department, Mountain Valley Emergency, and Oak Valley Ambulance. The Authority having Jurisdiction will retain Incident Command Duties until such emergency is mitigated and returned to event staff.

#### Communication

All communications shall be controlled through the Command Post. The emergency channel will be designated and listed on every radio for all emergency response personnel and staff. All radio zones will have access to Emergency Channels. All emergency channels will be dedicated and recognized before the event and communicated during daily safety briefings. All emergency channels will be accessible on each zone.

The Command Post may designate additional channels as deemed necessary. All communications during an emergency shall be restricted to only emergency traffic. All other coordination shall be administered through the team leader and/or assigned personnel. Radio channel list will be included in the Emergency Response Plan.

Radio Channels will be assigned to each emergency dispatch (Security channel, Medical Channel, Fire Channel, Operations Channel, Production Channel, etc.) They will be assigned and delivered to all agencies and departments on site.

#### Team Leaders

Supervisory personnel are assigned to a group of event staff to ensure a safe and successful event. The team leaders shall work under the direction of the Event Command Post.

#### Manpower Staging Area

Manpower staging area is a location that will be set up adjacent to the incident without compromising safety to which all additional manpower personnel shall report for assignment. The Command Post will assign a team leader to this location to supervise manpower personnel.

## Casualty/Patient Categories

Triage of patients will occur in compliance with OES Region IV MCI Plan.

#### A. Immediate

These patients are of the highest priority and are removed and treated first. They are the ones that will die within minutes if not treated rapidly. Examples may include: Airway obstruction, massive bleeding, shock, open chest or abdominal wounds, severe head injuries and severe cardiac problems.

#### B. <u>Delayed</u>

The patients falling into this category are those whose injuries are such that will produce death within a half-hour or more, if not treated. These injuries are serious and need attention; however, treatment and removal may be delayed until the Priority I patients have been stabilized. Examples may include burns, major multiple fractures and spinal injuries.

#### C. Minor

The type of injuries in this category may have treatment delayed and are generally transported by some means other than ambulance. Examples may include minor fractures, lacerations with minimal blood loss, and rib fractures without breathing difficulty and minor burns.

#### D. D.O.A.

These patients are the already dead or so severely injured that death is certain within a short time, regardless of treatment given. Examples may include traumatic cardiac arrest, massive head injuries with brain matter exposed and massive body mutilation.

## VI. (cont). EMERGENCY EVACUATION

#### Shelter-In-Place:

Due to the geographic features of the Event location, shelter-in-place has been identified as the most effective emergency response strategy in the event of an earthquake or fire. Stages will be utilized to communicate with Event Attendees about the status of the emergency situation

and guide attendees to gather in a safe location to await further instructions. Depending upon the emergency situation, patients will be assessed by medical personnel and if appropriate, transported to off-site medical care.

#### Safety Manager

The Safety Manager shall report to the Command Post to coordinate evacuation efforts with the incident command personnel.

#### <u>Traffic</u>

Will report to the team Parking & Traffic Lead for their assignment. The primary function of traffic personnel will be to direct traffic out once the road conditions are assessed and casualty/patient priorities have been completed. The responsibility of the gate team leader is to position personnel so that a smooth traffic flow may be maintained during an evacuation.

## **Security**

Will direct people away from high-danger areas and toward safe gathering spaces. They will also assist the local authorities as needed.

## **Event Managers**

Shall report to manpower staging area and will work under the direction of the Site Operations Direction and Safety team leader as needed.

## Music Area Security

Music area personnel, during performance time, shall report immediately to the Stage Manager and work under the direction of the team leader to direct people to the proper area. Outside of the performance time, music area personnel shall report to the manpower staging area for further assignments.

#### Medical

All medical personnel shall report to the medical staging area that shall be designated at the time of the incident. The Event Medical Unit Leader will serve as a Liaison to the Medical Group Supervisor. The Medical Group Supervisor will be part of the responding emergency response team and will utilize the OES Region IV MCI Plan to mitigate the incident.

#### Communication

All communications shall be controlled by a designated Communications Officer appointed by and located at the Command Post. All communications personnel shall report to the command post. The emergency channel shall be Channel 1 during an emergency event. The Communications Officer may designate additional channels as deemed necessary.

#### Lifeguards

During recreational time lifeguards shall report immediately to the shoreline and work under the direction of the Medical leader. When outside recreational time, lifeguards are to report to manpower staging area for further assignment.

#### Fire

Fire personnel will be stationed in the medical tent or with Stanislaus Consolidated Fire Protection District personnel for the duration of the event. If fires are reported, Incident Command protocol will be enacted immediately. In conjunction, fire personnel will begin addressing the fire situation immediately and report to the Incident Commander and local agencies upon their arrival.

#### VII. Incident Report

All instances of accident, property incidents, or matters of record will be required to have an

incident report completed to record details of any activity that occurs at event requiring use of medical or security services. This form will be used to notify event officials of any special event in order to provide support or aid, as well as track data for future planning to mitigate any repetition of the unusual activity or injury.

#### <u>Documentation</u>

The special event incident form is to be completed by all affiliated staff, medical and security personnel and should be filled out immediately after the incident. Incidents which require the use of outside allied emergency agencies shall be ran through the Stanislaus County SR911 Dispatch system for proper notification, dispatching and documentation. Agency case numbers will be made available by response personnel upon their arrival. Emergency response personnel shall work in conjunction with Dirtybird Production Staff to ensure the appropriate investigation and documentation occurs.

## Routing

Special Event form, once completed, shall be taken the Command Post, and later will be filed with the Dirtybird Production team.

# VIII. Waste Management Plan Reduce / Reuse / Recycle Standards

#### Overview

Dirtybird Campout will work directly with our Waste Services Vendor and Education Program to provide a comprehensive, innovative, industry-leading waste management service. Gemini will work diligently with Dirtybird Campout and MRRP to "Keep It Green" by diverting as much waste as possible from landfills. Gemini offers "The Nothing Wasted" teams to collect presorted waste for Turlock Scavengers, the preferred vendor of MRRP, to take to local recycling centers.

Dirtybird Campout shall encourage Leave No Trace behavior to its attendees through online communications and on site field guides and signage. The event will provide opportunities for Attendees to be waste responsible with the goal of leaving the space cleaner than when they arrived.

Event shall be a Leave No Trace (LNT) and Pack-in Pack-out event, referring to the concept that a space can be left in nicer and cleaner condition than when first encountered. Attendees are expected to bring minimal waste to the event and pack out any waste that they do generate onsite. Therefore, the goal of the Gemini Waste Services team is to limit the amount of waste given to attendees in order to encourage the LNT principle.

Gemini Waste Services and Dirtybird Campout will have designated staff at ALL times to make sure that no trash or waste goes into the water at any time. All vendors will acquire the necessary permits through Stanislaus County Environmental Resources Department.

<u>Set Up and Implementation of Waste Management Collection System by Gemini Waste Services</u>

Dirtybird Campout proposes to implement the Gemini Waste Services Program as a comprehensive waste management solution for the Event site. Attendee participation in the maintenance and cleanup of the event grounds will be a top priority for our crew and work plan.

Gemini Waste Services will set up and strategically place up all compost, recycling and trash collection containers in groups around all West Shore activated areas as necessary. All collection stations will be clearly marked with signage as to the appropriate receptacle for each type of material (compost or recycling or landfill). Gemini will routinely patrol the Event site and empty containers on a regular schedule, as well as cleanup trouble spots throughout the live event.

Gemini Waste Services will thoroughly clean the venue each day so stage, food vending and other areas remain clean and safe. After the event, Gemini Waste Services will thoroughly clean the site in as timely a manner as possible. Dirtybird Campout and Gemini Staff members and work exchange "Green Team" crews will hand pick the site, bag loose litter, collect all bags of waste, and sort for proper disposal and capture.

## Collection points

There will be approximately 25 attendee recycling collection stations located on-site, 8-10 staff and vendor collection stations, and one main sorting station for the dumpster hauling of waste to the appropriate off-site facility. The attendee collection stations will consist of composting, aluminum recycling, and cigarette receptacles. The staff collection stations will consist of three bins, one for each of the following materials: Recycling (Paper, metal/glass, plastic) compost, and landfill. The main sorting station will consist of three dumpsters: single stream recycling, landfill and compost.

#### Service Schedule

Gemini Waste Services will provide labor in sufficient numbers for the above services.

Gemini Waste Services will routinely service all stations with crew working in shifts covering 20-24 hours/day on event days and 10-12 hours/day on build and strike days.

Gemini Waste Services will arrive to site on Wednesday, September 24 and depart when cleanup is finished, after a final walk-through with Parks staff (tentatively EOD Thursday October 12, 2018).

Gemini Waste Services will ensure an appropriate hauling schedule is set up with Turlock Hauling, the preferred MRRP hauling vendor.

A Return / Recap survey With Gemini Productions and Tailfeather Events, Inc. will be provided 30 days or 1 month from last person out.

#### Event Waste Education Literature, Signage Education, and Specifics of Waste

## **Policies**

Gemini Waste Services will be 'advocating' pack in pack out principles upon entry and exodus through their presence in key areas. Green Crew will enforce strict pack in/ out principles. Should there be any trash left behind after the event, Dirtybird Campout and Gemini Waste Services will be responsible for all waste that is not packed out by attendees.

Gemini Waste Services will work closely with the event to ensure waste and recycling information on event greeting is disseminated before the event. This includes:

- Distributing waste protocols in writing in advance and onsite with concessions vendors
- Advancing waste protocol in writing with other operations and production vendors.
- Drafting messaging for event website and social media educating Attendees on waste responsible behavior
- Signage at all key places: Camping areas, walk-in camping, all collection stations, heavy traffic roads and footpaths, entry and exit.
- Trained workers at heavy traffic waste stations.

#### Food Vendors, Staff Catering & Marketplace vendors

Pre event literature will be sent to production leads in an effort to educate vendors about waste management practices on-site. Upon arrival, additional education sessions will take place preevent to ensure that waste management during event goes as smoothly as possible.

Vendors must follow strict guidelines regarding the materials they are allowed to use in their kitchen a n d serve to attendees. Disposable, compostable dishware is used. Please see the materials list for acceptable materials. Any materials outside of the accepted list should either be left at home or packed out.

Vendors are expected to limit the amount of packaging they bring on-site by unwrapping goods before they come to site. All vendors must ensure that their sellable items are not disposable or soon-to-be trash items.

All waste shall be recycled by a local biofuel provider.

- All food and beverage vendors will be required to use BPI certified compostable service items.
- Vendors will be expected to sort and dispose of their prep-waste appropriately. Gemini
  Waste Services will work closely with the event to provide waste collection containers
  specifically for food and beverage vendors.
- Vendors will be required to clean their "booth" spaces upon leaving the event.
- Vendors will be required to remove their used cooking oil from site to dispose at their commercial kitchens.

## Other Vendor and Contractor Requirements

- All production and operation contractors will be required to clean their work spaces upon leaving the event.
- Materials that cannot be removed from site, must be sorted and disposed of in the provided dumpsters/debris boxes. Gemini Waste Services will be available to advise on proper disposal of items.
- Gemini Waste Services will provide waste stations for staff and vendor general use in staff camping, production and staff catering areas.

## IX. USE OF RESERVOIR

Attendees shall be permitted to swim in designated areas during designated hours. Floating inflatables and devices are approved up to 10' x 10'. Floating art installations are allowed as long as they adhere to criteria established by Dirtybird Campout in conjunction with the Modesto Reservoir Park Manager and Stanislaus County safety agencies.

Water quality regulations for events are as follows:

- NO Gas Cans are allowed at Modesto Reservoir Regional Park.
- No non-onboard portable generators allowed. If the generator is built into the recreational vehicles it is approved to be on site.
- NO ANIMALS are allowed at Modesto Regional Park at any time, with the exception of service animals that meet the definition under Stanislaus County Service Animal requirements. Service animals with proper credentials will not be allowed in the reservoir water.
- Removal of all reclaimed water that is used for bathing and or washing of equipment/ dishes by the company contracted for the event.
- Launch comprehensive program to educate attendees about new water policies via website, onsite booklet, Event greeter program, and educational installations to reinforce NO BATHING or washing of dishes, and clothes in the reservoir with soaps, shampoos or detergents
- Provide the County data on total gallons of reclaimed water transported out of the event
- Dust control to be done with clean water
- Bathing in the reservoir with soaps, shampoos or detergents of any kind is PROHIBITED
- Provide adequate showers at a reasonable fee to attendees in the effort of NO BATHING in the reservoir with soaps, shampoos or detergents.
- No swim stages allowed. Water art installations are not to become swim platforms
- All fuel areas including generators in use must have spill containment
- All water vessels shall be inspected by Parks staff for Quagga & Zebra Mussels prior to launch
- All vendors will acquire the necessary permits through Stanislaus County

## **Environmental Resources Department.**

- All Campers who will be conducting fishing activities will need to have a current license by Fish and Game (Closest license in Waterford).
- All portable restrooms need to be 100 ft. from shoreline and kept clean throughout the event.
- If there is water access during the time of your event, the department suggests that you
  hire a third party to do daily early morning water sampling. Modesto Irrigation District will
  perform daily samples of the water, and if the water does not meet clarity standards,
  event beaches will be closed down by MID.
- Personal Watercraft will be limited to no motorized vessels without holding tanks.
- Production and Security will have motorized boats onsite for production use only.
- Games and Activities will perform activities including Row Boat, Kayak, and/or canoe activities, swimming activities, and other water recreational activities with non-motorized vessels.
- Lifeguards will be stations at designated swimming areas.
- Signage protecting the water's edge will be provided by Modesto Regional Park and Dirtybird Campout.
- Animals are not allowed in water- any service ADA Animals allowed on site will be instructed to keep all animals out of the reservoir.

If you do not choose to perform your own water tests, then you agree to accept Stanislaus County Parks and Recreation's results. We can suggest an outside independent lab to perform these tests if you prefer.

#### X. POTABLE WATER DISTRIBUTION PLAN

Dirtybird Campout Potable Water Distribution plan will be based off of the MRRP's existing distribution, faucets and drinking fountains for all food preparation, hand and dishware washing. We use food grade hose as well as Pex pipe for longer runs as required.

Dirtybird Campout will design and implement a water distribution grid that encompasses the needs for all food vendors ware washing, prep and hand washing needs as specified by District Health department standards below. In addition hand washing and bottle fill locations for all Attendees and staff through this same grid of distribution will be provided.

All grey water collected from temporary shower locations and vendor/ patron tanks will be disposed of at a proper dumping facility.

Potable water during a community event is required as part of the food operation when food is being prepared, offered to the general public at the event. Below are some excerpts of California Retail Food Code in regards to potable water requirements. For further details and information see link at the end. Please contact our food program senior, Kit McClurg for more details of food operation requirements in a community event. Also see attached forms regarding water requirements and conditions for temporary food facilities during a community event. Please contact Kit McClurg for all food associated questions.

113869. "Potable water" means water that complies with the standards for transient noncommunity water systems pursuant to the California Safe Drinking Water Act (Chapter 4 (commencing with Section 116270) of Part 12, to the extent permitted by federal law.

114189. The enforcement agency may monitor and enforce the potable drinking water standards in the California Safe Drinking Water Act (Chapter 4 commencing with Section 116275) for purposes of enforcing this part and compliance with any requirements with regard to potable water, as defined in Section 113869.

#### 114205.

- (a) Nonpermanent food facilities that handle nonprepackaged food shall be equipped with potable water and wastewater tanks, unless approved temporary water and wastewater connections are provided.
- 114207. Materials that are used in the construction of potable water and wastewater tanks and appurtenances shall be safe, durable, corrosion-resistant, nonabsorbent, and finished to have a smooth, easily cleanable surface.
- 114381.1. In addition to the permit issued to each food facility participating in a community event or swap meet, a permit shall be obtained by the person or organization responsible for facilities that are shared by two or more food facilities.
- (a) The permit application and site plan shall be submitted to the enforcement agency at least two weeks prior to operation of any food facility.
- (b) The site plan shall show the proposed locations of the food facilities, restrooms, refuse containers, potable water supply faucets, waste water disposal facilities, and all shared warewashing and hand washing facilities.

#### X. NOISE MANAGEMENT PLAN

#### Purpose

To provide a comprehensive overview of noise management protocol utilizing the following methods:

Measures to Prevent Traffic and Noise Concerns

- Dirtybird Campout will send out an event notice within a 3-mile radius of Modesto Reservoir a couple weeks prior to the event, that has been pre-approved by Stan County Parks Department.
- All speaker systems will be aimed to the north and tilted down toward ground level.
- Four corner or full surround sound speaker setups are required during all peak and off peak to concentrate sound in a specific area at reduced speaker output levels and to reduce spillover.
- Highly directive speaker systems with smaller coverage pattern angles are recommended.
   Cardiod subwoofers cabinets (e.g. QSCKS212C) or cardiod subwoofer arrangements using multiple cabinets are required
- Create sound wall barriers using ideal surface weight of at least 3-4 lbs/sq.ft. with a solid backfacing. The side toward the sound source to be sound absorptive. Options that can be used are:
  - Option 1 Acoustical Curtains: Minimum 1 lb/sf (preferably 2 lb/sf) mass loaded vinyl barrier coupled with a quilted fiberglass absorber. Acceptable products, the following or equal: Kinetics KNC-100BQQ, Singer Safety Sound Stopper QFM SC-125, or Sound Seal BBC
  - Option 2 Straw bale walls: Plastered straw bale walls have been proven to be effective acoustical barriers for exterior wall construction. Unfinished straw bales should also provide sufficient absorption and barrier properties to be an effective sound wall, though test data is unavailable. To improve the effectiveness of straw bales as a barrier, it is recommended that a layer of continuous plywood be installed at the back of the bale stack or sandwiched in the center of bales to provide a solid backing.
  - Option 3 Plywood barrier: A continuous wall constructed of tongue and groove plywood can serve as effective barrier. The base of the plywood wall can be supported by concrete K- rails (concrete barriers used often for road construction projects) or supported by posts dug into the ground, or attached to scaffolding, etc. Wood studs, insulation, and a second layer of plywood with holes drilled in to the one side facing the noise source can be used for sound absorption.
- Create a contract and protocol for all sound system operators and DJ's that specifies how Dirtybird Campout will monitor and stay within decibel levels at all times This includes an acoustic check is to be performed on Thursday October 4, 2018 once the audio system has competed install and prior to performances beginning. A schedule of this acoustic check timeline will be included in the "Run of Show" event timeline (Internal document for stage teams and park and director personnel. During the Live show, a sound reading will be metered one time per artist performance during peak or half way through performance timeline. The meter will be read at 100' and 150' with a DB Meter taking acoustic measurements in dbc and dba signature readings. A log of each reading will be captured by the sound technician. This log will be made available to park personnel and upon request.
- Adhere to decibel level limits laid out in the Noise Sources and Category Descriptions chart below at ALL times, including during sound checks. Will be subject to Dirtybird Campout a \$1,000 fine per incident of exceeding these limits. Fines will be based on a third party Noise Monitor's detailed noise report of the DIRTYBIRD CAMPOUT.
- Stanislaus County will designate a third party Noise Monitor to report on sound levels at the event, whose fees will be paid by Dirtybird Campout (Up to \$7,700).

The following chart describes event areas categorized by noise impact and decibel levels not to be exceeded during peak, non-peak and regular programming hours.

#### **Event Notice**

Dirtybird Campout will send out an event notice to homes within a 3-mile radius of Stanislaus County Facility at least two weeks prior to the event. Stanislaus County will review the notice prior to it being sent out. The notice will clearly give the Hotline phone number to call for questions and complaints.

#### Hours of Operation

The curtailment of programming hours on main and regular stages will be implemented on evenings preceding weekdays (Thursdays and Sundays). These stages will have the largest sound systems (accounting for one half of the sound power at the event) and also host the main acts. These are the stages that have the most potential for disturbance. Small, micro, and portable categories may (case by case basis) continue to be operational throughout the event, however their noise levels are anticipated to be significantly lower as to not cause any disturbance to surrounding community.

#### Sound System Equipment & Configurations

Sound systems will be configured and managed to minimize noise disturbance. Providing such layouts will maximize levels throughout the audience, while minimizing the "throw" and directionality problems. As with site layout, the orientation and design of the sound systems can have a significant effect on the sound propagation to the community. Careful design of the sound systems will maximize the containment of sound within the venue. Each system will also comprise of electronic 'limiters', which will be set to control the output of the sound, both in terms of the overall level, and also the frequency (the bass beat can be controlled independently).

Provide focused "surround sound" PA Systems. Four corner and full surround speaker arrangements shall be utilized. Stages and speaker systems will be oriented/aimed to the north where there are far fewer noise-sensitive receptors.

All of the previously mentioned sound barriers will be utilized to further absorb and block the sound from spreading to the community.

#### Car Parks and Camping Areas

We will inform and educate our Attendees about the sound permit and ordinance in the campgrounds. The campsite sound ordinance will state that playing any kind of sound or music at levels so as to be 'audible and discernible' offsite will not be permitted at any time during the

event.

To mitigate renegade sound sources, Vehicles entering the site will be searched by security personnel. Any sound equipment that is identified as having the potential to be used for unlicensed public entertainment will be confiscated. Equipment that falls into this category are Subwoofer speakers and multiple (more than 1) self-powered speakers or amplified speakers.

Off board generators and gas tanks for powering such sound systems will not be permitted on site.

Messaging to ticket holders, on our websites, and in the event online social channels like the social media event pages will confirm that renegade performance sound equipment, generators, and fuel tanks will not be permitted at this site.

Security teams as well as our Ranger teams will be patrolling the campsites to ensure that this requirement is strictly observed. In the event of a potential breach of campground sound ordinance, the Ranger team will be the first team to engage, inform and educate the owners of sound systems and/ or Attendees in violation of the campsite sound ordinance. They will inform the Attendees that they are in breach of the event's sound permit that states no personal sound systems or excessive sound are allowed. They will be require to cease all sound above the park perimeter levels in the noise ordinance. These campsites and Attendees will receive a one warning in writing. A copy will live on file as an incident report. Should these Attendees or campsites violate the sound ordinance again they will be asked to leave Dirtybird Campout Event for the duration of the event.

Rangers will use all reasonable endeavors to halt these activities such as communication, instruction, and education. By informing the attendees that for Dirtybird Campout to be invited back to MRRP, our Dirtybird Community must work together to comply to follow the sound permit regulations.

Should any individual or group not comply with the education and communication methods of our Ranger and/ or security teams and continue to produce sound that is audible from the park boundary, they will be given a warning that the situation would be escalated to invite Event security to support reducing the sound. If Rangers and Security are not able to manage the sound violators, Law Enforcement would be called in for support these teams.

Any such incident will be kept under continual review for the duration of the Event or until the matter is resolved.

#### Complaint Handling

The following protocol will be put in place to encourage direct communication between local residents and event organizers and ensure that local residents know what to expect:

- Any complaints received over the Event will be logged and recorded so preventative
  measures can be put in place to stop a recurrence of the same complaint. By recording
  all complaints it will enable staff to see where the complaints are coming from and for
  what reasons.
- A Noise Monitor will be appointed for the duration of the event, whose sole task will be the management of noise issues arising from the permitted site.
- Throughout the event, the Noise Monitor will liaise closely with Dirtybird Campout representatives, first Risk Manager Jeff Kasky and then Communications Manager

Aundy Crenshaw, who are responsible for decibel level controls and for directing communications to the Dirtybird Campout Production Managers (including any Technical Directors, Sound Engineers, and Stage Managers). If the Dirtybird Campout Representatives are made aware of noise disturbances or any possible breach from permitted levels, the source of the disturbance will be identified and sound levels reduced as necessary. In the event that Dirtybird Campout staff are not responsive, Law Enforcement may take all necessary action to reduce the decibel levels.

## Neighborhood Call In Line and Communications Channels

A dedicated telephone line will be made available to all Modesto Reservoir Regional Park neighbors for the duration of the sound checks and event. This line will be monitored and answered by the Dirtybird team during event hours. This line is a communication tool for the neighborhood should there be any questions regarding the Dirtybird Campout event, access to the event for neighbors, and concerns neighbors may have regarding the event.

A dedicated Neighborhood email will also be provided to all neighbors. All call in lines and emails will be listed in letter to the neighbors and in the "Neighborhood Packets" provided to all neighbors upon pick up.

Should complaints of noise arise, at any time during the event, the event's Noise Monitor or Parks staff may visit the caller and/or the Regional Park boundaries to perform a noise level measurement. If sound levels are above the limit, immediate action will be taken to reduce the noise level from the venue by having the Dirtybird Campout Representatives directly communicate with the Production Managers at the source of the noise disturbance. If troubleshooting the issue leads to tangible solutions such as repositioning speakers and noise barriers, the Noise Monitor will communicate his or her findings to the Dirtybird Campout Representatives, who will then communicate to their production managers to carry out the changes. This information will be recorded and noted as a reference to address for future events.

Communication with the representatives will be achieved by cell phone, text, or on site 2-way radio if cellular service is not available, thus a quick response to the problem can be achieved. Dirtybird Campout will also provide Internet Connectivity for email and web services. Dirtybird Campout Representatives will have direct communications to production managers via on site 2-way radios who will take appropriate actions.

Parks staff will assume responsibility for receiving calls placed to the hotline. Parks staff will work with the Dirtybird Campout Representatives Jeff Kasky and Aundy Crenshaw who will address sound engineer/staff to investigate and address any calls with concerns, that are received and adjustments will be made if over the approved levels. It is the expectation that the Dirtybird Campout Representatives will be available to answer all calls from Parks staff and that calls to Dirtybird Campout Representatives are not forwarded to a voicemail. A follow-up call will be made to advise the caller of the actions/steps taken to address the concern. All concerns will be logged and recorded to allow for preventative measures in the future. A dedicated staff member from the Parks department will be in place to ensure that the complaint hotline is well publicized, manage, and log all calls. The caller will be provided with relevant information including event program times.

Dirtybird Campout will cover the actual Parks Staff costs to run the Hotline. Estimated costs for administration is approximately \$2000.

A Noise Monitor will be appointed by Stanislaus County for the duration of the event. The sole

task of this Noise Monitor will be the management of noise issues arising from the permitted site. Dirtybird Campout will be responsible for the cost of this Noise Monitor up to \$7,700.

Throughout the event, the Noise Monitor will liaise closely with local law enforcement agencies. If the Dirtybird Campout Representatives are made aware of noise disturbances or any possible breach from permitted levels, the source of the disturbance will be identified and sound levels reduced as necessary.

#### Noise Management

The Noise Monitor will provide a detailed report of noise levels at the event. This report will coincide with the acoustic readings taken by Dirtybird Campout's sound technicians at each stage. The Event will be charged a fine of \$1,000 per instance if event noise levels exceed those established in the chart above.

During the event, ongoing noise monitoring will be conducted by Noise Monitor at residential catchment areas to assess noise impacts and ensure that these impacts are addressed in future planning. The Noise Monitor will be on wireless radio and mobile phone contact with the first point of contact: Jeff Kasky, second contact: Aundy Crenshaw, and then the Event Director (Lisa Sunde) and the Production Manager (Lee Kalkofen) throughout the event. Should there be any noise issues with residential areas, we will address it immediately at the noise source.

Noise monitoring enables any changing conditions to be responded to expediently in order to ensure the event is successful. Therefore, the Noise Monitor will have unrestricted access within the venue location prior to the event and during the event for the purpose of reference noise level monitoring (prior to the event) and onsite noise monitoring (during the event).

## Sound Monitoring and Control

Both before and during the event, the event management team will have full control over the sound levels at all stages. Thus, all other parties, including artists, production managers, and sound engineers will have to sign a contract that permits them to stay within allowed decibels levels. Noise levels will be monitored continuously throughout the event at each stage during each artist performance. In addition to the control of the overall sound level, frequency adjustments can also be made to reduce the sound at dbA and dbC frequencies.

#### Sound Management

The configuration of the sound system and sound system management practices will be assessed and modifications identified to ensure a substantial reduction in off-site noise levels, particularly in low frequency sound, at all future events.

#### Sound Walls and Barriers

Sound walls and structures will be put in place to reduce the spreading of sound beyond immediate stage areas. Four point sound systems will be put in place as well as straw hay bale barriers around speaker systems.

## **Background Summary:**

These events take place in throughout the United States. Dirtybird Campout is an adult summer camp themed music event. The event began in 2015 with approximately 4100 attendees, and has grown to 7800 attendees in 2017. The event is seeking MRRP to be the host location that can better serve the attendees by providing traditional camp and recreation programming in line with the event programming such as field games, canoeing, kayaking, swimming, archery, fishing, arts and crafts and more, while also providing stages for music programming and variety shows such as talent shows, Bingo, magic shows, and comedy.

## Requirements/Conditions of Exclusive Use Event Agreement/Permit:

#### I. General Conditions

- · All Parks' rules and regulations will be enforced.
- Tailfeather Events, Inc. shall work with all other necessary groups, organizations, or other
  governmental personnel as determined by applicable codes, laws, and regulations to ensure a
  safe event including, but not limited to: The Department of Environmental Resources
  Environmental Health, The Sheriff's Department, California Highway Patrol, Stanislaus
  Consolidated Fire, Risk Management, and Mountain Valley Emergency Medical Services.
- This Exclusive Use Event Agreement / Permit shall be valid only for the Campout Event on the days and hours specified on the permit and be in compliance with the Final Operations Plan.
- Tailfeather Events, Inc. shall provide the Department of Parks and Recreation insurance coverage which meets the liability limits as required by the Stanislaus County Risk Management Division with regards to special events.
- Tailfeather Events, Inc. shall indemnify the County according to the Organizational Hold Harmless Agreement, and shall provide this agreement in writing to the County prior to being on site. Individual Hold Harmless Agreements for each participant shall be acknowledged electronically or on paper as a condition of the on-line registration process for the Campout Event at Modesto Reservoir. An electronic and / or hard copy shall be provided to Stanislaus County Parks and Recreation prior to anyone on site.
- An Outdoor Entertainment Activities Permit is required by the Stanislaus County Sheriff's Department. A copy of the approved Outdoor Entertainment Activities Permit as issued by the Sheriff's Department shall be provided to the Department of Parks and Recreation immediately upon receipt by the Event Director and prior to the Event.
- An Alcohol Letter of Approval from the Stanislaus County Sheriff's Department and an Alcohol License issued by the Alcohol Beverage Control Board in Stockton, California is required and shall be provided to the Department of Parks and Recreation immediately upon receipt by the Event Director, and prior to the Event.
- If the Stanislaus County Department of Public Works requires an Encroachment Permit, a copy
  of the approved Encroachment Permit as issued by Public Works shall be provided to the
  Department of Parks and Recreation immediately upon receipt by the Event Director, and prior
  to anyone on site.

- The event shall be held in accordance with the Modesto Reservoir Regional Park, site map and the Final 2018 Operations Plan. If an addendum to the Operations Plan is necessary after the issuance of this permit, then an addendum outlining any necessary changes to the permit shall be agreed upon and signed by both the event organizer and the Stanislaus County Parks and Recreation Department Director or Assistant Director.
- The anticipated number of participants is between 7,000- 7,500 attendees, which equates to approximately 2000-2142 vehicles.
- Tailfeather Events, Inc. will abide by and assure that attendees abide by all posted signage that states "No vehicles trailers or tents beyond this point", as per County Ordinance 18.08.010 Designation of public campgrounds.
- Tailfeather Events, Inc. will provide a third party ticket sales report and/or some form of independent ticket sales or audited information to the County for verification of ticket sales, and production/vendor/artist/ volunteer attendance on a daily basis.

## II. Emergency Services and Security

- The event shall be held in complete compliance with the Fire Prevention Plan, outlined in the Draft Operations Plan or as approved by the Fire Marshall and amended in the Operations Plan.
- The security Contractor shall be approved by the Stanislaus County Sheriff's Department. The event shall be held in complete compliance with the Security Plan, outlined in the Operations Plan or as approved by the Sheriff's Office and amended in the Operations Plan.
- The event shall be held in complete compliance with all of the medical measures described in the Emergency Medical Plan, outlined in the Operations Plan.
- Tailfeather Events, Inc. shall maintain communication with the Stanislaus County Sheriff's Department to ensure compliance with the above emergency service conditions.

#### III. Use of Reservoir

- Water quality regulations for events are as follows:
- NO Gas Cans are allowed at Modesto Reservoir Regional Park.
- No non-onboard portable generators allowed. If the generator is built into the recreational vehicles it is approved to be on site.
- NO ANIMALS are allowed at Modesto Regional Park at any time, with the exception of service

- animals that meet the definition under Stanislaus County Service Animal requirements.
- Removal of all reclaimed water that is used for bathing and or washing of equipment/ dishes by the company contracted for the event.
- Launch comprehensive program to educate attendees about new water policies via website, onsite booklet, Event greeter program, and educational installations to reinforce NO BATHING or washing of dishes, and clothes in the reservoir with soaps, shampoos or detergents
- Provide the County data on total gallons of reclaimed water transported out of the event
- Dust control to be done with clean water
- Bathing in the reservoir with soaps, shampoos or detergents of any kind is PROHIBITED, including biodegradable
- Provide adequate showers at a reasonable fee to attendees in the effort of NO BATHING in the reservoir with soaps, shampoos or detergents.
- No swim stages allowed. Water art installations are not to become swim platforms
- All fuel areas including generators in use must have spill containment
- All water vessels shall be inspected by Parks staff for Quagga & Zebra Mussels prior to launch
- All vendors will acquire the necessary permits through Stanislaus County Environmental Resources Department
- All Campers who will be conducting fishing activities will need to have a current license by Fish and Game.
- All portable restrooms need to be 100 ft. from shoreline and kept clean throughout the event.

## IV. Traffic and Parking

• The event shall be held in complete compliance with the Traffic Plan, outlined in the Operations

Plan.

 Tailfeather Events, Inc. shall maintain communication with the Stanislaus County Sheriff's Department, California Highway Patrol, and incorporate recommendations made by the Stanislaus County Sheriff's Department, California Highway Patrol, and the Park Manager to ensure compliance with all traffic and parking conditions.

- Dirtybird Campout will send out an event notice to homes within a 3-mile radius of Modesto Reservoir at least two weeks prior to the event with a phone number to call for information.
- Noise monitoring by Tailfeather Events staff, will be ongoing during the event, with modifications and adjustments to decibel levels being made as needed to ensure the sound remains within the permitted levels.
- Sound walls/barrier systems will be used to reduce the spreading of sound beyond immediate areas.
- Parks staff will assume responsibility for receiving noise complaint calls placed to the hotline during event programming hours.

## VI. Water, Garbage and Sanitation

- The event shall be held in complete compliance with the Waste Management Plan, outlined in the Operations Packet.
- Tailfeather Events, Inc. shall provide one water closet and one urinal for every two hundred (200) males, and one water closet for every one hundred (100) females, or major fraction of such number permitted to attend.

- All portables shall be placed 100' from high water mark and secured in place to prevent any
  waste discharge into reservoir water. Tailfeather Events, Inc. shall provide and position all
  necessary portalets, including ADA portable restrooms.
- All toilets shall be maintained in a clean and sanitary manner during the festival.
- By the last permitted day of use after the end of the festival, the premises shall be cleaned up and all trash and debris removed. All tables, dumpsters, etc., will be returned to their original position.
- Repairs to the area of use, if needed, shall be determined by Modesto Reservoir Regional Park staff upon conclusion of the event. Any required repairs will be made within seven days.
- Prior to departure from site and/or prior to the last permitted day, an on- site walk through will be done with event and Park staff.
- Tailfeather Events, Inc. shall incorporate all recommendations made by the Stanislaus County Environmental Resources Department to ensure compliance with all water and sanitation conditions.
- Food Service
- All persons selling, preparing, delivering, or serving food or beverages shall comply with California Codes set by the Stanislaus County Environmental Resources Department.
- Tailfeather Events, Inc. shall provide sanitary facilities for food vendors that include adequate
  provisions for potable water supply and storage, refrigeration, and washing and utensil clean
  up; that meet the requirements of the Environmental Resources Department in accordance
  with all applicable California Temporary Food Facility laws.
- Tailfeather Events, Inc. shall provide the Stanislaus County Department of Parks and Recreation with a list of all vendors and / or vendor booths participating in the Music Festival no later than three weeks prior to the event date.

## VII. Fees

- With the exception of the activities authorized within the designated "Exclusive Use" area, for the purpose of this permit, all other County fees pursuant to the Parks and Recreation Department's fee schedule for entering Modesto Reservoir shall apply.
- The Exclusive Use Fee of \$90 per day and the \$10 per day Reservation Fee. Events with 5,000 or more attendees require a \$10,000 refundable deposit, (refundable if all conditions are met), is payable to the Department of Parks and Recreation, and shall be received at the time the Event Approval Request is submitted, for each event date. Should the event be cancelled by Tailfeather Events, Inc. for any reason, the Exclusive Use Fee is non-refundable. However, if the County, for any reason, were to be the cause of cancellation then the Exclusive Use Fee shall be refundable.
- · Stanislaus County is not responsible for any performance, licensing, or royalty fees to the

performers, artists, or to any other persons or entities seeking such fees for anything related to any Tailfeather Events, Inc. event. Further, the County is not responsible for any taxes owed by Tailfeather Events, Inc. or its event performers, artists, or any other persons or entities that are a result of or related in any way to the music festival held on County owned property.

• The remaining balance of event fees must be paid in full and received by the Stanislaus County Department of Parks and Recreation no later than 5:00 p.m., twenty-one (21) days after each scheduled event. Tailfeather Events, Inc. will be assessed a \$200 late fee if not paid by 5:00 p.m., twenty-one (21) days after each event. After thirty (30) calendar days, an additional five percent late fee will be assessed on any total remaining balance owed. If not paid in full within thirty (30) calendar days, no future events will be scheduled until all charges are paid in full.
