STAFF RECOMMENDATION:

- 1. Set a Public Hearing on September 25, 2018, at the 9:00 a.m. meeting to introduce and waive the first reading of an ordinance to amend existing fees for the Stanislaus Animal Services Agency.
- 2. Authorize the Clerk of the Board to publish notice as required by law.

DISCUSSION:

Stanislaus Animal Services Agency (SASA) administers vaccinations to cats and dogs brought by their owners to the clinics held at SASA. SASA also administers owner surrender services and adoptions of animals. SASA is permitted by California law to charge a fee for each of these services. Fees currently being charged by SASA were adopted by Stanislaus County Board of Supervisor ordinances. Services fees were last increased in 2008.

The SASA Joint Powers Agency Board (SASA Board) has approved the SASA Executive Director's recommendation to increase existing fees for rabies vaccinations, owner surrenders and adoptions, with a discount applied to all adoptions to "in service" area homes. "In service" areas include the cities of Modesto, Ceres, Hughson, Patterson, Waterford and the unincorporated area of Stanislaus County. The SASA Board further directed the SASA Executive Director to request the Stanislaus County Board of Supervisors adopt the increases to existing fees and amend the fee schedule in the County Code to reflect the increased fees. This agenda item is submitted to the Board of Supervisors to request a public hearing to consider the proposed increase of three existing fees that will allow the SASA to recover costs and offset expenses of the services provided.

SASA continues to experience increases in wages, health insurance premiums, workers compensation and inflation, which have caused an increase in costs. The proposed increased fees will more fully recover the actual costs incurred by the SASA in providing essential services to the general public.

Annually, SASA evaluates the cost of services provided and the fees associated with programs administered. This process includes the consideration of new or additional fees, where appropriate, as well as modifications to existing fees in order to cover program costs. In researching proposed fee changes, SASA surveyed the fees in eight comparable counties throughout California and found that the proposed fees are in-line with the other counties. Following are charts outlining the service fees for the eight comparison counties of Fresno, Kern, Madera, Merced, Monterey, Sacramento, San Joaquin, and Tulare.

SASA is proposing fee increases for three (3) of its services. The proposed fee schedule and recommendations are attached (Exhibit A) and details regarding recommended fee increases are as follows:

Rabies Vaccination Fee

SASA is requesting to increase the rabies vaccination fee. The California Health and Safety Code Section 121690(f) mandates that counties declared as "rabies areas" (currently, all 58 California counties) must fulfill certain activities, including sponsoring "actual cost" rabies vaccination clinics. The "actual cost" figure of \$6, which has been in effect since 2004, has not kept pace with inflation and significantly underestimates the costs for local rabies control agencies to operate a vaccine clinic in today's economic environment.

California Department of Public Health-Veterinary Public Health Section has recommended the "actual cost" charged per rabies vaccine dose be increased to \$10. The increase is overdue and is more commensurate with current material, facility, and operational costs, while also remaining within the financial means of the majority of pet owners.

A survey of the eight comparison counties has been completed and reveals that most counties have increased to the \$10 rabies vaccination fee.

SASA currently sponsors low cost vaccination and license clinics. Six years ago, SASA vaccinated close to 2,000 animals a year and clinics were held one day a month. The number of animals vaccinated has steadily increased every year to reach over 7,000 animals and over time expanded to five days a week to accommodate the need.

We estimate the additional revenue from these fees will be approximately \$20,000 annually.

Adoption Fee

The California Food and Agricultural Code Section 30503(a)(1) mandates all dogs be spayed or neutered at the time of adoption. SASA currently charges an adoption fee of \$90 for dogs. SASA recommends an increase to dog adoption fees from the current \$90 to \$120, with a \$20 discount for all dogs who are adopted to in service area homes. The dog adoption fee increase of \$30 will bring the fee more in line to support the costs of vaccinations, spay/neuter surgeries, microchips, and board and care at the shelter. Since the number of cat adoptions are lower than the number of dog adoptions, SASA will maintain cat adoption fees at the current fee of \$45.

In comparison with the eight comparable counties, SASA adoption fees rank very low. SASA is estimating the \$30 increase for approximately 830 annual dog adoptions to non-service area homes will increase revenue by approximately \$24,900, and the \$10 increase for approximately 1,710 annual dog adoptions to "in service" area homes will increase revenue by approximately \$17,100. SASA is projecting the increase in adoption fees will increase revenue by approximately \$42,000 annually.

Owner Surrender Fee

Owner surrender fees are paid for a veterinarian to euthanize terminally ill animals. SASA currently charges pet owners a fee of \$30 to release their animal to SASA. SASA is recommending the fee be increased to \$40 to cover SASA's costs and provide better customer service. Based on an average of 800 owner surrenders, SASA is projecting the increase of owner surrender fees will increase revenue by approximately \$8,000 annually.

POLICY ISSUE:

An ordinance of the Board of Supervisors is required to increase or establish fees of SASA. This item meets the legal requirements for setting a public hearing to consider increasing fees of the SASA. Notice of the public hearing is attached.

FISCAL IMPACT:

It is necessary to increase existing fees to offset costs incurred by SASA to provide certain services. These fees will allow for the recovery of some costs associated with providing these specific services. These costs include annual salaries, indirect costs, operating costs, facility, and utility costs. SASA's Fiscal Year 2018-2019 operating budget is \$4,610,618. It is estimated the fee increases will generate approximately \$70,000 in additional revenue annually. This additional revenue was included in the SASA Fiscal Year 2018-2019 Budget. If approved, the increased fees will be effective thirty (30) days after the adoption of the ordinance.

BOARD OF SUPERVISORS' PRIORITY:

The SASA is a separate entity created through a Joint Powers Agreement between the County and the cities of Modesto, Ceres, Patterson, Hughson, and Waterford. The services provided by SASA support the Board's priority of *Supporting Strong and Safe Neighborhoods*.

STAFFING IMPACT:

There is no staffing impact associated with the action recommended.
