A presentation was made regarding 9/15 through 10/20/2011 as National Hispanic Month in Stanislaus County.

Cherise Babb spoke regarding the proposed wage reductions and the increased retirement and health insurance costs for County employees.

Ray Brockman, a County employee, voiced concerns about the proposed wage reductions and increased retirement and medical benefit costs.

Gabriel Miramontes spoke regarding the services provided by the Department of Child Support Services and proposed wage reductions for employees.

Angela Jameson voiced concerns about staffing reductions and proposed wage reductions for County employees.

Rebecca Harrington from the South Modesto MAC spoke regarding nuisances associated with a recycler in their neighborhood. Supervisor DeMartini stated that he will look into the permitted uses for this recycler, and will follow-up on this issue.

Cynthia Hujdic spoke regarding the difficulties faced by employees due to reduced staffing levels at CSA.

Wayne Davidson voiced concerns regarding AB 109 and the transfer of the supervision for lower-level criminal offenders and parolees from the State to our county.

Maize Avila voiced concerns regarding the reduction of County services due to the budget.

O'Brien/Withdraw unan. **6:35 p.m.** Closed the public review period for the FY 2010-2011 Consolidated Annual Performance Evaluation Report (CAPER) and conducted a public hearing; adopted the FY 2010-2011 CAPER and authorized staff to incorporate comments received prior to the close of the public comment period and during the public hearing in the final CAPER to be submitted to the Department of Housing and Urban Development (HUD) – Planning

Withdraw/Chiesa unan. **B5** Approved the Community Corrections Partnership Plan for Implementation of the 2011 Public Safety Realignment; authorized the Chief Probation Officer to sign all necessary documents related to the Public Safety Realignment, including all contracts; approved contracts listed in Attachment 1 of the agenda item where cumulative compensation paid exceeds \$100,000 or greater since 07/01/2009, and authorized the Chief Probation Officer and the Sheriff to sign the related contracts as detailed in Attachment 1; directed the Auditor-Controller to establish a new non-interest bearing Special Revenue fund for the Probation Department as a separate legal budget unit titled as Local Community Corrections Budget and establish appropriations and estimated revenue as detailed in the Budget Journal; directed the Auditor-Controller to adjust each agency's FY 2011-2012 appropriations and estimated revenue as detailed in the Budget Journal forms; and, amended the Salary and Position Allocation

Resolution to reflect the recommended changes outlined in the Staffing Impacts section, effective the first pay period following the Board of Supervisors' approval – Probation

O'Brien/De Martini unan. **B6** Approved a conditional award of a construction contract, conditioned upon State approval to proceed with the construction of the Stanislaus County Juvenile Commitment Center Project, to Roebbelen Contracting, Inc. of El Dorado Hills, California, for the lump sum amount of \$14,983,000 for the Base Bid and Alternates 1, 2 and 3; approved the formal resolution as required by the State of California for submission of the conditional award of a construction contract in order to proceed with the construction of the Stanislaus County Juvenile Commitment Center Project; authorized the CEO to plan and conduct a public ground breaking ceremony to coincide with the commencement of construction; authorized the Project Manager to issue a Notice to Proceed upon receipt of proper insurance and bonds; authorized the Project Manager to negotiate and sign contracts and work authorizations necessary to manage the construction phase including construction management, professional services, and other project related expenses as necessary to manage the project as long as the costs are within the approved project budget as approved by the Board of Supervisors; directed the Auditor-Controller to establish the Project Budget and to increase appropriations and estimated revenue for this project as detailed in the Budget Journal form; and, relieved F&H Construction of its mathematical bid error and thus the forfeiture of its bid bond and approved the report prepared by County Staff in accordance with Public Contract Code §5101 and appended to this Agenda Item as Exhibit A and authorized the Project Manager to execute the report – CEO
