The hours of operation will be Sunday through Saturday, sunrise to sundown, by appointment only, with a maximum of 30 participants for large group demonstrations. The property is located at 5153 Santa Fe Street, on the north side of Santa Fe Street and west of Richardson Road, in the Riverbank/Oakdale area. A CEQA Negative Declaration will be considered.
