Agriculture) zoning district. This amendment will not apply to A-2 zoned land which is enrolled under a California Land Conservation Contract (Williamson Act Contract). As part of this amendment, both the A-2 (Chapter 21.20.030) and the R-1 (Chapter 21.28.030) zoning districts will be amended to add Public Events and Outdoor Entertainment, under Uses Requiring a Use Permit. The Planning Commission will consider a Negative Declaration on this project.

#### IX. REPORT OF THE DIRECTOR

### **BOARD OF SUPERVISORS' ACTIONS OF DECEMBER 11, 2007**

- A. The Board, sitting as the Redevelopment Agency, approved an expenditure of \$60,000 of Housing Set Aside Funds for the purchase of one single family residential lot in the airport neighborhood. That lot eventually will be transferred to Habitat for Humanity, who will then build a low-income housing unit on it.
- B. The Board conducted on a public hearing on the second reading of an ordinance amending Title 16 of the Stanislaus County Code, adopting by reference the California Code of Regulations Title 24, 2007 Edition of the California Building Standards. In essence, the Board adopted a new building code.

- D. Considered and denied General Plan Amendment 2006-07 and Rezone 2006-11, Belaski Repair Shop. Your Planning Commission had recommended denial of this item.
- E. Considered the General Plan Amendment 2007-01, and the introduction and waiving of a reading and adoption of Ordinance Amendment 2007-02, the Ag Element Update of the Stanislaus County General Plan, Stanislaus County Williamson Act Uniform Rules Update. The Board approved the Ag Element and subsequent amendments on a 3-2 vote, removing the requirement for mitigation of commercial and industrial land.
