expand an existing dairy operation, located on three parcels (56.2, 28.16, and 28.62 acres in size), currently permitted through the Central Valley Regional Water Quality Control Board to house a maximum of 2,760 mature cows and 250 support stock, to a maximum of 3,800 mature cows and 890 support stock. This request includes the addition of corrals, two freestall barns (94,500 square feet, and 60,000 square feet in size), two 9,000 square foot special needs barns, a 2,880 square foot addition to an existing special needs barn, and a calf hutch with flush lanes. The property is located in the A-2-40 (General Agriculture) zoning district on the northeast corner of West Main Street and N. Blaker Road (9769 & 10213 West Main Street, 118, 132, & 136 N. Blaker Road), west of the City of Turlock. The Planning Commission will consider adoption of a CEQA Negative Declaration for this project. APN: 022-041-006, 022-041-012, & 022-041-013.

NON-CONSENT ITEMS

B. TIME EXTENSION AND MODIFICATION TO CONDITIONS OF APPROVAL FOR VESTING TENTATIVE SUBDIVISION MAP APPLICATION NO. PLN2014-0074 – FAIRWAY 7 ESTATES – Request for a one year time extension and modification to Conditions of Approval No. 12, 56, and 63 addressing site and storm drain basin screening and a multi-modal pathway. The project was approved on December 5, 2015, to allow for the subdivision of an 8± acre parcel into 13 lots for in the R-A (Rural Residential) zoning district. The project site is located at the northeast corner of State Route 108/120 and North Stearns Road, in the Oakdale area. This request is considered Exempt from the California Environmental Quality Act. APN: 064-016-004.

Etchebarne/Buehner (6/2) (Blom/Gibson) APPROVED THE STAFF RECOMMENDATION AS OUTLINED IN THE PLANNING COMMISSION MEMO DATED MARCH 15, 2018, INCLUDING THE MODIFICATIONS TO CONDITIONS OF APPROVAL NO. 12, 56, 60, AND 63, AND WITH THE ADDITION OF CONDITION OF APPROVAL NO. 66 TO READ AS FOLLOWS:

12. The block wall along State Route 108/120 shall be 10 feet tall without landscaping or 8 feet tall and constructed, except where the grade differential makes the intent of the sound wall ineffective. There shall be with landscaping incorporated into the design where the grade is level or below the State Route roadway. The proposed storm drain basin shall be screened completely by a 6-foot-tall chain-link fence with landscaping grown onto it. In any case where a planting location is found to potentially interfere with existing electrical facilities, a more suitable species shall be selected and approved by

the director of the County Parks Department or staff. The final design shall be approved by the Director of Planning and Community Development or his/her designee prior to the recording of the final map.

- 56. A multi-modal access passage shall be provided to allow access for pedestrians and bicyclists traveling through the subdivision onto North Stearns Road. A minimum 5-foot wide multi-modal access shall be installed that may run contiguous to the 20-foot wide fire access lane to Stearns Road. The design and improvements are to be approved by the Public Works director and/or designee. The passage shall be gated and locked until future pedestrian improvements to North Stearns Road are completed or unlocking/removal of the gate are approved by both the City of Oakdale and Stanislaus County Public Works directors, and/or their appointed designee determine it is appropriate to open the pathway.
- 60. All conditions of the Will Serve Letter dated May 6, 2014, shall be completed prior to the recording of the final map acceptance of the domestic water system by the Oakdale Irrigation District.
- 63. A six-foot-tall split-faced block wall on property lines adjacent to North Stearns Road shall be required, except where the grade differential makes the intent of the sound wall ineffective. A six-foot-tall chain-link fence shall be installed where the grade is below the roadway. The chain-link fence shall include landscaping, subject to final approval by Oakdale Irrigation District, County Planning and City Planning staff or their designees prior to installation. The block wall All improvements shall be accepted into the formed County Service Area (CSA).
- 66. If the storm drain basin is to be landscaped with grass and served with an irrigation system, then the fence along the north and east parts of the basin lot are not to be installed to keep the basin as open space. The driveway into the basin shall have removable bollards installed for access to the basin by Public Works and Parks staff. If the basin is to be completely fenced, then the basin shall not be irrigated or planted in grass.
